2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION.**

4 The Federal building and United States courthouse
5 located at 231 W. Lafayette in Detroit, Michigan, shall
6 be known and designated as the “Theodore Levin Federal
7 Building and United States Courthouse”.

8 **SEC. 2. REFERENCES.**

9 Any reference in a law, map, regulation, document,
10 paper, or other record of the United States to the Federal
11 building and United States courthouse referred to in sec-
12 tion 1 shall be deemed to be a reference to the “Theodore
13 Levin Federal Building and United States Courthouse”.

14 **SECTION 1. DESIGNATION.**

15 *The United States courthouse located at 231 West La-*
16 *fayette Street in Detroit, Michigan, shall be known and des-*
17 *ignated as the “Theodore Levin United States Courthouse”.*

18 **SEC. 2. REFERENCES.**

19 *Any reference in a law, map, regulation, document,*
20 *paper, or other record of the United States to the United*
21 *States courthouse referred to in section 1 shall be deemed*
22 *to be a reference to the “Theodore Levin United States*
23 *Courthouse”.*

Amend the title so as to read as follows: “A bill to designate the United States courthouse located at 231

West Lafayette Street in Detroit, Michigan, as the 'Theodore Levin United States Courthouse'.".
