Mr. DERRICK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4801) to amend the Small Business Act, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4801) to amend the Small Business
6 Act, and for other purposes. The first reading of the bill
7 shall be dispensed with. All points of order against consid-
8 eration of the bill are waived. General debate shall be con-

1 fined to the bill and the amendments made in order by
2 this resolution and shall not exceed one hour equally di-
3 vided and controlled by the chairman and ranking minor-
4 ity member of the Committee on Small Business. After
5 general debate the bill shall be considered for amendment
6 under the five-minute rule. In lieu of the amendments rec-
7 ommended by the Committee on Small Business now
8 printed in the bill, it shall be in order to consider as an
9 original bill for the purpose of amendment under the five-
10 minute rule an amendment in the nature of a substitute
11 consisting of the text of the bill modified by the amend-
12 ments recommended by the Committee on Small Business
13 now printed in the bill and by the additional amendments
14 printed in part 1 of the report of the Committee on Rules
15 accompanying this resolution. That amendment in the na-
16 ture of a substitute shall be considered as read. No other
17 amendment shall be in order except those printed in part
18 2 of the report of the Committee on Rules. Each amend-
19 ment may be offered only in the order printed in the re-
20 port, may be offered only by a Member designated in the
21 report, shall be considered as read, shall be debatable for
22 the time specified in the report equally divided and con-
23 trolled by the proponent and an opponent, shall not be
24 subject to amendment except as specified in the report,
25 and shall not be subject to a demand for division of the

1 question in the House or in the Committee of the Whole.
2 All points of order against the amendments printed in the
3 report are waived. At the conclusion of consideration of
4 the bill for amendment the Committee shall rise and re-
5 port the bill to the House with such amendments as may
6 have been adopted. Any Member may demand a separate
7 vote in the House on any amendment adopted in the Com-
8 mittee of the Whole to the bill or to the amendment in
9 the nature of a substitute made in order as original text.
10 The previous question shall be considered as ordered on
11 the bill and amendments thereto to final passage without
12 intervening motion except one motion to recommit with
13 or without instructions.
