AN ACT

To make a technical amendment, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CDBG TECHNICAL AMENDMENT.**

4 Notwithstanding any other provision of law, the city
5 of Slidell, Louisiana may submit, not later than 10 days
6 after the enactment of this Act, and the Secretary of
7 Housing and Urban Development shall consider and ac-
8 cept, the final statement of community development objec-
9 tives and projected use of funds required by section
10 104(a)(1) of the Housing and Community Development
11 Act of 1974 in connection with a grant to the city of Sli-
12 dell under title 1 of such Act for fiscal year 1994.

1 **SEC. 2. INCREASE OF CDBG PUBLIC SERVICES CAP.**

2 (a) IN GENERAL.—Section 105(a)(8) of the Housing
3 and Community Development Act of 1974 (42 U.S.C.
4 5305(a)(8)) is amended—

5 (1) by striking “and” after the penultimate
6 comma; and

7 (2) by inserting before the semicolon at the end
8 the following: “, and except that of any amount of
9 assistance under this title (including program in-
10 come) in fiscal year 1994 to the City of Pittsburgh,
11 Pennsylvania, such city may use not more than 20
12 percent in each such fiscal year for activities under
13 this paragraph”.

14 **SEC. 3. CONVERSION PROJECTS.**

15 (a) SECTION 23 CONVERSION.—

16 (1) AUTHORIZATION.—Notwithstanding con-
17 tracts entered into pursuant to section 14(b)(2) of
18 the United States Housing Act of 1937, the Sec-
19 retary is authorized to enter into obligations for con-
20 version of Leonard Terrace Apartments in Grand
21 Rapids, Michigan, from a leased housing contract
22 under section 23 of such Act to a project-based rent-
23 al assistance contract under section 8 of such Act.

24 (2) REPAYMENT REQUIRED.—The authorization
25 made in paragraph (1) is conditioned on the repay-
26 ment to the Secretary of all amounts received by the

1 public housing agency under the comprehensive im-
2 provement assistance program under section 14 of
3 the United States Housing Act of 1937 for the
4 Leonard Terrace Apartment project and the
5 amounts, as determined by the Secretary, received
6 by the public housing agency under the formula in
7 section 14(k) of such Act by reason of the project.

8 **SEC. 4. FIRE SAFETY IN FEDERALLY ASSISTED HOUSING.**

9 Section 31(c)(2)(A)(i) of the Federal Fire Prevention
10 and Control Act of 1974 (15 U.S.C. 2227(c)(2)(A)(i)) is
11 amended by adding “(or equivalent level of safety)” after
12 “system”.
