

In the Senate of the United States,

April 6 (legislative day, April 5), 1995.

Resolved, That the bill from the House of Representatives (H.R. 1345) entitled “An Act to eliminate budget deficits and management inefficiencies in the government of the District of Columbia through the establishment of the District of Columbia Financial Responsibility and Management Assistance Authority, and for other purposes”, do pass with the following

AMENDMENTS:

1 **(1)**Page 7, line 2, strike out **[or]**

2 **(2)**Page 7, line 6, strike out **[States.]** and insert:

3 *States;*

4 **(3)**Page 7, after line 6, insert:

5 *(3) to amend, supersede, or alter the provisions*

6 *of title 11 of the District of Columbia Code, or sec-*

7 *tions 431 through 434, 445, and 602(a)(4) of the Dis-*

8 *trict of Columbia Self-Government and Governmental*

1 *Reorganization Act (pertaining to the organization,*
2 *powers, and jurisdiction of the District of Columbia*
3 *courts); or*

4 *(4) to authorize the application of section 103(e)*
5 *or 303(b)(3) of this Act (relating to issuance of sub-*
6 *poenas) to judicial officers or employees of the Dis-*
7 *trict of Columbia courts.*

8 **(4)**Page 10, strike out lines 7 to 9 and insert:

9 *(4) maintains a primary residence in the Dis-*
10 *trict of Columbia or has a primary place of business*
11 *in the District of Columbia.*

12 **(5)**Page 12, strike out lines 17 to 24, and insert:

13 *(c) INAPPLICABILITY OF CERTAIN EMPLOYMENT AND*
14 *PROCUREMENT LAWS.—*

15 *(1) CIVIL SERVICE LAWS.—The Executive Direc-*
16 *tor and staff of the Authority may be appointed with-*
17 *out regard to the provisions of title 5, United States*
18 *Code, governing appointments in the competitive serv-*
19 *ice, and paid without regard to the provisions of*
20 *chapter 51 and subchapter III of chapter 53 of that*
21 *title relating to classification and General Schedule*
22 *pay rates.*

23 *(2) DISTRICT EMPLOYMENT AND PROCUREMENT*
24 *LAWS.—The Executive Director and staff of the Au-*
25 *thority may be appointed and paid without regard to*

1 *the provisions of the District of Columbia Code gov-*
2 *erning appointments and salaries. The provisions of*
3 *the District of Columbia Code governing procurement*
4 *shall not apply to the Authority.*
