A BILL

To amend the Clean Air Act to provide that traffic signal synchronization projects are exempt from certain requirements of Environmental Protection Agency Rules.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION. 1. TRAFFIC SIGNAL SYNCHRONIZATION**
 2 **PROJECTS.**

3 Section 176(c)(4) of the Clean Air Act is amended
 4 by adding the following at the end thereof:

5 “(D) Traffic signal synchronization projects shall be
 6 exempt from regional emissions analysis requirements and
 7 from requirements under rules of the Administrator for
 8 determining the conformity to State or Federal implemen-
 9 tation plans of transportation plans, programs, and
 10 projects funded or approved under title 23 of the United
 11 States Code or the Federal Transit Act.”.

12 **SECTION. 1. TRAFFIC SIGNAL SYNCHRONIZATION**
 13 **PROJECTS.**

14 *Section 176(c)(4) (42 U.S.C. 7506(c)(4)) of the Clean*
 15 *Air Act is amended by adding the following at the end*
 16 *thereof:*

17 “(D) Compliance with the rules of the Administrator
 18 for determining the conformity of transportation plans,
 19 programs, and projects funded or approved under title 23
 20 of the United States Code or the Federal Transit Act to
 21 State or Federal implementation plans shall not be required
 22 for traffic signal synchronization projects prior to the fund-
 23 ing, approval or implementation of such projects. The sup-
 24 porting regional emissions analysis for any conformity de-
 25 termination made with respect to a transportation plan,
 26 program, or project shall consider the effect on emissions

- 1 *of any such project funded, approved, or implemented prior*
- 2 *to the conformity determination.”.*
