## A BILL

To extend the authority of the Overseas Private Investment  
Corporation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Exports, Jobs, and  
5 Growth Act of 1996”.

1       **TITLE I—OVERSEAS PRIVATE**  
2       **INVESTMENT CORPORATION**

3       **SEC. 101. INCOME LEVELS.**

4           Section 231 of the Foreign Assistance Act of 1961  
5 (22 U.S.C. 2191) is amended in paragraph (2) of the sec-  
6 ond undesignated paragraph—

7           (1) by striking “\$984 or less in 1986 United  
8 States dollars” and inserting “\$1,280 or less in  
9 1994 United States dollars”; and

10          (2) by striking “\$4,269 or more in 1986 United  
11 States dollars” and inserting “\$5,556 or more in  
12 1994 United States dollars”.

13       **SEC. 102. CEILING ON INVESTMENT INSURANCE.**

14           Section 235(a)(1) of the Foreign Assistance Act of  
15 1961 (22 U.S.C. 2195(a)(1)) is amended by striking  
16 “\$13,500,000,000” and inserting “\$25,000,000,000”.

17       **SEC. 103. CEILING ON FINANCING.**

18           Section 235(a)(2) of the Foreign Assistance Act of  
19 1961 (22 U.S.C. 2195(a)(2)) is amended by striking  
20 “\$9,500,000,000” and inserting “\$20,000,000,000”.

21       **SEC. 104. ISSUING AUTHORITY.**

22           Section 235(a)(3) of the Foreign Assistance Act of  
23 1961 (22 U.S.C. 2195(a)(3)) is amended by striking  
24 “1996” and inserting “2000”.

1 **SEC. 105. POLICY GUIDANCE.**

2 Section 231 of the Foreign Assistance Act of 1961  
3 (22 U.S.C. 2191) is amended in the first paragraph—

4 (1) by striking “To mobilize” and inserting “To  
5 increase United States exports to, and to mobilize”;

6 (2) by striking “of less developed” and insert-  
7 ing “of, less developed”; and

8 (3) by inserting “trade policy and” after “com-  
9 plementing the”.

10 **SEC. 106. BOARD OF DIRECTORS.**

11 Section 233(b) of the Foreign Assistance Act of 1962  
12 (22 U.S.C. 2183(b)) is amended—

13 (1) by striking the second and third sentences;

14 (2) in the fourth sentence by striking “(other  
15 than the President of the Corporation, appointed  
16 pursuant to subsection (c) who shall serve as a Di-  
17 rector, ex-officio)”;

18 (3) in the second undesignated paragraph—

19 (A) by inserting “the President of the Cor-  
20 poration, the Administrator of the Agency for  
21 International Development, the United States  
22 Trade Representative, and” after “including”;  
23 and

24 (B) by adding at the end the following:  
25 “The United States Trade Representative may  
26 designate a Deputy United States Trade Rep-

1           representative to serve on the Board in place of the  
2           United States Trade Representative.”; and

3           (3) by inserting after the second undesignated  
4           paragraph the following:

5           “There shall be Chairman and a Vice Chairman of  
6           the Board, both of whom shall be designated by the Presi-  
7           dent of the United States from among the Directors of  
8           the Board other than those appointed under the second  
9           sentence of the first paragraph of this subsection.”.

10                           **TITLE II—TRADE AND**  
11                           **DEVELOPMENT AGENCY**

12           **SEC. 201. TRADE AND DEVELOPMENT AGENCY AUTHORIZA-**  
13                           **TION.**

14           Section 661(f)(1)(A) of the Foreign Assistance Act  
15           of 1961 (22 U.S.C. 2191(f)(1)(A)) is amended to read as  
16           follows:

17                       “(1) AUTHORIZATION.—(A) There are author-  
18                       ized to be appropriated for purposes of this section,  
19                       in addition to funds otherwise available for such pur-  
20                       poses, \$40,000,000 for fiscal 1997, and such sums  
21                       as are necessary for fiscal year 1998.”.

1 **TITLE III—EXPORT PROMOTION**  
2 **PROGRAMS WITHIN THE**  
3 **INTERNATIONAL TRADE AD-**  
4 **MINISTRATION**

5 **SEC. 301. EXPORT PROMOTION AUTHORIZATION.**

6 Section 202 of the Export Administration Amend-  
7 ments Act of 1985 (15 U.S.C. 4052) is amended to read  
8 as follows:

9 **“SEC. 202. AUTHORIZATION OF APPROPRIATIONS.**

10 “There are authorized to be appropriated to the De-  
11 partment of Commerce to carry out export promotion pro-  
12 grams \$240,000,000 for fiscal year 1997 and such sums  
13 as are necessary for fiscal year 1998.”.

14 **TITLE IV—TRADE PROMOTION**  
15 **COORDINATING COMMITTEE**

16 **SEC. 401. STRATEGIC EXPORT PLAN.**

17 Section 2312(e) of the Export Enhancement Act of  
18 1988 (15 U.S.C. 4727) is amended—

19 (1) by striking “and” at the end of paragraph

20 (4);

21 (2) by striking the period at the end of para-  
22 graph (5) and inserting “; and”; and

23 (3) by adding at the end the following:

24 “(6) identify means for providing more coordi-  
25 nated and comprehensive export promotion services

1 to, and in behalf of, small and medium-sized busi-  
2 ness.”.
