A BILL

To extend the authority of the Overseas Private Investment Corporation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Exports, Jobs, and*
3 *Growth Act of 1996”.*

4 **TITLE I—OVERSEAS PRIVATE**
5 **INVESTMENT CORPORATION**

6 **SEC. 101. INCOME LEVELS.**

7 *Section 231 of the Foreign Assistance Act of 1961 (22*
8 *U.S.C. 2191) is amended in paragraph (2) of the second*
9 *undesignated paragraph—*

10 *(1) by striking “\$984 or less in 1986 United*
11 *States dollars” and inserting “\$1,280 or less in 1994*
12 *United States dollars”; and*

13 *(2) by striking “\$4,269 or more in 1986 United*
14 *States dollars” and inserting “\$5,556 or more in*
15 *1994 United States dollars”.*

16 **SEC. 102. CEILING ON INVESTMENT INSURANCE.**

17 *Section 235(a)(1) of the Foreign Assistance Act of 1961*
18 *(22 U.S.C. 2195(a)(1)) is amended by striking*
19 *“\$13,500,000,000” and inserting “\$25,000,000,000”.*

20 **SEC. 103. CEILING ON FINANCING.**

21 *Section 235(a)(2)(A) of the Foreign Assistance Act of*
22 *1961 (22 U.S.C. 2195(a)(2)(A)) is amended by striking*
23 *“\$9,500,000,000” and inserting “\$20,000,000,000”.*

1 **SEC. 104. ISSUING AUTHORITY.**

2 *Section 235(a)(3) of the Foreign Assistance Act of 1961*
3 *(22 U.S.C. 2195(a)(3)) is amended by striking “1996” and*
4 *inserting “2001”.*

5 **SEC. 105. POLICY GUIDANCE.**

6 *Section 231 of the Foreign Assistance Act of 1961 (22*
7 *U.S.C. 2191) is amended in the first paragraph—*

8 *(1) by striking “To mobilize” and inserting “To*
9 *increase United States exports to, and to mobilize”;*

10 *(2) by striking “of less developed” and inserting*
11 *“of, less developed”; and*

12 *(3) by inserting “trade policy and” after “com-*
13 *plementing the”.*

14 **SEC. 106. BOARD OF DIRECTORS.**

15 *Section 233(b) of the Foreign Assistance Act of 1961*
16 *(22 U.S.C. 2193(b)) is amended—*

17 *(1) by striking the second and third sentences;*

18 *(2) in the fourth sentence by striking “(other*
19 *than the President of the Corporation, appointed pur-*
20 *suant to subsection (c) who shall serve as a Director,*
21 *ex-officio)”;*

22 *(3) in the second undesignated paragraph—*

23 *(A) by inserting “the President of the Cor-*
24 *poration, the Administrator of the Agency for*
25 *International Development, the United States*

1 *Trade Representative, and” after “including”;*
2 *and*

3 *(B) by adding at the end the following:*
4 *“The United States Trade Representative may*
5 *designate a Deputy United States Trade Rep-*
6 *resentative to serve on the Board in place of the*
7 *United States Trade Representative.”; and*

8 *(4) by inserting after the second undesignated*
9 *paragraph the following:*

10 *“There shall be Chairman and a Vice Chairman of the*
11 *Board, both of whom shall be designated by the President*
12 *of the United States from among the Directors of the Board*
13 *other than those appointed under the second sentence of the*
14 *first paragraph of this subsection.”.*

15 ***TITLE II—TRADE AND***
16 ***DEVELOPMENT AGENCY***

17 ***SEC. 201. TRADE AND DEVELOPMENT AGENCY AUTHORIZA-***
18 ***TION.***

19 *Section 661(f)(1)(A) of the Foreign Assistance Act of*
20 *1961 (22 U.S.C. 2191(f)(1)(A)) is amended to read as fol-*
21 *lows:*

22 *“(1) AUTHORIZATION.—(A) There are authorized*
23 *to be appropriated for purposes of this section, in ad-*
24 *dition to funds otherwise available for such purposes,*

1 \$40,000,000 for fiscal 1997, and such sums as are
2 necessary for fiscal year 1998.”.

3 **TITLE III—EXPORT PROMOTION**
4 **PROGRAMS WITHIN THE**
5 **INTERNATIONAL TRADE AD-**
6 **MINISTRATION**

7 **SEC. 301. EXPORT PROMOTION AUTHORIZATION.**

8 Section 202 of the Export Administration Amend-
9 ments Act of 1985 (15 U.S.C. 4052) is amended to read
10 as follows:

11 **“SEC. 202. AUTHORIZATION OF APPROPRIATIONS.**

12 *“There are authorized to be appropriated to the De-*
13 *partment of Commerce to carry out export promotion pro-*
14 *grams \$240,000,000 for fiscal year 1997 and such sums as*
15 *are necessary for fiscal year 1998.”.*

16 **TITLE IV—TRADE PROMOTION**
17 **COORDINATING COMMITTEE**

18 **SEC. 401. STRATEGIC EXPORT PLAN.**

19 Section 2312(c) of the Export Enhancement Act of
20 1988 (15 U.S.C. 4727) is amended—

21 (1) by striking “and” at the end of paragraph

22 (4);

23 (2) by striking the period at the end of para-
24 graph (5) and inserting a semicolon; and

25 (3) by adding at the end the following:

1 “(6) *identify means for providing more coordi-*
2 *nated and comprehensive export promotion services*
3 *to, and in behalf of, small- and medium-sized busi-*
4 *nesses; and*

5 “(7) *establish a set of priorities to promote Unit-*
6 *ed States exports to, and free market reforms in, the*
7 *Middle East that are designed to stimulate job growth*
8 *both in the United States and the region.”.*

9 **SEC. 402. IMPLEMENTATION OF PRIMARY OBJECTIVES.**

10 *The Trade Promotion Coordinating Committee shall—*

11 (1) *identify the areas of overlap and duplication*
12 *among Federal export promotion activities and report*
13 *on the actions taken or efforts currently underway to*
14 *eliminate such overlap and duplication;*

15 (2) *report on actions taken or efforts currently*
16 *underway to promote better coordination between*
17 *State, Federal, and private sector export promotion*
18 *activities, including co-location, cost-sharing between*
19 *Federal, State, and private sector export promotion*
20 *programs, and sharing of market research data; and*

21 (3) *by not later than September 30, 1997, in-*
22 *clude the matters addressed in paragraphs (1) and*
23 (2) *in the annual report required to be submitted*
24 *under section 2312(f) of the Export Enhancement Act*
25 *of 1988 (15 U.S.C. 4727(f)).*

1 **SEC. 403. PRIVATE SECTOR DEVELOPMENT IN THE**
2 **UKRAINE.**

3 *The Trade Promotion Coordinating Committee shall*
4 *include in the annual report submitted in 1997 under sec-*
5 *tion 2312(f) of the Export Enhancement Act of 1988 (15*
6 *U.S.C. 4727(f)) a description of the activities of the depart-*
7 *ments and agencies of the Trade Promotion Coordinating*
8 *Committee to foster United States trade and investment*
9 *which facilitates private sector development in the Ukraine.*
