Mr. QUILLEN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1905) making appropriations for energy and water development for the fiscal year ending September 30, 1996, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1905) making appropriations for
6 energy and water development for the fiscal year ending

1 September 30, 1996, and for other purposes. The first
2 reading of the bill shall be dispensed with. General debate
3 shall be confined to the bill and shall not exceed one hour
4 equally divided and controlled by the chairman and rank-
5 ing minority member of the Committee on Appropriations.
6 After general debate the bill shall be considered for
7 amendment under the five-minute rule. The bill shall be
8 considered by title rather than by paragraph. Each title
9 shall be considered as read. Points of order against provi-
10 sions in the bill for failure to comply with clause 2 or 6
11 of rule XXI are waived except as follows: beginning with
12 “: *Provided further*” on page 6, line 6, through “such
13 transfer” on line 13. Where points of order are waived
14 against part of a paragraph, points of order against a pro-
15 vision in another part of such paragraph may be made
16 only against such provision and not against the entire
17 paragraph. Before consideration of any other amendment
18 it shall be in order to consider the amendment printed in
19 the report of the Committee on Rules accompanying this
20 resolution if offered by Representative Shuster of Penn-
21 sylvania or his designee. That amendment shall be consid-
22 ered as read, shall be debatable for ten minutes equally
23 divided and controlled by the proponent and an opponent,
24 shall not be subject to amendment, and shall not be sub-
25 ject to a demand for division of the question in the House

1 or in the Committee of the Whole. All points of order
2 against that amendment are waived. After disposition of
3 that amendment, the provisions of the bill as then per-
4 fected shall be considered as original text. During further
5 consideration of the bill for amendment, the Chairman of
6 the Committee of the Whole may accord priority in rec-
7 ognition on the basis of whether the Member offering an
8 amendment has caused it to be printed in the portion of
9 the Congressional Record designated for that purpose in
10 clause 6 of rule XXIII. Amendments so printed shall be
11 considered as read. At the conclusion of consideration of
12 the bill for amendment the Committee shall rise and re-
13 port the bill to the House with such amendments as may
14 have been adopted. The previous question shall be consid-
15 ered as ordered on the bill and amendments thereto to
16 final passage without intervening motion except one mo-
17 tion to recommit with or without instructions.
