

## **H. Res. 460**

***In the House of Representatives, U.S.,***

*June 27 (legislative day of June 26), 1996.*

1        *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3675) making appropriations for  
6 the Department of Transportation and related agencies  
7 for the fiscal year ending September 30, 1997, and for  
8 other purposes. The first reading of the bill shall be dis-  
9 pensed with. Points of order against consideration of the  
10 bill for failure to comply with section 401(a) of the Con-  
11 gressional Budget Act of 1974 are waived. General debate  
12 shall be confined to the bill and shall not exceed one hour  
13 equally divided and controlled by the chairman and rank-  
14 ing minority member of the Committee on Appropriations.  
15 After general debate the bill shall be considered for  
16 amendment under the five-minute rule. Points of order  
17 against provisions in the bill for failure to comply with  
18 clause 2 or 6 of rule XXI are waived except as follows:

1 beginning with the colon on page 10, line 25, through  
2 “program” on page 11, line 3. Where points of order are  
3 waived against part of a paragraph, points of order  
4 against a provision in another part of such paragraph may  
5 be made only against such provision and not against the  
6 entire paragraph. The amendment printed in section 2 of  
7 this resolution shall be considered as adopted in the House  
8 and in the Committee of the Whole. During consideration  
9 of the bill for further amendment, the Chairman of the  
10 Committee of the Whole may accord priority in recognition  
11 on the basis of whether the Member offering an amend-  
12 ment has caused it to be printed in the portion of the Con-  
13 gressional Record designated for that purpose in clause  
14 6 of rule XXIII. Amendments so printed shall be consid-  
15 ered as read. The Chairman of the Committee of the  
16 Whole may postpone until a time during further consider-  
17 ation in the Committee of the Whole a request for a re-  
18 corded vote on any amendment. The Chairman of the  
19 Committee of the Whole may reduce to not less than five  
20 minutes the time for voting by electronic device on any  
21 postponed question that immediately follows another vote  
22 by electronic device without intervening business, provided  
23 that the time for voting by electronic device on the first  
24 in any series of questions shall be not less than fifteen  
25 minutes. After the reading of the final lines of the bill,

1 a motion that the Committee of the Whole rise and report  
2 the bill to the House with such amendments as may have  
3 been adopted shall, if offered by the majority leader or  
4 a designee, have precedence over a motion to amend. At  
5 the conclusion of consideration of the bill for amendment  
6 the Committee shall rise and report the bill to the House  
7 with such amendments as may have been adopted. The  
8 previous question shall be considered as ordered on the  
9 bill and amendments thereto to final passage without in-  
10 tervening motion except one motion to recommit with or  
11 without instructions.

12 SEC. 2. The amendment considered as adopted in the  
13 House and in the Committee of the Whole is as follows:

14 Page 8, line 18, strike “proceeds from the sale of”.

15 Page 8, line 20, strike “credited as offsetting collec-  
16 tions to this account so as to result” and insert in lieu  
17 thereof “disposed of in a manner resulting”.

18 Page 8, line 22, strike the comma after the figure  
19 and all that follows through “Act” on page 9, line 1.

20 Page 11, line 18, strike “\$2,742,602,000” and insert  
21 in lieu thereof “\$1,642,500,000”.

22 Page 27, line 4, strike “\$400,000,000” and insert in  
23 lieu thereof “\$460,000,000”.

- 1        Page 48, line 12, strike the colon and all that follows
- 2    through “funds” on line 15.
