Mr. KERREY (for himself, Mr. DOLE, Mr. EXON, and Mrs. KASSEBAUM) introduced the following bill; which was read twice and referred to the Committee on Energy and Natural Resources

A BILL

To extend contracts between the Bureau of Reclamation and irrigation districts in Kansas and Nebraska, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Irrigation Project Con-
5 tract Extension Act of 1996”.

6 **SEC. 2. EXTENSION OF CONTRACTS.**

7 The Secretary of the Interior shall extend the con-
8 struction repayment and water service contracts for the
9 following projects, entered into by the Secretary of the In-

terior under subsections (d) and (e) of section 9 of the Reclamation Project Act of 1939 (43 U.S.C. 485h) and section 9(c) of the Act of December 22, 1944 (58 Stat. 891, chapter 665), for a period of 4 additional years after the dates on which each of the contracts, respectively, would expire but for this section:

(1) The Ainsworth Unit, Missouri River Basin Project, consisting of the project constructed and operated under the Act of December 22, 1944 (58 Stat. 887, chapter 665), the Act of August 21, 1954 (68 Stat. 757, chapter 781), and the Act of May 18, 1956 (70 Stat. 160, chapter 285), situated in Cherry County, Brown County, and Rock County, Nebraska.

(2) The Almena Unit, Missouri River Basin Project, consisting of the project constructed and operated under the Act of December 22, 1944 (58 Stat. 887, chapter 665), and the Flood Control Act of 1946 (60 Stat. 641, chapter 596), as a component of the Pick-Sloan Missouri Basin Program, situated in Norton County and Phillips County, Kansas.

(3) The Bostwick Unit (Kansas portion), Missouri River Basin Project, consisting of the project constructed and operated under the Act of December

1 22, 1944 (58 Stat. 887, chapter 665), as a compo-
2 nent of the Pick-Sloan Missouri Basin Program, sit-
3 uated in Republic County, Jewell County, and Cloud
4 County, Kansas.

5 (4) The Bostwick Unit (Nebraska portion),
6 Missouri River Basin Project, consisting of the
7 project constructed and operated under the Act of
8 December 22, 1944 (58 Stat. 887, chapter 665), as
9 a component of the Pick-Sloan Missouri Basin Pro-
10 gram, situated in Harlan County, Franklin County,
11 Webster County, and Nuckolls County, Nebraska.

12 (5) The Farwell Unit, Missouri River Basin
13 Project, consisting of the project constructed and op-
14 erated under the Act of December 22, 1944 (58
15 Stat. 887, chapter 665), and the Act of August 3,
16 1956 (70 Stat. 975, chapter 923), situated in How-
17 ard County, Sherman County, and Valley County,
18 Nebraska.

19 (6) The Frenchman-Cambridge Unit, Missouri
20 River Basin Project, consisting of the project con-
21 structed and operated under the Act of December
22 22, 1944 (58 Stat. 887, chapter 665), as a compo-
23 nent of the Pick-Sloan Missouri Basin Program, sit-
24 uated in Chase County, Frontier County, Hitchcock

1 County, Furnas County, and Harlan County, Ne-
2 braska.

3 (7) The Frenchman Valley Unit, Missouri River
4 Basin Project, consisting of the project constructed
5 and operated under the Act of December 22, 1944
6 (58 Stat. 887, chapter 665), as a component of the
7 Pick-Sloan Missouri Basin Program, situated in
8 Hayes County and Hitchcock County, Nebraska.

9 (8) The Kirwin Unit, Missouri River Basin
10 Project, consisting of the project constructed and op-
11 erated under the Act of December 22, 1944 (58
12 Stat. 887, chapter 665), and the Flood Control Act
13 of 1946 (60 Stat. 641, chapter 596), as a compo-
14 nent of the Pick-Sloan Missouri Basin Program, sit-
15 uated in Phillips County, Smith County, and
16 Osborne County, Kansas.

17 (9) The Sargent Unit, Missouri River Basin
18 Project, consisting of the project constructed and op-
19 erated under the Act of December 22, 1944 (58
20 Stat. 887, chapter 665), and the Flood Control Act
21 of 1946 (60 Stat. 641, chapter 596), situated in
22 Blaine County, Custer County, and Valley County,
23 Nebraska.

24 (10) The Webster Unit, Missouri River Basin
25 Project, consisting of the project constructed and op-

1 erated under the Act of December 22, 1944 (58
2 Stat. 887, chapter 665), and the Flood Control Act
3 of 1946 (60 Stat. 641, chapter 596), as a compo-
4 nent of the Pick-Sloan Missouri Basin Program, sit-
5 uated in Rooks County and Osborn County, Kansas.
