Mr. YOUNG introduced the following joint resolution; which was referred to the Committee on Appropriations

The Committee on Appropriations discharged; considered and passed

JOINT RESOLUTION

Making further continuing appropriations for the fiscal year 2001, and for other purposes.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled,*

3 SECTION 1. Public Law 106–275 is further amended
4 by striking the date specified in section 106(c) and insert-
5 ing “December 5, 2000”, and by adding, at the end, the
6 following three new sections:

7 “SEC. 121. (a) Notwithstanding any other provision
8 of this joint resolution, except section 107, there are ap-
9 propriated for all construction expenses, salaries, and

1 other expenses associated with conducting the inaugural
2 ceremonies of the President and Vice President of the
3 United States, January 20, 2001, in accordance with such
4 program as may be adopted by the joint committee author-
5 ized by Senate Concurrent Resolution 89, agreed to March
6 14, 2000 (One Hundred Sixth Congress), and Senate Con-
7 current Resolution 90, agreed to March 14, 2000 (One
8 Hundred Sixth Congress), \$1,000,000 to be disbursed by
9 the Secretary of the Senate and to remain available until
10 September 30, 2001. Funds made available under this
11 heading shall be available for payment, on a direct or re-
12 imburseable basis, whether incurred on, before, or after,
13 October 1, 2000: *Provided*, That the compensation of any
14 employee of the Committee on Rules and Administration
15 of the Senate who has been designated to perform service
16 for the Joint Congressional Committee on Inaugural Cere-
17 monies shall continue to be paid by the Committee on
18 Rules and Administration, but the account from which
19 such staff member is paid may be reimbursed for the serv-
20 ices of the staff member (including agency contributions
21 when appropriate) out of funds made available under this
22 heading.

23 “(b) During fiscal year 2001 the Secretary of De-
24 fense shall provide protective services on a non-reimburs-

1 able basis to the United States Capitol Police with respect
2 to the following events:

3 “(1) Upon request of the Chair of the Joint
4 Congressional Committee on Inaugural Ceremonies
5 established under Senate Concurrent Resolution 89
6 (One Hundred Sixth Congress), agreed to March 14,
7 2000, the proceedings and ceremonies conducted for
8 the inauguration of the President-elect and Vice
9 President-elect of the United States.

10 “(2) Upon request of the Speaker of the House
11 of Representatives and the President Pro Tempore
12 of the Senate, the joint session of Congress held to
13 receive a message from the President of the United
14 States on the State of the Union.

15 “SEC. 122. Notwithstanding any other provision of
16 this joint resolution except section 107, \$5,961,000 shall
17 be available for a payment to the District of Columbia to
18 reimburse the District for expenses incurred in connection
19 with Presidential inauguration activities.

20 “SEC. 123. Notwithstanding limitations imposed by
21 this continuing resolution except section 107, the Execu-
22 tive Residence at the White House is authorized to make
23 expenditures to provide for the orderly transition and mov-
24 ing expenses following the election on November 7,
25 2000.”.

1 SEC. 2. Notwithstanding section 106 of Public Law
2 106–275, funds shall be available and obligations for man-
3 datory payments due on or about December 1, 2000, may
4 continue to be made.
