1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; REFERENCE TO OMNIBUS PARKS**
2 **AND PUBLIC LANDS MANAGEMENT ACT OF**
3 **1996.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Omnibus Parks Technical Corrections Act of 1999”.

6 (b) REFERENCE TO OMNIBUS PARKS ACT.—In this
7 Act, the term “Omnibus Parks Act” means the Omnibus
8 Parks and Public Lands Management Act of 1996 (Public
9 Law 104–333; 110 Stat. 4093).

10 **TITLE I—TECHNICAL**
11 **CORRECTIONS TO DIVISION I**

12 **SEC. 101. PRESIDIO OF SAN FRANCISCO.**

13 Title I of division I of the Omnibus Parks Act (16
14 U.S.C. 460bb note) is amended as follows:

15 “(1) TRANSFER FROM SECRETARY OF THE IN-
16 TERIOR.—The Secretary of the Interior shall trans-
17 fer to the Secretary of Agriculture administrative ju-
18 risdiction over approximately 2,167 acres of lands
19 and interests in land located in Duchesne and
20 Wasatch Counties, Utah, that were acquired by the
21 Secretary of the Interior for the Central Utah
22 Project, as depicted on the maps entitled—

23 “(A) the ‘Dutch John Townsite, Ashley
24 National Forest, Lower Stillwater’, dated Feb-
25 ruary 1997;

1 “(B) The ‘Dutch John Townsite, Ashley
2 National Forest, Red Hollow (Diamond Prop-
3 erties)’, dated February 1997; and

4 “(C) The ‘Dutch John Townsite, Ashley
5 National Forest, Coal Hollow (Current Creek
6 Reservoir)’, dated February 1997.

7 “(2) TRANSFER FROM SECRETARY OF AGRI-
8 CULTURE.—The Secretary of Agriculture shall
9 transfer to the Secretary of the Interior administra-
10 tive jurisdiction over approximately 2,450 acres of
11 lands and interests in lands located in the Ashley
12 National Forest, as depicted on the map entitled
13 ‘Ashley National Forest, Lands to be Transferred to
14 the Bureau of Reclamation (BOR) from the Forest
15 Service’, dated February 1997.”.

16 (3) In paragraph (3)(A), by striking the second
17 sentence and inserting the following new sentence:
18 “The boundaries of the Ashley National Forest and
19 the Uinta National Forest are hereby adjusted to re-
20 flect the transfers required by this section.”.

21 (4) In paragraph (3)(B), by striking “The
22 transferred lands” and inserting “The lands and in-
23 terests in land transferred to the Secretary of Agri-
24 culture under paragraph (1)”.

1 (b) ELECTRIC POWER.—Section 13(d) of such Act
 2 (112 Stat. 3053) is amended by striking paragraph (1)
 3 and inserting the following new paragraph:

4 “(1) AVAILABILITY.—The United States shall
 5 make available for the Dutch John community elec-
 6 tric power and associated energy previously reserved
 7 from the Colorado River Storage Project for project
 8 use as firm electric service.”.

9 **SEC. 304. OREGON PUBLIC LANDS TRANSFER AND PROTEC-**
 10 **TION ACT OF 1998.**

11 Section 3 of the Oregon Public Lands Transfer and
 12 Protection Act of 1998 (Public Law 105–321; 112 Stat.
 13 3022) is amended as follows:

14 (1) In subsection (a), by striking paragraph (3)
 15 and redesignating paragraphs (4) and (5) as para-
 16 graphs (3) and (4), respectively.

17 (2) By striking subsection (b) and inserting the
 18 following new subsection:

19 “(b) POLICY OF NO NET LOSS OF O & C LAND AND
 20 CBWR LAND.—In carrying out sales, purchases, and ex-
 21 changes of land in the geographic area, the Secretary shall
 22 ensure that on October 30, 2008, and on the expiration
 23 of each 10-year period thereafter, the number of acres of
 24 O & C land and CBWR land in the geographic area is

1 not less than the number of acres of such land on October
2 30, 1998.”.
