## A BILL

To amend title 18, United States Code, to prevent the misuse of genuine and counterfeit police badges by those seeking to commit a crime, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Police Badge Fraud  
5 Prevention Act of 1999”.

1 **SEC. 2. POLICE BADGES.**

2 (a) IN GENERAL.—Chapter 33 of title 18, United  
3 States Code, is amended by adding at the end the fol-  
4 lowing:

5 **“§ 716. Police badges**

6 “(a) Whoever—

7 “(1) knowingly transfers, transports, or re-  
8 ceives, in interstate or foreign commerce, a counter-  
9 feit police badge;

10 “(2) knowingly transfers, in interstate or for-  
11 eign commerce, a genuine police badge to an indi-  
12 vidual not authorized to possess it under the law of  
13 the place in which the badge is the official badge of  
14 the police;

15 “(3) knowingly receives a genuine police badge  
16 in a transfer prohibited by paragraph (2); or

17 “(4) being a person not authorized to possess a  
18 genuine police badge under the law of the place in  
19 which the badge is the official badge of the police,  
20 knowingly transports that badge in interstate or for-  
21 eign commerce;

22 shall be fined under this title or imprisoned not more than  
23 180 days, or both.

24 “(b) It is a defense to a prosecution under this sec-  
25 tion that the badge is used exclusively—

26 “(1) in a collection or exhibit;

1           “(2) for decorative purposes; or

2           “(3) for a dramatic presentation, such as a the-  
3           atrical, film, or television production.

4           “(c) As used in this section—

5           “(1) the term ‘genuine police badge’ means an  
6           official badge issued by public authority to identify  
7           an individual as a law enforcement officer having po-  
8           lice powers; and

9           “(2) the term ‘counterfeit police badge’ means  
10          an item that so resembles a police badge that it  
11          would deceive an ordinary individual into believing it  
12          was a genuine police badge.”.

13          (b) CLERICAL AMENDMENT.—The table of sections  
14          at the beginning of chapter 33 of title 18, United States  
15          Code, is amended by adding at the end the following new  
16          item:

“716. Police badges.”.
