## AN ACT

To extend energy conservation programs under the Energy Policy and Conservation Act through fiscal year 2003.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. ENERGY POLICY AND CONSERVATION ACT 2 AMENDMENTS. 3 The Energy Policy and Conservation Act is 4 amended-5 (1) by amending section 166 (42 U.S.C. 6246) 6 to read as follows: 7 "AUTHORIZATION OF APPROPRIATIONS 8 "SEC. 166. There are authorized to be appropriated 9 for fiscal years 2000 through 2003 such sums as may be 10 necessary to implement this part."; 11 (2) in section 181 (42 U.S.C. 6251) by striking "March 31, 2000" both places it appears and insert-12 13 ing "September 30, 2003"; and 14 (3) in section 281 (42 U.S.C. 6285) by striking 15 "March 31, 2000" both places it appears and insert-16 ing "September 30, 2003". 17 SEC. 2. PURCHASE OF OIL FROM MARGINAL WELLS. 18 (a) PURCHASE OF OIL FROM MARGINAL WELLS.— 19 Part B of Title I of the Energy Policy and Conservation 20 Act (42 U.S.C. 6232 et seq.) is amended by adding the 21 following new section after section 168: 22 "PURCHASE OF OIL FROM MARGINAL WELLS 23 "SEC. 169. (a) IN GENERAL.—From amounts authorized under section 166, in any case in which the price 24 25 of oil decreases to an amount less than \$15.00 per barrel (an amount equal to the annual average well head price 26

1	per barrel for all domestic crude oil), adjusted for infla-
2	tion, the Secretary may purchase oil from a marginal well
3	at \$15.00 per barrel, adjusted for inflation.
4	"(b) Definition of Marginal Well.—The term
5	"marginal well" means a well that—
6	"(1) has an average daily production of 15 bar-
7	rels or less;
8	"(2) has an average daily production of 25 bar-
9	rels or less with produced water accounting for 95
10	percent or more of total production; or
11	"(3) produces heavy oil with an API gravity
12	less than 20 degrees.".
13	(b) Conforming Amendment.—The table of con-
14	tents for the Energy Policy and Conservation Act is
15	amended by inserting after the item relating to section
16	168 the following:
	"Sec. 169. Purchase of oil from marginal wells.".
17	SEC. 3. NORTHEAST HOME HEATING OIL RESERVE.
18	(a) AMENDMENT.—Title I of the Energy Policy and
19	Conservation Act is amended by—
20	(1) redesignating part D as part E;
21	(2) redesignating section 181 as section 191;

23	(3) inserting after part C the following new
24	part D:

## "Part D—Northeast Home Heating Oil Reserve "ESTABLISHMENT

3 "SEC. 181. (a) Notwithstanding any other provision 4 of this Act, the Secretary may establish, maintain, and operate in the Northeast a Northeast Home Heating Oil 5 Reserve. A Reserve established under this part is not a 6 7 component of the Strategic Petroleum Reserve established 8 under part B of this title. A Reserve established under this part shall contain no more than 2 million barrels of 9 10 petroleum distillate.

11 "(b) For the purposes of this part—

12 "(1) the term 'Northeast' means the States of
13 Maine, New Hampshire, Vermont, Massachusetts,
14 Connecticut, Rhode Island, New York, Pennsylvania,
15 and New Jersey; and

16 "(2) the term 'petroleum distillate' includes17 heating oil and diesel fuel.

20 to carry out this part, the Secretary may—

21 "(1) purchase, contract for, lease, or otherwise
22 acquire, in whole or in part, storage and related fa23 cilities, and storage services;

3 "(b) Within 45 days of the date of the enactment of
4 this section, the Secretary shall transmit to the President
5 and, if the President approves, to the Congress a plan
6 describing—

7 "(1) the acquisition of storage and related fa8 cilities or storage services for the Reserve;

9 "(2) the acquisition of petroleum distillate for
10 storage in the Reserve;

11 "(3) the anticipated methods of disposition of
12 petroleum distillate from the Reserve; and

13 "(4) the estimated costs of establishment, main-14 tenance, and operation of the Reserve.

15 The storage of petroleum distillate in a storage facility
16 that meets existing environmental requirements is not a
17 'major Federal action significantly affecting the quality of
18 the human environment' as that term is used in section
19 102(2)(C) of the National Environmental Policy Act of
20 1969.

21 "NORTHEAST HOME HEATING OIL RESERVE ACCOUNT

"SEC. 184. (a) Upon a decision of the Secretary of
Energy to establish a Reserve under this part, the Secretary of the Treasury shall establish in the Treasury of
the United States an account know as the 'Northeast

Home Heating Oil Reserve Account' (referred to in this
 section as the 'Account').

3 "(b) The Secretary of the Treasury shall deposit in
4 the Account any amounts appropriated to the Account and
5 any receipts from the sale, exchange, or other disposition
6 of petroleum distillate from the Reserve.

7 "(c) The Secretary of Energy may obligate amounts 8 in the Account to carry out activities under this part with-9 out the need for further appropriation, and amounts avail-10 able to the Secretary of Energy for obligation under this 11 section shall remain available without fiscal year limita-12 tion.

13	"EXEMPTIONS
14	"SEC. 185. An action taken under this part—
15	"(1) is not subject to the rulemaking require-
16	ments of section 523 of this Act, section 501 of the
17	Department of Energy Organization Act, or section
18	553 of title 5, United States Code; and
19	"(2) is not subject to laws governing the Fed-
20	eral procurement of goods and services, including
21	the Federal Property and Administrative Services
22	Act of 1949 (including the Competition in Con-
23	tracting Act) and the Small Business Act.".
24	(b) Authorization of Appropriations.—There
25	are authorized to be appropriated such sums as may be

- 1 necessary to carry out part D of title I of the Energy Pol-
- 2 icy and Conservation Act.
