October 5 (legislative day, September 22), 2000.

Resolved, That the bill from the House of Representatives (H.R. 3292) entitled “An Act to provide for the establishment of the Cat Island National Wildlife Refuge in West Feliciana Parish, Louisiana.”, do pass with the following

AMENDMENTS:

1 **(1)**Page 4, line 7, after “animals;” insert: *and*

6 **(5)**Page 6, after line 2, insert:

7 *(b) PRIORITY USES.—In providing opportunities for*

 2 *hunting, fishing, wildlife observation and photography, and*
 3 *environmental education and interpretation are the pri-*
 4 *ority public uses of the Refuge.*

5 **(6)**Page 6, after line 11, insert:

6 **SEC. 8. DESIGNATION OF HERBERT H. BATEMAN EDU-**
 7 **CATION AND ADMINISTRATIVE CENTER.**

8 *(a) IN GENERAL.—A building proposed to be located*
 9 *within the boundaries of the Chincoteague National Wildlife*
 10 *Refuge, on Assateague Island, Virginia, shall be known and*
 11 *designated as the “Herbert H. Bateman Education and Ad-*
 12 *ministrative Center”.*

13 *(b) REFERENCES.—Any reference in a law, map, regu-*
 14 *lation, document, paper, or other record of the United*
 15 *States to the building referred to in subsection (a) shall be*
 16 *deemed to be a reference to the Herbert H. Bateman Edu-*
 17 *cation and Administrative Center.*

 15 *(4) of section 4(a) of the National Wildlife Refuge*
 16 *System Administration Act of 1966 (16 U.S.C.*
 17 *668dd(a))”.*

18 *(c) Effective on the day after the date of enactment*
 19 *of the Red River National Wildlife Refuge Act (106th Con-*
 20 *gress), section 4(b)(2)(D) of that Act is amended by striking*
 21 *“section 4(a)(3) and (4) of the National Wildlife Refuge*
 22 *System Administration Act of 1966 (16 U.S.C. 668ee(a)(3),*
 23 *(4))” and inserting “paragraphs (3) and (4) of section 4(a)*

1 *of the National Wildlife Refuge System Administration Act*
2 *of 1966 (16 U.S.C. 668dd(a))”.*
