A BILL

To redesignate the Big South Trail in the Comanche Peak Wilderness Area of Roosevelt National Forest in Colorado as the “Jaryd Atadero Legacy Trail”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. FINDING.**

2 Congress finds that Jaryd Atadero, a 3-year old boy
3 from Littleton, Colorado, was last seen the morning of Oc-
4 tober 2, 1999, 1½ miles from the trailhead of the Big
5 South Trail in the Comanche Peak Wilderness Area of
6 Roosevelt National Forest.

7 **SEC. 2. REDESIGNATION.**

8 The Big South Trail in the Comanche Peak Wilder-
9 ness Area of Roosevelt National Forest located in Colo-
10 rado shall be known and designated as the “Jaryd Atadero
11 Legacy Trail”.

12 **SEC. 3. REFERENCES.**

13 Any reference in a law, map, regulation, document,
14 paper, or other record of the United States to the trail
15 referred to in section 2 shall be deemed to be a reference
16 to the “Jaryd Atadero Legacy Trail”.

17 **SEC. 4. SIGN.**

18 The Secretary of Agriculture shall post a sign at the
19 trailhead of the trail referred to in section 2 that includes
20 a copy of this Act and a picture of Jaryd Atadero.

21 **SECTION 1. FINDING.**

22 Congress finds that Jaryd Atadero, a 3-year old boy
23 from Littleton, Colorado, was last seen the morning of Octo-
24 ber 2, 1999, 1½ miles from the trailhead of the Big South
25 Trail in the Comanche Peak Wilderness Area of Roosevelt
26 National Forest.

1 **SEC. 2. DEDICATION.**

2 *Congress dedicates the Big South Trail in the Coman-*
3 *che Peak Wilderness Area of Roosevelt National Forest to*
4 *Jaryd Atadero and his legacy of promoting safe outdoor*
5 *recreation for children.*

6 **SEC. 3. SIGN.**

7 *The Secretary of Agriculture shall recognize the loss*
8 *of Jaryd Atadero and the need for increased awareness of*
9 *child safety in outdoor recreation settings by posting an in-*
10 *terpretive sign at the Big South Trail trailhead that—*

11 *(1) describes consideration for safe outdoor recre-*
12 *ation with children;*

13 *(2) refers to the tragic loss of Jaryd Atadero to*
14 *underscore the need for such safety considerations;*

15 *(3) refers to the dedication by Congress of this*
16 *trail and safety message to the legacy of Jaryd*
17 *Atadero; and*

18 *(4) for not less than 1 year, includes a copy of*
19 *this Act and an image of Jaryd Atadero.*

Amend the title so as to read: “A bill to dedicate the Big South Trail in the Comanche Peak Wilderness Area of Roosevelt National Forest in Colorado to the legacy of Jaryd Atadero.”.
