- 11 Section 2(a) of the John H. Chafee Environmental
- 12 Education Act (20 U.S.C. 5502(a)) is amended to read

- 14 "(a) FINDINGS.—The Congress finds the following:
- 15 "(1) The most effective environmental edu-
- 16 cation is fair and accurate in its treatment of envi-
- 17 ronmental issues and is based on sound scientific
- principles.

- "(2) Education and learning about the environment are central to protecting the Nation's natural resources and human health.
 - "(3) Environmental education develops an important base of knowledge and skills that can encourage life-long learning in related areas of national interest, such as mathematics, science, and medicine.
 - "(4) Environmental education fosters awareness of the natural and built environment, an understanding of complex environmental concepts, conditions, and issues and provides all learners with the skills to make an independent, informed analysis of environmental issues.
 - "(5) Balanced and scientifically based environmental education provides students of all ages with the resources and the opportunities to explore beyond the classroom and focuses learning on the interdisciplinary nature of environmental issues and conditions.
 - "(6) In attempting to improve public awareness of environmental issues, the Government can best assure that the available information is science-based, balanced, and age-appropriate.".

- 16 ed a John H. Chafee Memorial Fellowship shall focus on
- 17 the study of—
- 18 "(1) resource management;

24	provide a cash award of up to \$2,500 to the
25	local educational agency employing any teacher

5	construction costs, general expenses, salaries,
6	bonuses, or other administrative expenses.

10	of the fiscal years 2002 through 2006.
11	"(b) Limitations.—

13	of the amounts made available under subsection (a)
14	for each fiscal year—
15	"(A) not more than 20 percent may be
16	used for the activities of the Office of Environ-
17	mental Education established under section 4;
18	"(B) not more than 25 percent may be
19	used for the operation of the environmental
20	education and training program under section
21	5;
22	"(C) not less than 43 percent shall be used
23	for environmental education grants under sec-
24	tion 6, of which \$125,000 shall be used to fund
25	the John H. Chafee Memorial Fellowship
26	awards under section 7;

1	"(D) 2 percent shall be used for the teach-
2	ers awards under section 8(b); and
3	"(E) 10 percent shall be used for the ac-
4	tivities of the Foundation under section 10.
5	"(2) Administrative expenses.—Of the
6	amounts made available under paragraph (1)(A) for
7	each fiscal year, not more than 5 percent may be
8	used for administrative expenses of the Office of En-
9	vironmental Education.
10	"(c) Expense Report.—As soon as practicable
11	after the end of each fiscal year, the Administrator shall
12	submit to Congress a report describing in detail the activi-
13	ties for which funds appropriated for the fiscal year were
14	expended.
15	"(d) Matching Funds.—Funds appropriated pur-
16	suant to this section may be made available to the Na-
17	tional Environmental Learning Foundation to match par-
18	tially or wholly the amount or value of contributions
19	(whether in currency, services, or property) made to the
20	Foundation by private persons and State and local govern-
21	ments if the Administrator determines that such funds will
22	be used to carry out the statutory purposes of the Founda-
23	tion in a manner consistent with the goals, objectives, and
24	programs of this Act.".
