Ms. PRYCE of Ohio, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for consideration of the bill (H.R. 1658) to provide a more just and uniform procedure for Federal civil forfeitures, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1658) to provide a more just and  
6 uniform procedure for Federal civil forfeitures, and for  
7 other purposes. The first reading of the bill shall be dis-

1 pensed with. All points of order against consideration of  
2 the bill are waived. General debate shall be confined to  
3 the bill and shall not exceed one hour equally divided and  
4 controlled by the chairman and ranking minority member  
5 of the Committee on the Judiciary. After general debate  
6 the bill shall be considered for amendment under the five-  
7 minute rule. It shall be in order to consider as an original  
8 bill for the purpose of amendment under the five-minute  
9 rule an amendment in the nature of a substitute consisting  
10 of the bill modified by the amendment recommended by  
11 the Committee on the Judiciary now printed in the bill.  
12 Each section of that amendment in the nature of a sub-  
13 stitute shall be considered as read. Before consideration  
14 of any other amendment it shall be in order to consider  
15 the amendment printed in the report of the Committee  
16 on Rules accompanying this resolution, which may be of-  
17 fered only by Representative Hyde or his designee, may  
18 amend portions of the bill not yet read for amendment,  
19 and shall be considered as read. No further amendment  
20 to the amendment in the nature of a substitute made in  
21 order as original text shall be in order except those printed  
22 in the portion of the Congressional Record designated for  
23 that purpose in clause 8 of rule XVIII and except pro  
24 forma amendments for the purpose of debate. Each  
25 amendment so printed may be offered only by the Member

1 who caused it to be printed or his designee and shall be  
2 considered as read. The chairman of the Committee of the  
3 Whole may: (1) postpone until a time during further con-  
4 sideration in the Committee of the Whole a request for  
5 a recorded vote on any amendment; and (2) reduce to five  
6 minutes the minimum time for electronic voting on any  
7 postponed question that follows another electronic vote  
8 without intervening business, provided that the minimum  
9 time for electronic voting on the first in any series of ques-  
10 tions shall be 15 minutes. At the conclusion of consider-  
11 ation of the bill for amendment the Committee shall rise  
12 and report the bill to the House with such amendments  
13 as may have been adopted. Any Member may demand a  
14 separate vote in the House on any amendment adopted  
15 in the Committee of the Whole to the bill or to the amend-  
16 ment in the nature of a substitute made in order as origi-  
17 nal text. The previous question shall be considered as or-  
18 dered on the bill and amendments thereto to final passage  
19 without intervening motion except one motion to recommit  
20 with or without instructions.
