To reauthorize the Congressional Award Act.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CONGRESSIONAL AWARD ACT AMENDMENTS**
2 **OF 1999.**

3 (a) CHANGE OF ANNUAL REPORTING DATE.—Sec-
4 tion 3(e) of the Congressional Award Act (2 U.S.C.
5 802(e)) is amended in the first sentence by striking “April
6 1” and inserting “June 1”.

7 (b) MEMBERSHIP REQUIREMENTS.—Section 4(a)(1)
8 of the Congressional Award Act (2 U.S.C. 803(a)(1)) is
9 amended—

10 (1) in subparagraphs (A) and (D), by striking
11 “member of the Congressional Award Association”
12 and inserting “recipient of the Congressional
13 Award” ; and

14 (2) in subparagraphs (B) and (C), by striking
15 “representative of a local Congressional Award
16 Council” and inserting “a local Congressional Award
17 program volunteer”.

18 (c) EXTENSION OF REQUIREMENTS REGARDING FI-
19 NANCIAL OPERATIONS OF CONGRESSIONAL AWARD PRO-
20 GRAM; NONCOMPLIANCE WITH REQUIREMENTS.—Section
21 5(c)(2)(A) of the Congressional Award Act (2 U.S.C.
22 804(c)(2)(A)) is amended by striking “and 1998” and in-
23 serting “1998, 1999, 2000, 2001, 2002, 2003, and 2004”.

24 (d) TERMINATION.—Section 9 of the Congressional
25 Award Act (2 U.S.C. 808) is amended by striking “Octo-
26 ber 1, 1999” and inserting “October 1, 2004”.
