## A BILL

To extend the moratorium enacted by the Internet Tax Freedom Act through 2006, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Internet Tax Non-  
3 discrimination Act”.

4 **SEC. 2. EXTENSION OF INTERNET TAX FREEDOM ACT MOR-**  
5 **ATORIUM.**

6 (a) **EXTENSION; INTERNET ACCESS TAXES.**—Section  
7 1101 of the Internet Tax Freedom Act (47 U.S.C. 151  
8 note) is amended—

9 (1) by striking “taxes during the period begin-  
10 ning on October 1, 1998, and ending 3 years after  
11 the date of enactment of this Act—” in subsection  
12 (a) and inserting “taxes.”;

13 (2) by striking paragraph (1) of subsection (a)  
14 and inserting the following:

15 “(1) Taxes on Internet access.”;

16 (3) by inserting before “multiple” in paragraph  
17 (2) of subsection (a) the following: “During the pe-  
18 riod beginning on October 1, 1998, and ending on  
19 December 31, 2006.”;

20 (4) by striking subsection (d); and

21 (5) by redesignating subsections (e) and (f) as  
22 subsections (d) and (e), respectively.

23 (b) **CONFORMING AMENDMENT.**—Section 1104(10)  
24 of Internet Tax Freedom Act (47 U.S.C. 151 note) is  
25 amended by striking “services unless such tax was gen-

1 erally imposed and actually enforced prior to October 1,  
 2 1998.” and inserting “services.”.

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Internet Tax Non-*  
 5 *discrimination Act”.*

6 **SEC. 2. EXTENSION OF INTERNET TAX FREEDOM ACT MOR-**  
 7 **ATORIUM.**

8 *Section 1101(a) of the Internet Tax Freedom Act (47*  
 9 *U.S.C. 151 note) is amended by striking “3 years after the*  
 10 *date of the enactment of this Act” and inserting “on Novem-*  
 11 *ber 1, 2003”.*

Amend the title so as to read: “A bill to extend the moratorium enacted by the Internet Tax Freedom Act through November 1, 2003; and for other purposes.”.
