Mr. LATOURETTE introduced the following bill; which was referred to the

A BILL

To authorize the Pyramid of Remembrance Foundation to establish a memorial in the District of Columbia or its environs to soldiers who have lost their lives during peacekeeping operations, humanitarian efforts, training, terrorist attacks, or covert operations.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AUTHORITY TO ESTABLISH MEMORIAL.**

4 (a) IN GENERAL.—The Pyramid of Remembrance
5 Foundation is authorized to establish a memorial on Fed-
6 eral land in the District of Columbia or its environs to
7 honor members of the Armed Forces of the United States

1 who have lost their lives during peacekeeping operations,
2 humanitarian efforts, training, terrorist attacks, or covert
3 operations.

4 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-
5 RATIVE WORKS.—The Pyramid of Remembrance Founda-
6 tion shall establish the memorial authorized by this Act
7 in accordance with the Commemorative Works Act (40
8 U.S.C. 1001, et seq.), except that section 3(c) of that Act
9 shall not apply.

10 **SEC. 2. FUNDS FOR MEMORIAL.**

11 (a) USE OF FEDERAL FUNDS PROHIBITED.—Except
12 as provided by the Commemorative Works Act, no Federal
13 funds may be used to pay any expense of the establish-
14 ment of the memorial.

15 (b) DEPOSIT OF EXCESS FUNDS.—If—

16 (1) upon payment of all expenses of the estab-
17 lishment of the memorial, including payment to the
18 Treasury of the maintenance and preservation
19 amount required by section 8(b) of the Commemora-
20 tive Works Act; or

21 (2) upon expiration of the authority for the me-
22 morial under section 10(b) of the Commemorative
23 Works Act,

24 there remains a balance of funds received for the establish-
25 ment of the memorial, the Pyramid of Remembrance

1 Foundation shall transmit that balance to the Secretary
2 of the Treasury for deposit in the account provided for
3 in section 8(b)(1) of the Commemorative Works Act.

4 **SEC. 3. DEFINITION.**

5 For the purposes of this Act, the term “the District
6 of Columbia and its environs” has the meaning given that
7 term in section 2 of the Commemorative Works Act.
