## A BILL

To require that the Coast Guard Sea Marshal program be carried out in the 20 ports in the United States considered by the Secretary of Transportation to be the most vulnerable to attack by use of a commercial vessel as a terrorist instrument, to authorize additional personnel and funds for such program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Seaport Security En-  
5       hancement Act”.

1 **SEC. 2. ADDITIONAL AUTHORIZATIONS FOR COAST GUARD**  
2 **SEA MARSHAL PROGRAM.**

3 (a) **EXPANSION OF PROGRAM.**—The Secretary of  
4 Transportation shall carry out the Coast Guard Sea Mar-  
5 shal program in the 20 ports in the United States consid-  
6 ered by the Secretary to be the most vulnerable to attack  
7 by use of a commercial vessel as a terrorist instrument.

8 (b) **AUTHORIZATION OF ADDITIONAL PERSONNEL**  
9 **AND APPROPRIATIONS.**—To carry out this section—

10 (1) the authorized end-of-year strength for ac-  
11 tive duty personnel of the Coast Guard as of Sep-  
12 tember 30, 2002, is increased by 1,000; and

13 (2) there is authorized to be appropriated to the  
14 Secretary of Transportation such additional funds as  
15 are necessary for activities of such additional per-  
16 sonnel.

17 **SEC. 3. CONTINUING EFFECT OF REGULATIONS ESTAB-**  
18 **LISHING REQUIREMENTS FOR NOTIFICATION**  
19 **OF ARRIVAL IN UNITED STATES PORTS.**

20 The regulations published on October 4, 2001, estab-  
21 lishing requirements for notification of arrival in United  
22 States ports (66 Fed. Reg. 50565) shall be in effect until  
23 the Secretary of Transportation publishes a finding that  
24 such regulations should terminate.
