A BILL

To make certain adjustments to the boundaries of the Mount Nebo Wilderness Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Mount Nebo Wilderness*
5 *Boundary Adjustment Act”.*

1 **SEC. 2. BOUNDARY ADJUSTMENTS.**

2 (a) *LANDS REMOVED.*—*The boundary of the Mount*
3 *Nebo Wilderness is adjusted to exclude the following:*

4 (1) *MONUMENT SPRINGS.*—*The approximately*
5 *8.4 acres of land depicted on the Map as “Monument*
6 *Springs”.*

7 (2) *GARDNER CANYON.*—*The approximately*
8 *177.8 acres of land depicted on the Map as “Gardner*
9 *Canyon”.*

10 (3) *BIRCH CREEK.*—*The approximately 5.0 acres*
11 *of land depicted on the Map as “Birch Creek”.*

12 (4) *INGRAM CANYON.*—*The approximately 15.4*
13 *acres of land depicted on the Map as “Ingram Can-*
14 *yon”.*

15 (5) *WILLOW NORTH A.*—*The approximately 3.4*
16 *acres of land depicted on the Map as “Willow North*
17 *A”.*

18 (6) *WILLOW NORTH B.*—*The approximately 6.6*
19 *acres of land depicted on the Map as “Willow North*
20 *B”.*

21 (7) *WILLOW SOUTH.*—*The approximately 21.5*
22 *acres of land depicted on the Map as “Willow South”.*

23 (8) *MENDENHALL CANYON.*—*The approximately*
24 *9.8 acres of land depicted on the Map as “Mendenhall*
25 *Canyon”.*

1 (9) *WASH CANYON.*—*The approximately 31.4*
 2 *acres of land depicted on the Map as “Wash Canyon”.*

3 (b) *LANDS ADDED.*—*Subject to valid existing rights,*
 4 *the boundary of the Mount Nebo Wilderness is adjusted to*
 5 *include the approximately 293.2 acres of land depicted on*
 6 *the Map for addition to the Mount Nebo Wilderness. The*
 7 *Utah Wilderness Act of 1984 (Public Law 94–428) shall*
 8 *apply to the land added to the Mount Nebo Wilderness pur-*
 9 *suant to this subsection.*

10 **SEC. 3. MAP.**

11 (a) *DEFINITION.*—*For the purpose of this Act, the term*
 12 *“Map” shall mean the map entitled “Mt. Nebo Wilderness*
 13 *Boundary Adjustment”, numbered 531, and dated May 29,*
 14 *2001.*

15 (b) *MAP ON FILE.*—*The Map and the final document*
 16 *entitled “Mount Nebo, Proposed Boundary Adjustments,*
 17 *Parcel Descriptions (See Map #531)” and dated June 4,*
 18 *2001, shall be on file and available for inspection in the*
 19 *office of the Chief of the Forest Service, Department of Agri-*
 20 *culture.*

21 (c) *CORRECTIONS.*—*The Secretary of Agriculture may*
 22 *make technical corrections to the Map.*

23 **SEC. 4. TECHNICAL BOUNDARY ADJUSTMENT.**

24 *The boundary of the Mount Nebo Wilderness is ad-*
 25 *justed to exclude the approximately 21.26 acres of private*

- 1 *property located in Andrews Canyon, Utah, and depicted*
- 2 *on the Map as “Dale”.*
