Mr. HASTINGS of Washington, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2330) making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 2002, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-

1 ation of the bill (H.R. 2330) making appropriations for
2 Agriculture, Rural Development, Food and Drug Adminis-
3 tration, and Related Agencies programs for the fiscal year
4 ending September 30, 2002, and for other purposes. The
5 first reading of the bill shall be dispensed with. All points
6 of order against consideration of the bill are waived. Gen-
7 eral debate shall be confined to the bill and shall not ex-
8 ceed one hour equally divided and controlled by the chair-
9 man and ranking minority member of the Committee on
10 Appropriations. After general debate the bill shall be con-
11 sidered for amendment under the five-minute rule. The
12 amendment printed in the report of the Committee on
13 Rules accompanying this resolution shall be considered as
14 adopted in the House and in the Committee of the Whole.
15 Points of order against provisions in the bill, as amended,
16 for failure to comply with clause 2 of rule XXI are waived.
17 During consideration of the bill for further amendment,
18 the Chairman of the Committee of the Whole may accord
19 priority in recognition on the basis of whether the Member
20 offering an amendment has caused it to be printed in the
21 portion of the Congressional Record designated for that
22 purpose in clause 8 of rule XVIII. Amendments so printed
23 shall be considered as read. At the conclusion of consider-
24 ation of the bill for amendment the Committee shall rise
25 and report the bill, as amended, to the House with such

1 further amendments as may have been adopted. The pre-
2 vious question shall be considered as ordered on the bill
3 and amendments thereto to final passage without inter-
4 vening motion except one motion to recommit with or
5 without instructions.
