Mr. HASTINGS of Washington, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2646) to provide for the continuation of agricultural programs through fiscal year 2011.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2646) to provide for the continu-
6 ation of agricultural programs through fiscal year 2011.
7 The first reading of the bill shall be dispensed with. All

1 points of order against consideration of the bill are waived.
2 General debate shall be confined to the bill and shall not
3 exceed two hours equally divided and controlled by the
4 chairman and ranking minority member of the Committee
5 on Agriculture. After general debate the bill shall be con-
6 sidered for amendment under the five-minute rule. In lieu
7 of the amendments recommended by the Committees on
8 Agriculture and International Relations now printed in the
9 bill, it shall be in order to consider as an original bill for
10 the purpose of amendment under the five-minute rule an
11 amendment in the nature of a substitute consisting of the
12 text printed in part A of the report of the Committee on
13 Rules accompanying this resolution, modified by the
14 amendment printed in part B of the report. That amend-
15 ment in the nature of a substitute shall be considered as
16 read. All points of order against that amendment in the
17 nature of a substitute are waived. No amendment to that
18 amendment in the nature of a substitute shall be in order
19 except those printed before October 3, 2001, in the portion
20 of the Congressional Record designated for that purpose
21 in clause 8 of rule XVIII and except pro forma amend-
22 ments for the purpose of debate. Each amendment so
23 printed may be offered only by the Member who caused
24 it to be printed or his designee and shall be considered
25 as read. At the conclusion of consideration of the bill for

1 amendment the Committee shall rise and report the bill
2 to the House with such amendments as may have been
3 adopted. Any Member may demand a separate vote in the
4 House on any amendment adopted in the Committee of
5 the Whole to the bill or to the amendment in the nature
6 of a substitute made in order as original text. The previous
7 question shall be considered as ordered on the bill and
8 amendments thereto to final passage without intervening
9 motion except one motion to recommit with or without in-
10 structions.
