Mr. DIAZ-BALART, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 247) to amend the Housing and Community Development Act of 1974 to authorize communities to use community development block grant funds for construction of tornado-safe shelters in manufactured home parks.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-

1 ation of the bill (H.R. 247) to amend the Housing and
2 Community Development Act of 1974 to authorize com-
3 munities to use community development block grant funds
4 for construction of tornado-safe shelters in manufactured
5 home parks. The first reading of the bill shall be dispensed
6 with. General debate shall be confined to the bill and shall
7 not exceed one hour equally divided and controlled by the
8 chairman and ranking minority member of the Committee
9 on Financial Services. After general debate the bill shall
10 be considered for amendment under the five-minute rule.
11 It shall be in order to consider as an original bill for the
12 purpose of amendment under the five-minute rule the
13 amendment in the nature of a substitute printed in the
14 Congressional Record and numbered 1 pursuant to clause
15 8 of rule XVIII. That amendment in the nature of a sub-
16 stitute shall be considered as read. During consideration
17 of the bill for amendment, the Chairman of the Committee
18 of the Whole may accord priority in recognition on the
19 basis of whether the Member offering an amendment has
20 caused it to be printed in the portion of the Congressional
21 Record designated for that purpose in clause 8 of rule
22 XVIII. Amendments so printed shall be considered as
23 read. At the conclusion of consideration of the bill for
24 amendment the Committee shall rise and report the bill
25 to the House with such amendments as may have been

1 adopted. Any Member may demand a separate vote in the
2 House on any amendment adopted in the Committee of
3 the Whole to the bill or to the amendment in the nature
4 of a substitute made in order as original text. The previous
5 question shall be considered as ordered on the bill and
6 amendments thereto to final passage without intervening
7 motion except one motion to recommit with or without in-
8 structions.
