A BILL

To provide for the reauthorization of the breast cancer research special postage stamp, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REAUTHORIZATION OF BREAST CANCER RE-**
2 **SEARCH SPECIAL POSTAGE STAMP.**

3 (a) **SHORT TITLE.**—This Act may be cited as the
4 “Breast Cancer Research Stamp Act of 2001”.

5 (b) **REAUTHORIZATION AND INAPPLICABILITY OF**
6 **LIMITATION.**—

7 (1) **IN GENERAL.**—Section 414 of title 39,
8 United States Code, is amended by striking sub-
9 section (g) and inserting the following:

10 “(g) For purposes of section 416 (including any regu-
11 lation prescribed under subsection (e)(1)(C) of that sec-
12 tion), the special postage stamp issued under this section
13 shall not apply to any limitation relating to whether more
14 than 1 semipostal may be offered for sale at the same
15 time.

16 “(h) This section shall cease to be effective after July
17 29, 2008.”.

18 (2) **EFFECTIVE DATE.**—The amendment made
19 by this subsection shall take effect on the earlier
20 of—

21 (A) the date of enactment of this Act; or

22 (B) July 29, 2002.

23 (c) **RATE OF POSTAGE.**—Section 414(b) of title 39,
24 United States Code, is amended—

1 (1) in paragraph (1), by striking “of not to ex-
2 ceed 25 percent” and inserting “of not less than 15
3 percent”; and

4 (2) by adding after the sentence following para-
5 graph (3) the following: “The special rate of postage
6 of an individual stamp under this section shall be an
7 amount that is evenly divisible by 5.”.
