A BILL

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Native American
 5 Breast and Cervical Cancer Treatment Technical Amend-
 6 ment Act of 2001”.

7 **SEC. 2. CLARIFICATION OF INCLUSION OF INDIAN WOMEN**
 8 **WITH BREAST OR CERVICAL CANCER IN OP-**
 9 **TIONAL MEDICAID ELIGIBILITY CATEGORY.**

10 (a) TECHNICAL AMENDMENT.—The subsection (aa)
 11 of section 1902 of the Social Security Act (42 U.S.C.
 12 1396a) added by section 2(a)(2) of the Breast and Cer-
 13 vical Cancer Prevention and Treatment Act of 2000 (Pub-
 14 lic Law 106–354; 114 Stat. 1381) is amended in para-
 15 graph (4) by inserting “, but applied without regard to
 16 paragraph (1)(F) of such section” before the period at the
 17 end.

18 (b) BIPA TECHNICAL AMENDMENTS.—

19 (1) Section 1902 of the Social Security Act (42
 20 U.S.C. 1396a), as amended by section 702(b) of the
 21 Medicare, Medicaid, and SCHIP Benefits Improve-
 22 ment and Protection Act of 2000 (114 Stat. 2763A–
 23 572) (as enacted into law by section 1(a)(6) of Pub-
 24 lic Law 106–554), is amended by redesignating the

1 subsection (aa) added by such section as subsection
 2 (bb).

3 (2) Section 1902(a)(15) of the Social Security
 4 Act (42 U.S.C. 1396a(a)(15)), as added by section
 5 702(a)(2) of the Medicare, Medicaid, and SCHIP
 6 Benefits Improvement and Protection Act of 2000
 7 (114 Stat. 2763A–572) (as so enacted into law), is
 8 amended by striking “subsection (aa)” and inserting
 9 “subsection (bb)”.

10 (3) Section 1915(b) of the Social Security Act
 11 (42 U.S.C. 1396n(b)), as amended by section
 12 702(c)(2) of the Medicare, Medicaid, and SCHIP
 13 Benefits Improvement and Protection Act of 2000
 14 (114 Stat. 2763A–574) (as so enacted into law), is
 15 amended by striking “1902(aa)” and inserting
 16 “1902(bb)”.

17 (c) EFFECTIVE DATES.—

18 (1) BCCPTA TECHNICAL AMENDMENT.—The
 19 amendment made by subsection (a) shall take effect
 20 as if included in the enactment of the Breast and
 21 Cervical Cancer Prevention and Treatment Act of
 22 2000 (Public Law 106–354; 114 Stat. 1381).

23 (2) BIPA TECHNICAL AMENDMENTS.—The
 24 amendments made by subsection (b) shall take effect
 25 as if included in the enactment of section 702 of the

1 Medicare, Medicaid, and SCHIP Benefits Improve-
2 ment and Protection Act of 2000 (114 Stat. 2763A–
3 572) (as enacted into law by section 1(a)(6) of Pub-
4 lic Law 106–554).
