A BILL

To encourage the negotiated settlement of tribal claims.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SETTLEMENT OF TRIBAL CLAIMS.**

4 (a) ~~IN GENERAL.—Solely for purposes of providing~~
5 ~~an opportunity to explore the settlement of tribal claims,~~
6 ~~during fiscal year 2002, the statute of limitations shall~~
7 ~~be deemed not to have run for any claim concerning losses~~
8 ~~to or mismanagement of tribal trust funds.~~

1 (b) **NO PRECLUSION OF FINDINGS.**—Nothing in this
 2 section precludes a court or other adjudicatory entity from
 3 adjudicating a statute of limitations defense either:

4 (1) in an action filed on or after October 1,
 5 2002; or

6 (2) in any case, controversy, or other pro-
 7 ceeding pending on the date of enactment of this
 8 section against the United States in which a court
 9 or adjudicatory entity is called on to determine
 10 whether the statute of limitations on such a claim
 11 has run.

12 **SECTION 1. SETTLEMENT OF TRIBAL CLAIMS.**

13 (a) *IN GENERAL.*—Notwithstanding any other provi-
 14 sion of law, for purposes of determining the date on which
 15 an Indian tribe received a reconciliation report for purposes
 16 of applying a statute of limitations, any such report pro-
 17 vided to or received by an Indian tribe in response to sec-
 18 tion 304 of the American Indian Trust Fund Management
 19 Reform Act of 1994 (25 U.S.C. 4044) shall be deemed to
 20 have been received by the Indian tribe on December 31,
 21 1999.

22 (b) *STATEMENT OF PURPOSE.*—Subsection (a) is solely
 23 intended to provide recipients of reconciliation reports with
 24 the opportunity to postpone the filing of claims, or to facili-

- 1 *tate the voluntary dismissal of claims, to encourage settle-*
- 2 *ment negotiations with the United States.*
