To establish the Carter G. Woodson Home National Historic Site in the District of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Carter G. Woodson
3 Home National Historic Site Establishment Act of 2003”.

4 **SEC. 2. FINDINGS AND PURPOSE.**

5 (a) FINDINGS.—The Congress finds that:

6 (1) Dr. Carter G. Woodson, considered the fa-
7 ther of African-American history, founded in 1915
8 The Association for the Study of Negro Life and
9 History, renamed as The Association for the Study
10 of African-American Life and History.

11 (2) Through the Association, Dr. Woodson, the
12 son of slaves who earned a Ph.D. degree from Har-
13 vard University, dedicated his life to educating the
14 American public about the extensive and positive
15 contributions of African Americans to the Nation’s
16 history and culture.

17 (3) Under Dr. Woodson’s leadership, Negro
18 History Week was designated in 1926. That des-
19 ignation has since evolved into Black History Month
20 in February of each year.

21 (4) The headquarters and operations of the As-
22 sociation was Dr. Woodson’s home at 1538 Ninth
23 Street, Northwest, Washington, D.C., where he lived
24 from 1915 to 1950.

25 (5) The Carter G. Woodson Home was des-
26 ignated as a National Historic Landmark in 1976

1 for its national significance in African-American cul-
2 tural heritage.

3 (6) A National Park Service study of the Carter
4 G. Woodson Home dated June 2002, found that the
5 Carter G. Woodson Home is suitable for designation
6 as a unit of the National Park System, and is fea-
7 sible for designation so long as property adjacent to
8 the home is available for National Park Service ad-
9 ministrative, curatorial, access, and visitor interpre-
10 tative needs.

11 (7) Establishment of the Carter G. Woodson
12 Home National Historic Site would foster opportuni-
13 ties for developing and promoting interpretation of
14 African-American cultural heritage throughout the
15 Shaw area of Washington, D.C.

16 (b) PURPOSE.—The purpose of this Act is to pre-
17 serve, protect, and interpret for the benefit, education, and
18 inspiration of present and future generations, the home
19 of the preeminent historian and educator Dr. Carter G.
20 Woodson, founder of the organization known today as The
21 Association for the Study of African-American Life and
22 History.

23 **SEC. 3. DEFINITIONS.**

24 In this Act:

1 (1) The term “Secretary” means the Secretary
2 of the Interior.

3 (2) The term “historic site” means the Carter
4 G. Woodson Home National Historic Site.

5 (3) The term “map” means the map entitled
6 “Carter G. Woodson Home National Historic Site”,
7 numbered 876/82338 and dated February 10, 2003.

8 **SEC. 4. CARTER G. WOODSON HOME NATIONAL HISTORIC**
9 **SITE.**

10 (a) ESTABLISHMENT.—After the Secretary has ac-
11 quired, or agreed to a long-term lease for, the majority
12 of the property described in subsection (b), the Secretary
13 shall establish as a unit of the National Park System the
14 Carter G. Woodson Home National Historic Site.

15 (b) BOUNDARY.—The historic site shall consist of the
16 property located at 1538 Ninth Street, Northwest, in the
17 District of Columbia and three adjoining houses north of
18 that address, as depicted on the map, if acquired or leased
19 by the Secretary.

20 (c) AVAILABILITY OF MAP.—The map shall be avail-
21 able for public inspection in the appropriate offices of the
22 National Park Service, Department of the Interior.

23 (d) ACQUISITION.—The Secretary may acquire lands
24 or interests in lands, and improvements thereon, within
25 the boundary of the historic site from willing owners by

1 donation, purchase with donated or appropriated funds,
2 or exchange.

3 (e) ADMINISTRATION.—

4 (1) IN GENERAL.—The Secretary shall admin-
5 ister the historic site in accordance with this Act
6 and with laws generally applicable to units of the
7 National Park System, including the Act of August
8 25, 1916 (commonly known as the National Park
9 Service Organic Act; 16 U.S.C. 1 et seq.), and the
10 Act of August 21, 1935 (commonly known as the
11 Historic Sites, Buildings, and Antiquities Act; 16
12 U.S.C. 461 et seq.).

13 (2) REHABILITATION AGREEMENT.—In order to
14 achieve cost efficiencies in the restoration of prop-
15 erty, the Secretary may enter into an agreement
16 with the Shiloh Community Development Corpora-
17 tion for the purpose of rehabilitating the Carter G.
18 Woodson Home and other property within the
19 boundary of the historic site. The agreement may
20 contain such terms and conditions as the Secretary
21 deems appropriate.

22 (3) OPERATION AGREEMENT.—In order to rees-
23 tablish the historical connection between the home of
24 Dr. Woodson and the association he founded and to
25 facilitate interpretation of Dr. Woodson’s achieve-

1 ments, the Secretary may enter into an agreement
2 with The Association for the Study of African-Amer-
3 ican Life and History that allows the association to
4 use a portion of the historic site for its own adminis-
5 trative purposes. The agreement may contain such
6 terms and conditions as the Secretary deems appro-
7 priate.

8 (4) COOPERATIVE AGREEMENTS.—The Sec-
9 retary may enter into cooperative agreements with
10 public and private entities for the purpose of fos-
11 tering interpretation of African-American heritage in
12 the Shaw area of Washington, D.C.

13 (5) GENERAL MANAGEMENT PLAN.—The Sec-
14 retary shall prepare a general management plan for
15 the historic site within three years after funds are
16 made available for that purpose.

17 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

18 There are authorized to be appropriated such sums
19 as are necessary to carry out this Act.
