3 **TITLE I—GENERAL PROVISIONS**

4 **SEC. 101. GENERAL DEFINITIONS.**

5 *Section 202 of the Museum and Library Services Act*

6 *(20 U.S.C. 9101) is amended—*

1 (1) *by striking paragraph (1) and inserting the*
 2 *following:*

3 “(1) *DETERMINED TO BE OBSCENE.*—*The term*
 4 *‘determined to be obscene’ means determined, in a*
 5 *final judgment of a court of record and of competent*
 6 *jurisdiction in the United States, to be obscene.’;*”

7 (2) *by striking paragraph (4);*

8 (3) *by redesignating paragraph (3) as para-*
 9 *graph (5);*

10 (4) *by inserting after paragraph (2) the fol-*
 11 *lowing:*

12 “(3) *FINAL JUDGMENT.*—*The term ‘final judg-*
 13 *ment’ means a judgment that is—*

14 “(A) *not reviewed by any other court that*
 15 *has authority to review such judgment; or*

16 “(B) *not reviewable by any other court.*

17 “(4) *INDIAN TRIBE.*—*The term ‘Indian tribe’*
 18 *means any tribe, band, nation, or other organized*
 19 *group or community, including any Alaska native*
 20 *village, regional corporation, or village corporation*
 21 *(as defined in, or established pursuant to, the Alaska*
 22 *Native Claims Settlement Act (43 U.S.C. 1601 et*
 23 *seq.)), which is recognized by the Secretary of the In-*
 24 *terior as eligible for the special programs and services*

1 *provided by the United States to Indians because of*
 2 *their status as Indians.”; and*

3 *(5) by adding at the end the following:*

4 “(6) *MUSEUM AND LIBRARY SERVICES BOARD.*—
 5 *The term ‘Museum and Library Services Board’*
 6 *means the National Museum and Library Services*
 7 *Board established under section 207.*

8 “(7) *OBSCENE.*—*The term ‘obscene’ means, with*
 9 *respect to a project, that—*

10 “(A) *the average person, applying contem-*
 11 *porary community standards, would find that*
 12 *such project, when taken as a whole, appeals to*
 13 *the prurient interest;*

14 “(B) *such project depicts or describes sexual*
 15 *conduct in a patently offensive way; and*

16 “(C) *such project, when taken as a whole,*
 17 *lacks serious literary, artistic, political, or sci-*
 18 *entific value.”.*

19 **SEC. 102. INSTITUTE OF MUSEUM AND LIBRARY SERVICES.**

20 *Section 203 of the Museum and Library Services Act*
 21 *(20 U.S.C. 9102) is amended—*

22 *(1) in subsection (b), by striking the last sen-*
 23 *tence; and*

24 *(2) by adding at the end the following:*

1 “(c) *MUSEUM AND LIBRARY SERVICES BOARD.*—*There*
 2 *shall be a National Museum and Library Services Board*
 3 *within the Institute, as provided under section 207.”.*

4 **SEC. 103. DIRECTOR OF THE INSTITUTE.**

5 *Section 204 of the Museum and Library Services Act*
 6 *(20 U.S.C. 9103) is amended—*

7 *(1) in subsection (e), by adding at the end the*
 8 *following: “Where appropriate, the Director shall en-*
 9 *sure that activities under subtitle B are coordinated*
 10 *with activities under section 1251 of the Elementary*
 11 *and Secondary Education Act of 1965 (20 U.S.C.*
 12 *6383).”; and*

13 *(2) by adding at the end the following:*

14 “(f) *REGULATORY AUTHORITY.*—*The Director may*
 15 *promulgate such rules and regulations as are necessary and*
 16 *appropriate to implement the provisions of this title.*

17 “(g) *APPLICATION PROCEDURES.*—

18 “(1) *IN GENERAL.*—*In order to be eligible to re-*
 19 *ceive financial assistance under this title, a person or*
 20 *agency shall submit an application in accordance*
 21 *with procedures established by the Director by regula-*
 22 *tion.*

23 “(2) *REVIEW AND EVALUATION.*—*The Director*
 24 *shall establish procedures for reviewing and evalu-*
 25 *ating applications submitted under this title. Actions*

1 *of the Institute and the Director in the establishment,*
 2 *modification, and revocation of such procedures under*
 3 *this Act are vested in the discretion of the Institute*
 4 *and the Director. In establishing such procedures, the*
 5 *Director shall ensure that the criteria by which appli-*
 6 *cations are evaluated are consistent with the purposes*
 7 *of this title, taking into consideration general stand-*
 8 *ards of decency and respect for the diverse beliefs and*
 9 *values of the American public.*

10 “(3) *TREATMENT OF PROJECTS DETERMINED TO*
 11 *BE OBSCENE.—*

12 “(A) *IN GENERAL.—The procedures de-*
 13 *scribed in paragraph (2) shall include provisions*
 14 *that clearly specify that obscenity is without se-*
 15 *rious literary, artistic, political, or scientific*
 16 *merit, and is not protected speech.*

17 “(B) *PROHIBITION.—No financial assist-*
 18 *ance may be provided under this title with re-*
 19 *spect to any project that is determined to be ob-*
 20 *scene.*

21 “(C) *TREATMENT OF APPLICATION DIS-*
 22 *APPROVAL.—The disapproval of an application*
 23 *by the Director shall not be construed to mean,*
 24 *and shall not be considered as evidence that, the*

1 *project for which the applicant requested finan-*
 2 *cial assistance is or is not obscene.”.*

3 **SEC. 104. NATIONAL MUSEUM AND LIBRARY SERVICES**
 4 **BOARD.**

5 *The Museum and Library Services Act (20 U.S.C.*
 6 *9101 et seq.) is amended—*

7 *(1) by redesignating section 207 as section 208;*
 8 *and*

9 *(2) by inserting after section 206 the following:*

10 **“SEC. 207. NATIONAL MUSEUM AND LIBRARY SERVICES**
 11 **BOARD.**

12 *“(a) ESTABLISHMENT.—There is established within*
 13 *the Institute a board to be known as the ‘National Museum*
 14 *and Library Services Board’.*

15 *“(b) MEMBERSHIP.—*

16 *“(1) NUMBER AND APPOINTMENT.—The Museum*
 17 *and Library Services Board shall be composed of the*
 18 *following:*

19 *“(A) The Director.*

20 *“(B) The Deputy Director for the Office of*
 21 *Library Services.*

22 *“(C) The Deputy Director for the Office of*
 23 *Museum Services.*

24 *“(D) The Chairman of the National Com-*
 25 *mission on Libraries and Information Science.*

1 “(E) 10 members appointed by the Presi-
 2 dent, by and with the advice and consent of the
 3 Senate, from among individuals who are citizens
 4 of the United States and who are specially quali-
 5 fied by virtue of their education, training, or ex-
 6 perience in the area of library services, or their
 7 commitment to libraries.

8 “(F) 10 members appointed by the Presi-
 9 dent, by and with the advice and consent of the
 10 Senate, from among individuals who are citizens
 11 of the United States and who are specially quali-
 12 fied by virtue of their education, training, or ex-
 13 perience in the area of museum services, or their
 14 commitment to museums.

15 “(2) SPECIAL QUALIFICATIONS.—

16 “(A) LIBRARY MEMBERS.—Of the members
 17 of the Museum and Library Services Board ap-
 18 pointed under paragraph (1)(E)—

19 “(i) 5 shall be professional librarians
 20 or information specialists, of whom—

21 “(I) not less than 1 shall be
 22 knowledgeable about electronic infor-
 23 mation and technical aspects of library
 24 and information services and sciences;
 25 and

1 “(II) not less than 1 other shall be
 2 knowledgeable about the library and
 3 information service needs of under-
 4 served communities; and

5 “(ii) the remainder shall have special
 6 competence in, or knowledge of, the needs
 7 for library and information services in the
 8 United States.

9 “(B) MUSEUM MEMBERS.—Of the members
 10 of the Museum and Library Services Board ap-
 11 pointed under paragraph (1)(F)—

12 “(i) 5 shall be museum professionals
 13 who are or have been affiliated with—

14 “(I) resources that, collectively,
 15 are broadly representative of the cura-
 16 torial, conservation, educational, and
 17 cultural resources of the United States;
 18 or

19 “(II) museums that, collectively,
 20 are broadly representative of various
 21 types of museums, including museums
 22 relating to science, history, technology,
 23 art, zoos, botanical gardens, and muse-
 24 ums designed for children; and

1 “(ii) *the remainder shall be individ-*
 2 *uals recognized for their broad knowledge,*
 3 *expertise, or experience in museums or com-*
 4 *mitment to museums.*

5 “(3) *GEOGRAPHIC AND OTHER REPRESENTA-*
 6 *TION.—Members of the Museum and Library Services*
 7 *Board shall be appointed to reflect persons from var-*
 8 *ious geographic regions of the United States. The Mu-*
 9 *seum and Library Services Board may not include,*
 10 *at any time, more than 3 appointive members from*
 11 *a single State. In making such appointments, the*
 12 *President shall give due regard to equitable represen-*
 13 *tation of women, minorities, and persons with dis-*
 14 *abilities who are involved with museums and librar-*
 15 *ies.*

16 “(4) *VOTING.—The Director, the Deputy Direc-*
 17 *tor of the Office of Library Services, the Deputy Di-*
 18 *rector of the Office of Museum Services, and the*
 19 *Chairman of the National Commission on Library*
 20 *and Information Science shall be nonvoting members*
 21 *of the Museum and Library Services Board.*

22 “(c) *TERMS.—*

23 “(1) *IN GENERAL.—Except as otherwise provided*
 24 *in this subsection, each member of the Museum and*
 25 *Library Services Board appointed under subpara-*

1 *graph (E) or (F) of subsection (b)(1) shall serve for*
2 *a term of 5 years.*

3 “(2) *INITIAL BOARD APPOINTMENTS.*—

4 “(A) *TREATMENT OF MEMBERS SERVING ON*
5 *EFFECTIVE DATE.*—*Notwithstanding subsection*
6 *(b), each individual who is a member of the Na-*
7 *tional Museum Services Board on the date of en-*
8 *actment of the Museum and Library Services Act*
9 *of 2003, may, at the individual’s election, com-*
10 *plete the balance of the individual’s term as a*
11 *member of the Museum and Library Services*
12 *Board.*

13 “(B) *FIRST APPOINTMENTS.*—*Notwith-*
14 *standing subsection (b), any appointive vacancy*
15 *in the initial membership of the Museum and*
16 *Library Services Board existing after the appli-*
17 *cation of subparagraph (A), and any vacancy in*
18 *such membership subsequently created by reason*
19 *of the expiration of the term of an individual de-*
20 *scribed in subparagraph (A), shall be filled by*
21 *the appointment of a member described in sub-*
22 *section (b)(1)(E). When the Museum and Li-*
23 *brary Services Board consists of an equal num-*
24 *ber of individuals who are specially qualified in*
25 *the area of library services and individuals who*

1 *are specially qualified in the area of museum*
 2 *services, this subparagraph shall cease to be effec-*
 3 *tive and the board shall be appointed in accord-*
 4 *ance with subsection (b).*

5 *“(C) AUTHORITY TO ADJUST TERMS.—The*
 6 *terms of the first members appointed to the Mu-*
 7 *seum and Library Service Board shall be ad-*
 8 *justed by the President as necessary to ensure*
 9 *that the terms of not more than 4 members ex-*
 10 *pire in the same year. Such adjustments shall be*
 11 *carried out through designation of the adjusted*
 12 *term at the time of appointment.*

13 *“(3) VACANCIES.—Any member appointed to fill*
 14 *a vacancy shall serve for the remainder of the term*
 15 *for which the predecessor of the member was ap-*
 16 *pointed.*

17 *“(4) REAPPOINTMENT.—No appointive member*
 18 *of the Museum and Library Services Board who has*
 19 *been a member for more than 7 consecutive years*
 20 *shall be eligible for reappointment.*

21 *“(5) SERVICE UNTIL SUCCESSOR TAKES OF-*
 22 *FICE.—Notwithstanding any other provision of this*
 23 *subsection, an appointive member of the Museum and*
 24 *Library Services Board shall serve after the expira-*

1 *tion of the term of the member until the successor to*
 2 *the member takes office.*

3 “(d) *DUTIES AND POWERS.*—

4 “(1) *IN GENERAL.*—*The Museum and Library*
 5 *Services Board shall advise the Director on general*
 6 *policies with respect to the duties, powers, and au-*
 7 *thority of the Institute relating to museum and li-*
 8 *brary services, including financial assistance awarded*
 9 *under this title.*

10 “(2) *NATIONAL AWARDS.*—*The Museum and Li-*
 11 *brary Services Board shall advise the Director in*
 12 *making awards under section 209.*

13 “(e) *CHAIRPERSON.*—*The Director shall serve as*
 14 *Chairperson of the Museum and Library Services Board.*

15 “(f) *MEETINGS.*—

16 “(1) *IN GENERAL.*—*The Museum and Library*
 17 *Services Board shall meet not less than 2 times each*
 18 *year and at the call of the Director.*

19 “(2) *VOTE.*—*All decisions by the Museum and*
 20 *Library Services Board with respect to the exercise of*
 21 *its duties and powers shall be made by a majority*
 22 *vote of the members of the Board who are present and*
 23 *authorized to vote.*

24 “(g) *QUORUM.*—*A majority of the voting members of*
 25 *the Museum and Library Services Board shall constitute*

1 *a quorum for the conduct of business at official meetings,*
 2 *but a lesser number of members may hold hearings.*

3 “(h) *COMPENSATION AND TRAVEL EXPENSES.*—

4 “(1) *COMPENSATION.*—*Each member of the Mu-*
 5 *seum and Library Services Board who is not an offi-*
 6 *cer or employee of the Federal Government may be*
 7 *compensated at a rate to be fixed by the President,*
 8 *but not to exceed the daily equivalent of the max-*
 9 *imum annual rate of pay authorized for a position*
 10 *above grade GS–15 of the General Schedule under sec-*
 11 *tion 5108 of title 5, United States Code, for each day*
 12 *(including travel time) during which such member is*
 13 *engaged in the performance of the duties of the Mu-*
 14 *seum and Library Services Board. Members of the*
 15 *Museum and Libraries Services Board who are full-*
 16 *time officers or employees of the Federal Government*
 17 *may not receive additional pay, allowances, or bene-*
 18 *fits by reason of their service on the Museum and Li-*
 19 *brary Services Board.*

20 “(2) *TRAVEL EXPENSES.*—*Each member of the*
 21 *Museum and Library Services Board shall receive*
 22 *travel expenses, including per diem in lieu of subsist-*
 23 *ence, in accordance with applicable provisions under*
 24 *subchapter I of chapter 57 of title 5, United States*
 25 *Code.*

1 “(i) *COORDINATION.*—*The Director, with the advice of*
 2 *the Museum and Library Services Board, shall take steps*
 3 *to ensure that the policies and activities of the Institute are*
 4 *coordinated with other activities of the Federal Govern-*
 5 *ment.*”.

6 **SEC. 105. AWARDS; ANALYSIS OF IMPACT OF SERVICES.**

7 *The Museum and Library Services Act (20 U.S.C.*
 8 *9101 et seq.) is amended by inserting after section 208 (as*
 9 *redesignated by section 104 of this Act) the following:*

10 **“SEC. 209. AWARDS.**

11 *“The Director, with the advice of the Museum and Li-*
 12 *brary Services Board, may annually award National*
 13 *Awards for Library Service and National Awards for Mu-*
 14 *seum Service to outstanding libraries and outstanding mu-*
 15 *seums, respectively, that have made significant contribu-*
 16 *tions in service to their communities.*

17 **“SEC. 210. ANALYSIS OF IMPACT OF MUSEUM AND LIBRARY**
 18 **SERVICES.**

19 *“From amounts described in sections 214(c) and*
 20 *275(b), the Director shall carry out and publish analyses*
 21 *of the impact of museum and library services. Such*
 22 *analyses—*

23 *“(1) shall be conducted in ongoing consultation*
 24 *with—*

25 *“(A) State library administrative agencies;*

1 “(B) State, regional, and national library
2 and museum organizations; and

3 “(C) other relevant agencies and organiza-
4 tions;

5 “(2) shall identify national needs for, and trends
6 of, museum and library services provided with funds
7 made available under subtitles B and C;

8 “(3) shall report on the impact and effectiveness
9 of programs conducted with funds made available by
10 the Institute in addressing such needs; and

11 “(4) shall identify, and disseminate information
12 on, the best practices of such programs to the agencies
13 and entities described in paragraph (1).

14 **“SEC. 210A. PROHIBITION ON USE OF FUNDS FOR CON-**
15 **STRUCTION.**

16 “No funds appropriated to carry out the Museum and
17 Library Services Act, the Library Services and Technology
18 Act, or the Museum Services Act may be used for construc-
19 tion expenses.”.

20 **TITLE II—LIBRARY SERVICES**
21 **AND TECHNOLOGY**

22 **SEC. 201. PURPOSE.**

23 Section 212 of the Library Services and Technology
24 Act (20 U.S.C. 9121) is amended by striking paragraphs
25 (2) through (5) and inserting the following:

1 “(2) to promote improvement in library services
2 in all types of libraries in order to better serve the
3 people of the United States;

4 “(3) to facilitate access to resources in all types
5 of libraries for the purpose of cultivating an educated
6 and informed citizenry; and

7 “(4) to encourage resource sharing among all
8 types of libraries for the purpose of achieving eco-
9 nomical and efficient delivery of library services to
10 the public.”.

11 **SEC. 202. DEFINITIONS.**

12 Section 213 of the Library Services and Technology
13 Act (20 U.S.C. 9122) is amended—

14 (1) by striking paragraph (1); and

15 (2) by redesignating paragraphs (2), (3), (4),
16 (5), and (6) as paragraphs (1), (2), (3), (4), and (5),
17 respectively.

18 **SEC. 203. AUTHORIZATION OF APPROPRIATIONS.**

19 Section 214 of the Library Services and Technology
20 Act (20 U.S.C. 9123) is amended—

21 (1) by striking subsection (a) and inserting the
22 following:

23 “(a) *IN GENERAL.*—There are authorized to be appro-
24 priated to carry out this subtitle \$232,000,000 for fiscal

1 *year 2004 and such sums as may be necessary for fiscal*
 2 *years 2005 through 2009.”; and*

3 *(2) in subsection (c), by striking “3 percent” and*
 4 *inserting “3.5 percent”.*

5 **SEC. 204. RESERVATIONS AND ALLOTMENTS.**

6 *Section 221(b)(3) of the Library Services and Tech-*
 7 *nology Act (20 U.S.C. 9131(b)(3)) is amended to read as*
 8 *follows:*

9 *“(3) MINIMUM ALLOTMENTS.—*

10 *“(A) IN GENERAL.—For purposes of this*
 11 *subsection, the minimum allotment for each*
 12 *State shall be \$340,000, except that the min-*
 13 *imum allotment shall be \$40,000 in the case of*
 14 *the United States Virgin Islands, Guam, Amer-*
 15 *ican Samoa, the Commonwealth of the Northern*
 16 *Mariana Islands, the Republic of the Marshall*
 17 *Islands, the Federated States of Micronesia, and*
 18 *the Republic of Palau.*

19 *“(B) RATABLE REDUCTIONS.—Notwith-*
 20 *standing subparagraph (A), if the sum appro-*
 21 *priated under the authority of section 214 and*
 22 *not reserved under subsection (a) for any fiscal*
 23 *year is insufficient to fully satisfy the require-*
 24 *ment of subparagraph (A), each of the minimum*

1 *allotments under such subparagraph shall be re-*
 2 *duced ratably.*

3 “(C) *EXCEPTION.*—

4 “(i) *IN GENERAL.*—Notwithstanding
 5 *subparagraph (A), if the sum appropriated*
 6 *under the authority of section 214 and not*
 7 *reserved under subsection (a) for any fiscal*
 8 *year exceeds the aggregate of the allotments*
 9 *for all States under this subsection for fiscal*
 10 *year 2003—*

11 “(I) *the minimum allotment for*
 12 *each State otherwise receiving a min-*
 13 *imum allotment of \$340,000 under*
 14 *subparagraph (A) shall be increased to*
 15 *\$680,000; and*

16 “(II) *the minimum allotment for*
 17 *each State otherwise receiving a min-*
 18 *imum allotment of \$40,000 under sub-*
 19 *paragraph (A) shall be increased to*
 20 *\$60,000.*

21 “(ii) *INSUFFICIENT FUNDS TO AWARD*
 22 *ALTERNATIVE MINIMUM.*—*If the sum appro-*
 23 *priated under the authority of section 214*
 24 *and not reserved under subsection (a) for*
 25 *any fiscal year exceeds the aggregate of the*

allotments for all States under this subsection for fiscal year 2003 yet is insufficient to fully satisfy the requirement of clause (i), such excess amount shall first be allotted among the States described in clause (i)(I) so as to increase equally the minimum allotment for each such State above \$340,000. After the requirement of clause (i)(I) is fully satisfied for any fiscal year, any remainder of such excess amount shall be allotted among the States described in clause (i)(II) so as to increase equally the minimum allotment for each such State above \$40,000.

“(D) SPECIAL RULE.—

“(i) IN GENERAL.—Notwithstanding any other provision of this subsection and using funds allotted for the Republic of the Marshall Islands, the Federated States of Micronesia, and the Republic of Palau under this subsection, the Director shall award grants to the United States Virgin Islands, Guam, American Samoa, the Commonwealth of the Northern Mariana Islands, the Republic of the Marshall Islands,

1 *the Federated States of Micronesia, or the*
 2 *Republic of Palau to carry out activities de-*
 3 *scribed in this subtitle in accordance with*
 4 *the provisions of this subtitle that the Direc-*
 5 *tor determines are not inconsistent with this*
 6 *subparagraph.*

7 “(ii) *AWARD BASIS.—The Director*
 8 *shall award grants pursuant to clause (i)*
 9 *on a competitive basis and after taking into*
 10 *consideration available recommendations*
 11 *from the Pacific Region Educational Lab-*
 12 *oratory in Honolulu, Hawaii.*

13 “(iii) *ADMINISTRATIVE COSTS.—The*
 14 *Director may provide not more than 5 per-*
 15 *cent of the funds made available for grants*
 16 *under this subparagraph to pay the admin-*
 17 *istrative costs of the Pacific Region Edu-*
 18 *cational Laboratory regarding activities as-*
 19 *sisted under this subparagraph.”.*

20 **SEC. 205. STATE PLANS.**

21 *Section 224 of the Library Services and Technology*
 22 *Act (20 U.S.C. 9134) is amended—*

23 *(1) in subsection (a)(1), by striking “not later*
 24 *than April 1, 1997.” and inserting “once every 5*
 25 *years, as determined by the Director.”; and*

1 (2) *in subsection (f)—*

2 (A) *by striking “this Act” each place such*
3 *term appears and inserting “this subtitle”;*

4 (B) *in paragraph (1)—*

22 “(1) *expanding services for learning and access*
23 *to information and educational resources in a variety*
24 *of formats, in all types of libraries, for individuals of*
25 *all ages;*

 3 *gional, national, and international electronic net-*
 4 *works;*

5 “(3) *providing electronic and other linkages*
 6 *among and between all types of libraries;*

7 “(4) *developing public and private partnerships*
 8 *with other agencies and community-based organiza-*

10 “(5) *targeting library services to individuals of*
 11 *diverse geographic, cultural, and socioeconomic back-*
 12 *grounds, to individuals with disabilities, and to indi-*
 13 *viduals with limited functional literacy or informa-*
 14 *tion skills; and*

15 “(6) *targeting library and information services*
 16 *to persons having difficulty using a library and to*
 17 *underserved urban and rural communities, including*
 18 *children (from birth through age 17) from families*

13 **“SEC. 271. PURPOSE.**

14 *“It is the purpose of this subtitle—*

15 *“(1) to encourage and support museums in car-*
 16 *rying out their public service role of connecting the*
 17 *whole of society to the cultural, artistic, historical,*
 18 *natural, and scientific understandings that constitute*
 19 *our heritage;*

20 *“(2) to encourage and support museums in car-*
 21 *rying out their educational role, as core providers of*
 22 *learning and in conjunction with schools, families,*
 23 *and communities;*

1 “(3) to encourage leadership, innovation, and
 2 applications of the most current technologies and
 3 practices to enhance museum services;

4 “(4) to assist, encourage, and support museums
 5 in carrying out their stewardship responsibilities to
 6 achieve the highest standards in conservation and
 7 care of the cultural, historic, natural, and scientific
 8 heritage of the United States to benefit future genera-
 9 tions;

10 “(5) to assist, encourage, and support museums
 11 in achieving the highest standards of management
 12 and service to the public, and to ease the financial
 13 burden borne by museums as a result of their increas-
 14 ing use by the public; and

15 “(6) to support resource sharing and partner-
 16 ships among museums, libraries, schools, and other
 17 community organizations.”.

18 **SEC. 302. DEFINITIONS.**

19 Section 272(1) of the Museum and Library Services
 20 Act (20 U.S.C. 9172(1)) is amended by adding at the end
 21 the following: “Such term includes aquariums, arboretums,
 22 botanical gardens, art museums, children’s museums, gen-
 23 eral museums, historic houses and sites, history museums,
 24 nature centers, natural history and anthropology museums,

1 *planetariums, science and technology centers, specialized*
 2 *museums, and zoological parks.”.*

3 **SEC. 303. MUSEUM SERVICES ACTIVITIES.**

6 **“SEC. 273. MUSEUM SERVICES ACTIVITIES.**

 10 *erative agreements, and other forms of assistance, with mu-*

 15 *cational resources in a variety of formats (including*
 16 *exhibitions, programs, publications, and websites) for*

18 *“(2) supporting museums in building learning*
 19 *partnerships with the Nation’s schools and developing*
 20 *museum resources and programs in support of State*
 21 *and local school curricula;*

22 *“(3) supporting museums in assessing, con-*
 23 *serving, researching, maintaining, and exhibiting*
 24 *their collections, and in providing educational pro-*

1 *grams to the public through the use of their collec-*
2 *tions;*

3 *“(4) stimulating greater collaboration among*
4 *museums, libraries, schools, and other community or-*
5 *ganizations in order to share resources and strengthen*
6 *communities;*

7 *“(5) encouraging the use of new technologies and*
8 *broadcast media to enhance access to museum collec-*
9 *tions, programs, and services;*

10 *“(6) supporting museums in providing services*
11 *to people of diverse geographic, cultural, and socio-*
12 *economic backgrounds and to individuals with dis-*
13 *abilities;*

14 *“(7) supporting museums in developing and car-*
15 *rying out specialized programs for specific segments*
16 *of the public, such as programs for urban neighbor-*
17 *hoods, rural areas, Indian reservations, and State in-*
18 *stitutions;*

19 *“(8) supporting professional development and*
20 *technical assistance programs to enhance museum op-*
21 *erations at all levels, in order to ensure the highest*
22 *standards in all aspects of museum operations;*

23 *“(9) supporting museums in research, program*
24 *evaluation, and the collection and dissemination of*

1 *information to museum professionals and the public;*
 2 *and*

3 *“(10) encouraging, supporting, and dissemi-*
 4 *nating model programs of museum and library col-*
 5 *laboration.*

6 *“(b) FEDERAL SHARE.—*

7 *“(1) 50 PERCENT.—Except as provided in para-*
 8 *graph (2), the Federal share described in subsection*
 9 *(a) shall be not more than 50 percent.*

10 *“(2) GREATER THAN 50 PERCENT.—The Director*
 11 *may use not more than 20 percent of the funds made*
 12 *available under this subtitle for a fiscal year to enter*
 13 *into arrangements under subsection (a) for which the*
 14 *Federal share may be greater than 50 percent.*

15 *“(3) OPERATIONAL EXPENSES.—No funds for*
 16 *operational expenses may be provided under this sec-*
 17 *tion to any entity that is not a museum.*

18 *“(c) REVIEW AND EVALUATION.—*

19 *“(1) IN GENERAL.—The Director shall establish*
 20 *procedures for reviewing and evaluating arrange-*
 21 *ments described in subsection (a) entered into under*
 22 *this subtitle.*

23 *“(2) APPLICATIONS FOR TECHNICAL ASSIST-*
 24 *ANCE.—*

1 “(A) *IN GENERAL.*—*The Director may use*
 2 *not more than 10 percent of the funds appro-*
 3 *priated to carry out this subtitle for technical as-*
 4 *stance awards.*

5 “(B) *INDIVIDUAL MUSEUMS.*—*Individual*
 6 *museums may receive not more than 3 technical*
 7 *assistance awards under subparagraph (A), but*
 8 *subsequent awards for technical assistance shall*
 9 *be subject to review outside the Institute.*

10 “(d) *SERVICES FOR NATIVE AMERICANS.*—*From*
 11 *amounts appropriated under section 275, the Director shall*
 12 *reserve 1.75 percent to award grants to, or enter into con-*
 13 *tracts or cooperative agreements with, Indian tribes and or-*
 14 *ganizations that primarily serve and represent Native Ha-*
 15 *waiians (as defined in section 7207 of the Native Hawaiian*
 16 *Education Act (20 U.S.C. 7517)), to enable such tribes and*
 17 *organizations to carry out the activities described in sub-*
 18 *section (a).”.*

19 **SEC. 304. REPEALS.**

20 *Sections 274 and 275 of the Museum and Library*
 21 *Services Act (20 U.S.C. 9174 and 9175) are repealed.*

22 **SEC. 305. AUTHORIZATION OF APPROPRIATIONS.**

23 *Section 276 of the Museum and Library Services Act*
 24 *(20 U.S.C. 9176) is amended—*

1 (1) in subsection (a), by striking “\$28,700,000
 2 for the fiscal year 1997, and such sums as may be
 3 necessary for each of the fiscal years 1998 through
 4 2002.” and inserting “\$38,600,000 for fiscal year
 5 2004 and such sums as may be necessary for fiscal
 6 years 2005 through 2009.”; and

7 (2) by redesignating such section as section 275
 8 of such Act.

9 **SEC. 306. SHORT TITLE.**

10 *Subtitle C of the Museum and Library Services Act*
 11 *(20 U.S.C. 9171 et seq.) is amended—*

12 (1) by redesignating sections 271, 272, and 273
 13 as sections 272, 273, and 274, respectively; and

14 (2) by inserting after the subtitle heading the fol-
 15 lowing:

16 **“SEC. 271. SHORT TITLE.**

17 *“This subtitle may be cited as the ‘Museum Services*
 18 *Act’.”.*

19 **TITLE IV—NATIONAL COMMIS-**
 20 **SION ON LIBRARIES AND IN-**
 21 **FORMATION SCIENCE ACT**

22 **SEC. 401. AMENDMENT TO CONTRIBUTIONS.**
