1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. LEGISLATIVE PURPOSE AND CONSTRUCTION.**

2 (a) PURPOSE.—The purpose of this Act is to improve
3 the United States Code by making necessary technical
4 changes.

5 (b) NO SUBSTANTIVE CHANGE.—This Act makes no
6 substantive change in existing law and may not be con-
7 strued as making a substantive change in existing law.

8 (c) SEVERABILITY.—If a provision enacted by this
9 Act is held invalid, all valid provisions that are severable
10 from the invalid provision remain in effect. If a provision
11 enacted by this Act is held invalid in any of its applica-
12 tions, the provision remains valid for all valid applications
13 that are severable from any of the invalid applications.

14 **SEC. 2. TECHNICAL CHANGES IN PUBLIC LAW 107-217.**

15 (a) TECHNICAL CHANGES IN SCHEDULE OF LAWS

2 1952 (ch. 576, 66 Stat. 385, 400), strike “, proviso
3 on p. 400” (in the Section column), “, 400” (in the
4 Page column), and “, 313–2” (in the U.S. Code col-
5 umn) and insert, immediately below, “578” (in the
6 Chapter or Public Law column), “101 (proviso on p.
7 400)” (in the Section column), “66” (in the Volume
8 column), “400” (in the Page column), and “313–2”
9 (in the U.S. Code column).

10 (4) In the item related to the Act of July 31,
11 1953 (ch. 299, 67 Stat. 290), strike “4th proviso”
12 and substitute “3d proviso”.

13 (5) In the item related to the Act of June 29,
14 1956 (ch. 479, 70 Stat. 447), strike “par.” and sub-
15 stitute “proviso”.

16 (6) In the item related to the Act of August 6,
17 1973 (Public Law 93–83, 87 Stat. 216), strike “2”
18 (in the Section column) and substitute “2 ‘Sec.
19 525’ ”.

20 (7) In the item related to the Act of March 12,
21 2002 (Public Law 107–149, 116 Stat. 66), shift to
22 the right one column the matter in the Section, Vol-
23 ume, and Page columns and insert, in the Section
24 column, “1–13”.

11 (7)) of title 5, United States Code, strike “section 106(2)
12 of the Appalachian Regional Development Act of 1965 (40

15 (b) TITLE 10.—Title 10, United States Code, is
16 amended as follows:

12 strike “lands’ within the meaning of that Act” and
13 substitute “land’ within the meaning of those sec-
14 tions”.

15 (7) In section 9781(g), as amended by section
16 3(b)(40)(C) of Public Law 107-217 (116 Stat.
17 1298)—

18 (A) strike “subtitle III of the Federal
19 Property and Administrative Services Act of
20 1949” and substitute “title III of the Federal
21 Property and Administrative Services Act of
22 1949”; and

23 (B) strike “. (41 U.S.C. 251 et seq.)” and
24 substitute “(41 U.S.C. 251 et seq.).”.

1 (c) TITLE 13.—In section 15 of title 13, United
2 States Code, strike “; 40 U.S.C. 278a”.

3 (d) TITLE 23.—In section 104(a)(1) of title 23,
4 United States Code, strike “section 201 of the Appa-
5 lachian Regional Development Act of 1965 (40 U.S.C.
6 App.)” and substitute “section 14501 of title 40”.

7 (e) THE INTERNAL REVENUE CODE OF 1986.—In
8 section 7608(c)(1)(A)(i)(IV) of the Internal Revenue Code
9 of 1986 (26 U.S.C. 7608(c)(1)(A)(i)(IV)), as amended by
10 section 3(f) of Public Law 107–217 (116 Stat. 1299),
11 strike “title 40” and substitute “title 40, United States
12 Code”.

13 (f) TITLE 31.—Title 31, United States Code, is
14 amended as follows:

15 (1) In section 1105(g)(2)(B)(ii), as amended by
16 section 3(h)(3) of Public Law 107–217 (116 Stat.
17 1299), insert “section” before “1102 of title 40”.

18 (2) In section 9303(d)(1), as amended by sec-
19 tion 3(h)(9)(B)(i) of Public Law 107–217 (116 Stat.
20 1300), strike the comma appearing after “sections
21 3131 and 3133 of title 40”.

22 (g) TITLE 35.—In section 2(b)(4)(A) of title 35,
23 United States Code, strike “the Federal Property and Ad-
24 ministrative Services Act of 1949 (40 U.S.C. 471 et seq.),
25 the Public Buildings Act (40 U.S.C. 601 et seq.),” and

1 substitute “subtitle I and chapter 33 of title 40, title III
2 of the Federal Property and Administrative Services Act
3 of 1949 (41 U.S.C. 251 et seq.),”.

4 (h) TITLE 36.—Section 2113 of title 36, United
5 States Code, is amended as follows:

6 (1) In subsection (a)(2), strike “(40 U.S.C.
7 1003 note)” and substitute “(40 U.S.C. 8903
8 note)”.

9 (2) In subsection (c)(1), strike “section 8(b) of
10 the Commemorative Works Act (40 U.S.C.
11 1008(b))” and substitute “section 8906(b) of title
12 40”.

13 (3) In subsection (e), strike “section 8 of the
14 Commemorative Works Act (40 U.S.C. 1008)” and
15 substitute “section 8906 of title 40”.

16 (4) In subsection (h)—

17 (A) strike “section 10 of the Commemora-
18 tive Works Act (40 U.S.C. 1010)” and sub-
19 stitute “section 8903(e) of title 40”; and

20 (B) strike “(40 U.S.C. 1003 note)” and
21 substitute “(40 U.S.C. 8903 note)”.

22 (i) TITLE 38.—Title 38, United States Code, is
23 amended as follows:

24 (1) In section 8162(a)(3), as amended by sec-
25 tion 3(j)(5)(B) of Public Law 107–217 (116 Stat.

1 1301), strike the comma appearing after “of title
2 40”.

3 (2) In section 8165(c), as amended by section
4 3(j)(6) of Public Law 107–217 (116 Stat. 1301),
5 strike the comma appearing after “of title 40”.

6 (j) TITLE 39.—Section 410(d) of title 39, United
7 States Code, is amended as follows:

8 (1) In paragraph (1), strike “section 276a of
9 title 40” and substitute “section 3142 of title 40”.

10 (2) In paragraph (2), strike “section 276c of
11 title 40” and substitute “section 3145 of title 40”.

12 (k) TITLE 49.—In section 40110(d)(2) of title 49,
13 United States Code—

14 (1) strike clause (G);

15 (2) redesignate clause (H) as clause (G); and

16 (3) in clause (G) as redesignated, strike “sub-
17 paragraphs (A) through (G)” and substitute “sub-
18 paragraphs (A) through (F)”.

1 **SEC. 5. EFFECTIVE DATE.**

2 This Act and amendments and repeals made by this
3 Act are effective August 21, 2002.
