A BILL

To authorize the design and construction of a visitor center
for the Vietnam Veterans Memorial.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. VISITOR CENTER.**

4 *Public Law 96–297 (16 U.S.C. 431 note) is amended*
5 *by adding at the end the following:*

6 **“SEC. 6. VISITOR CENTER.**

7 **“(a) AUTHORIZATION.—**

8 *“(1) IN GENERAL.—The Vietnam Veterans Me-*
9 *memorial Fund, Inc., is authorized to construct a visitor*
10 *center at or near the Vietnam Veterans Memorial on*
11 *Federal land in the District of Columbia, or its envi-*
12 *rons, subject to the provisions of this section, in order*
13 *to better inform and educate the public about the*
14 *Vietnam Veterans Memorial and the Vietnam War.*

15 *“(2) LOCATION.—The visitor center shall be lo-*
16 *cated underground.*

1 “(b) *APPLICATION OF COMMEMORATIVE WORKS*
2 *ACT.*—Chapter 89 of title 40, United States Code (com-
3 monly referred to as the Commemorative Works Act) shall
4 apply to the siting, design, construction, and maintenance
5 of the visitor center, and the visitor center shall be consid-
6 ered a commemorative work for the purposes of that Act,
7 except that—

8 “(1) final approval of the visitor center shall not
9 be withheld; and

10 “(2) the provisions of section 8908(b) of title 40,
11 United States Code requiring further approval by law
12 for the location of a commemorative work within Area
13 I shall not apply.

14 “(c) *OPERATION AND MAINTENANCE.*—The Secretary
15 of the Interior shall—

16 “(1) operate the visitor center;

17 “(2) enter into a cooperative agreement with the
18 Vietnam Veterans Memorial Fund, Inc. for the rou-
19 tine maintenance of the visitor center;

20 “(3) not later than 120 days after the date of the
21 enactment of this section, in consultation with edu-
22 cators and veterans groups, provide to the Vietnam
23 Veterans Memorial Fund, Inc. a preliminary plan to
24 guide the design phase of the visitor center exhibits;
25 and

1 “(4) as soon as practicable, in consultation with
2 educators and veterans groups, develop a written in-
3 terpretive plan for the visitor center in accordance
4 with National Park Service policy.

5 “(d) *FUNDING.*—*The Vietnam Veterans Memorial*
6 *Fund, Inc. shall be solely responsible for acceptance of con-*
7 *tributions for, and payment of expenses of, the establish-*
8 *ment of the visitor center. No Federal funds shall be used*
9 *to pay any expense of the establishment of the visitor center*
10 *or its maintenance.”.*
