A BILL

To support the efforts of the California Missions Foundation to restore and repair the Spanish colonial and missionera missions in the State of California and to preserve the artworks and artifacts of these missions, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "California Missions
5	Preservation Act".
6	SEC. 2. FINDINGS.
7	Congress finds the following:
8	(1) The California missions represent some of
9	our Nation's oldest historical treasures.
10	(2) The first of the California missions was
11	founded in 1769, and eventually a chain of 21 mis-
12	sions and various sub-missions extended along the
13	coast of California on El Camino Real.
14	(3) The California missions contribute greatly
15	to the rich historical, cultural, and architectural her-
16	itage of California and the American West.
17	(4) The knowledge and cultural influence of na-
18	tive California Indians made a lasting contribution
19	to the early settlement of California and the develop-
20	ment of the California missions.
21	(5) More than 5,300,000 people visit the Cali-
22	fornia missions annually, and the historical impor-
23	tance of the California missions extends worldwide
24	as they have become a frequent destination for for-

eign visitors to the United States.

1	(6) The history of the California missions is an
2	important educational component in California
3	schools, and the study of the California missions is
4	part of the Statewide fourth grade curricula on Cali-
5	fornia history.
6	(7) Restoration and repair of the California

8	nial and mission-era artworks and artifacts of the
9	California missions, for the public enjoyment will en-

12	term "California Missions Foundation" means the
13	charitable corporation established in the State of
14	California in 1998 to fund the restoration and repair
15	of the California missions and the preservation of
16	the Spanish colonial and mission-era artworks and
17	artifacts of the California missions. The Foundation
18	is exempt from State franchise and income tax and
19	is organized and operated exclusively for charitable
20	purposes under section $501(c)(3)$ of the Internal
21	Revenue Code of 1986.
22	(3) Secretary.—The term "Secretary" means
23	the Secretary of the Interior.
24	(b) Grants Authorized.—The Secretary of the In-
25	terior may make grants to the California Missions Foun-

- 8 religion, and seeks to protect those qualities that are his-
- 9 torically significant.
- 10 (c) APPLICATION.—In order to receive a grant under
- 11 this section for the preservation of the California missions,
- 12 the California Missions Foundation shall submit to the
- 13 Secretary an application that includes—
- 14 (1) a status report on the condition of the in-
- 15 frastructure and artifacts for each of the California
- missions; and
- 17 (2) a comprehensive program for restoration,
- 18 repair, and preservation of such infrastructure and
- artifacts, including prioritized preservation efforts to
- 20 be conducted over a 5-year period and the estimated
- 21 costs of such preservation efforts.
- 22 (d) Matching Fund Requirement.—The Sec-
- 23 retary shall require the California Missions Foundation to
- 24 match grant funds provided under this section.

- 1 (e) Report.—As a condition of a grant under this
- 2 section, the California Missions Foundation shall submit
- 3 to the Secretary an annual report on the status of the
- 4 preservation efforts undertaken using grant funds pro-
- 5 vided under this section. The Secretary shall submit a
- 6 copy of each report to Congress.
- 7 (f) AUTHORIZATION OF APPROPRIATIONS.—There is
- 8 authorized to be appropriated to the Secretary a total of
- 9 \$10,000,000 during the five-fiscal year period beginning
- 10 October 1, 2003, to make grants under this section. Funds
- 11 appropriated pursuant to the authorization of appropria-
- 12 tions in this section shall be in addition to any funds made
- 13 available for preservation efforts in the State of California
- 14 under the National Historic Preservation Act.
