To designate the historic Federal District Court Building

located at 100 North Palafox Street in Pensacola, Florida, as the “Winston E. Arnow Federal Building”.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION.**

4 The historic Federal District Court Building located
 5 at 100 North Palafox Street in Pensacola, Florida, shall
 6 be known and designated as the “Winston E. Arnow Fed-
 7 eral Building”, in honor of Winston E. Arnow who was
 8 appointed United States District Judge for the Northern
 9 District of Florida by President Lyndon B. Johnson in
 10 1968, and who served with distinction until his death in
 11 1994.

12 **SEC. 2. REFERENCES.**

13 Any reference in a law, map, regulation, document,
 14 paper, or other record of the United States to the building
 15 referred to in section 1 shall be deemed to be a reference
 16 to the “Winston E. Arnow Federal Building”.

17 **SECTION 1. DESIGNATION.**

18 *The United States courthouse located at 100 North*
 19 *Palafox Street in Pensacola, Florida, shall be known and*
 20 *designated as the “Winston E. Arnow United States Court-*
 21 *house”.*

22 **SEC. 2. REFERENCES.**

23 *Any reference in a law, map, regulation, document,*
 24 *paper, or other record of the United States to the United*

- 1 *States courthouse referred to in section 1 shall be deemed*
- 2 *to be a reference to the “Winston E. Arnow United States*
- 3 *Courthouse”.*

Amend the title so as to read: “A bill to designate the United States courthouse located at 100 North Palafox Street in Pensacola, Florida, as the ‘Winston E. Arnow United States Courthouse’.”.
