**AN ACT**

To designate the visitor center in Organ Pipe Cactus National Monument in Arizona as the “Kris Eggle Visitor Center”, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. REDESIGNATION.**

4       (a) FINDING.—Congress finds that in August 2002,  
5       Kris Eggle, a 28-year-old park ranger in Organ Pipe Cac-  
6       tus National Monument, was murdered in the line of duty  
7       along the border between the United States and Mexico.

1       (b) DEDICATION.—Congress dedicates the visitor  
2 center in Organ Pipe Cactus National Monument to Kris  
3 Eggle and to promoting awareness of the risks taken each  
4 day by all public land management law enforcement offi-  
5 cers.

6       (c) REDESIGNATION.—The visitor center in Organ  
7 Pipe Cactus National Monument in Arizona is hereby des-  
8 ignated as the “Kris Eggle Visitor Center”.

9       (d) REFERENCE.—Any reference to the visitor center  
10 in Organ Pipe Cactus National Monument in Arizona, in  
11 any law, regulation, map, document, record, or other  
12 paper of the United States shall be considered to be a ref-  
13 erence to the “Kris Eggle Visitor Center”.

14       (e) SIGNAGE.—The Secretary of the Interior shall  
15 post interpretive signs at the visitor center and at the  
16 trailhead of the Baker Mine-Milton Mine Loop that—

17               (1) describe the important role of public law en-  
18               forcement officers in protecting park visitors;

19               (2) refer to the tragic loss of Kris Eggle in un-  
20               derscoring the importance of these officers;

21               (3) refer to the dedication of the trail and the  
22               visitor center by Congress; and

23               (4) include a copy of this Act and an image of  
24               Kris Eggle.

**1 SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

2        There are authorized to be appropriated such sums  
3 as may be necessary to carry out this Act.
