A BILL

To provide for the distribution of judgment funds to the
Cowlitz Indian Tribe.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. COWLITZ INDIAN TRIBE DISTRIBUTION OF**
 2 **JUDGMENT FUNDS ACT.**

3 *This Act shall be known as the “Cowlitz Indian Tribe*
 4 *Distribution of Judgment Funds Act”.*

5 **SEC. 2. DEFINITIONS.**

6 *For the purpose of this Act—*

7 *(1) The term “current judgment fund” means the*
 8 *funds awarded by the Indian Claims Commission*
 9 *Docket No. 218 and all interest accrued thereon as of*
 10 *the date of the enactment of this Act.*

11 *(2) The term “initial interest” means the inter-*
 12 *est on the funds awarded by the Indian Claims Com-*
 13 *mission Docket No. 218 during the time period from*
 14 *one year before the date of the enactment of this Act*
 15 *through the date of the enactment of this Act.*

16 *(3) The term “principal” means the funds*
 17 *awarded by the Indian Claims Commission Docket*
 18 *No. 218 and all interest accrued thereon as of one*
 19 *year before the date of the enactment of this Act.*

20 *(4) The term “Secretary” means the Secretary of*
 21 *the Interior.*

22 *(5) The term “tribe” means the Cowlitz Indian*
 23 *Tribe of Washington, which was extended Federal ac-*
 24 *knowledgment by the United States Department of the*
 25 *Interior on December 31, 2001, pursuant to part 83*
 26 *of title 25, Code of Federal Regulations.*

1 (6) *The term “tribal member” means an indi-*
 2 *vidual who is an enrolled member of the Cowlitz In-*
 3 *dian Tribe pursuant to tribal enrollment procedures*
 4 *and requirements.*

5 (7) *The term “tribe’s governing body” means the*
 6 *Cowlitz Tribal Council, which is the tribe’s governing*
 7 *body under the tribe’s Constitution.*

8 (8) *The term “tribal elder” means any tribal*
 9 *member who was 62 years of age or older as of Feb-*
 10 *ruary 14, 2000.*

11 **SEC. 3. JUDGMENT DISTRIBUTION PLAN.**

12 *Notwithstanding the Indian Tribal Judgment Funds*
 13 *Use or Distribution Act (25 U.S.C. 1401, et seq.), or any*
 14 *plan prepared or promulgated by the Secretary pursuant*
 15 *to that Act, the judgment funds awarded in Indian Claims*
 16 *Commission Docket No. 218 and interest accrued thereon*
 17 *as of the date of the enactment of this Act shall be distrib-*
 18 *uted and used in accordance with this Act.*

19 **SEC. 4. DISTRIBUTION AND USE OF FUNDS.**

20 (a) *PRINCIPAL PRESERVED AFTER ELDERLY ASSIST-*
 21 *ANCE AND TRIBAL ADMINISTRATION PAYMENTS.—(1) Ex-*
 22 *cept as provided in subsection (b), the principal shall not*
 23 *be distributed under this Act. Only the interest earned on*
 24 *the undistributed principal may be used to fund such pro-*

1 *grams. There will be no distribution of any funds other than*
2 *as specified in this Act.*

3 *(2) The Secretary shall—*

4 *(A) maintain undistributed current judgment*
5 *funds in an interest-bearing account in trust for the*
6 *tribe; and*

7 *(B) disburse principal or interest in accordance*
8 *with this Act not later than 30 days after receipt by*
9 *the Northwest Regional Director, Bureau of Indian*
10 *Affairs, of a request by the tribe's governing body for*
11 *such disbursement of funds.*

12 *(b) ELDERLY ASSISTANCE PROGRAM.—(1) From the*
13 *current judgment fund, the Secretary shall set aside 20 per-*
14 *cent for an elderly assistance payment. The Secretary shall*
15 *provide one elderly assistance payment to each enrolled*
16 *tribal elder not later than 30 days after all of the following*
17 *have occurred:*

18 *(A) The tribe's governing body has compiled and*
19 *reviewed for accuracy a list of all enrolled tribal*
20 *members that are both a minimum of one-sixteenth*
21 *Cowlitz blood and 62 years of age or older as of Feb-*
22 *ruary 14, 2000.*

23 *(B) The Secretary has verified the blood quan-*
24 *tum and age of the tribal members identified on the*
25 *list prepared pursuant to subparagraph (A).*

1 (C) *The tribe's governing body has made a re-*
2 *quest for disbursement of judgment funds for the el-*
3 *derly assistance payment.*

4 (2) *If a tribal elder eligible for an elderly assistance*
5 *payment dies before receiving payment under this sub-*
6 *section, the money which would have been paid to that indi-*
7 *vidual shall be added to and distributed in accordance with*
8 *the emergency assistance program under subsection (c).*

9 (3) *The Secretary shall pay all costs of distribution*
10 *under this subsection out of the amount set aside under*
11 *paragraph (1).*

12 (c) *EMERGENCY ASSISTANCE PROGRAM.—From the*
13 *principal, the Secretary shall set aside 10 percent for the*
14 *Emergency Assistance Program. Beginning the second year*
15 *after the date of the enactment of this Act, interest earned*
16 *on such sum shall be distributed annually in a lump sum*
17 *to the tribe's governing body and will be used to provide*
18 *emergency assistance for tribal members. 10 percent of the*
19 *initial interest shall be available upon the date of the enact-*
20 *ment of this Act to fund the program for the first year after*
21 *the date of the enactment of this Act.*

22 (d) *EDUCATION, VOCATIONAL, AND CULTURAL TRAIN-*
23 *ING PROGRAM.—From the principal, the Secretary shall set*
24 *aside 10 percent for an Education, Vocational and Cultural*
25 *Training Program. Beginning the second year after the*

1 *date of the enactment of this Act, interest earned on such*
2 *sum shall be distributed annually in a lump sum to the*
3 *tribe's governing body and will be used to provide scholar-*
4 *ships to tribal members pursuing educational advancement,*
5 *including cultural and vocational training. 10 percent of*
6 *the initial interest shall be available upon the date of the*
7 *enactment of this Act to fund the program for the first year*
8 *after the date of the enactment of this Act.*

9 (e) *HOUSING ASSISTANCE PROGRAM.—From the prin-*
10 *icipal, the Secretary shall set aside 5 percent for the Housing*
11 *Assistance Program. Beginning the second year after the*
12 *date of the enactment of this Act, interest earned on such*
13 *sum shall be disbursed annually in a lump sum to the*
14 *tribe's governing body and may be added to any existing*
15 *tribal housing improvements programs to supplement them*
16 *or it may be used in a separate Housing Assistance Pro-*
17 *gram to be established by the tribe's governing body. 5 per-*
18 *cent of the initial interest shall be available upon the date*
19 *of the enactment of this Act to fund the program for the*
20 *first year after the date of the enactment of this Act.*

21 (f) *ECONOMIC DEVELOPMENT, TRIBAL, AND CULTURAL*
22 *CENTERS.—From the principal, the Secretary shall set*
23 *aside 21.5 percent for economic development and, if other*
24 *funding is not available or not adequate (as determined by*
25 *the tribe), for the construction and maintenance of tribal*

1 *and cultural centers. Beginning the second year after the*
2 *date of the enactment of this Act, interest earned on such*
3 *sum shall be disbursed annually in a lump sum to the*
4 *tribe's governing body and shall be used for the following,*
5 *with 21.5 percent of the initial interest available upon the*
6 *date of the enactment of this Act to fund the program for*
7 *the first year after the date of the enactment of this Act:*

8 (1) *Property acquisition for business or other ac-*
9 *tivities which are likely to benefit the tribe economi-*
10 *cally or provide employment for tribal members.*

11 (2) *Business development for the tribe, including*
12 *collateralization of loans for the purchase or operation*
13 *of businesses, matching funds for economic develop-*
14 *ment grants, joint venture partnerships, and other*
15 *similar ventures, which are likely to produce profits*
16 *for the tribe. All business loans shall pay principal*
17 *and interest back to the Economic Development pro-*
18 *gram for reinvestments and business profits shall go*
19 *to the tribe's general fund for uses to be determined*
20 *by the tribe's governing body.*

21 (3) *Design, construction, maintenance, and oper-*
22 *ation of tribal and cultural centers.*

23 (g) *NATURAL RESOURCES.—From the principal, the*
24 *Secretary shall set aside 7.5 percent for natural resources.*
25 *Beginning the second year after the date of the enactment*

1 *of this Act, interest earned on such sum shall be disbursed*
2 *annually in a lump sum to the tribe's governing body and*
3 *may be added to any existing tribal natural resource pro-*
4 *gram to enhance the tribe's use and enjoyment of existing*
5 *and renewable natural resources within the tribe's lands.*
6 *7.5 percent of the initial interest shall be available upon*
7 *the date of the enactment of this Act to fund the program*
8 *for the first year after the date of the enactment of this Act.*

9 (h) *CULTURAL RESOURCES.—From the principal, the*
10 *Secretary shall set aside 4 percent for cultural resources.*
11 *Beginning the second year after the date of the enactment*
12 *of this Act, interest earned on such sum shall be distributed*
13 *annually in a lump sum to the tribe's governing body and*
14 *shall be used to maintain artifacts, collect documents, ar-*
15 *chive, and identify cultural sites of tribal significance. 4*
16 *percent of the initial interest shall be available upon the*
17 *date of the enactment of this Act to fund the program for*
18 *the first year after the date of the enactment of this Act.*

19 (i) *HEALTH.—From the principal, the Secretary shall*
20 *set aside 21 percent for health. Beginning the second year*
21 *after the date of the enactment of this Act, interest earned*
22 *on such sum shall be disbursed annually in a lump sum*
23 *to the tribe's governing body and shall be used for the health*
24 *needs of the tribe. 21 percent of the initial interest shall*
25 *be available upon the date of the enactment of this Act to*

1 *fund the program for the first year after the date of the*
2 *enactment of this Act.*

3 (j) *TRIBAL ADMINISTRATION PROGRAM.—From the*
4 *principal, the Secretary shall set aside 21 percent for tribal*
5 *administration. 21 percent of the initial interest and such*
6 *of the principal sum set aside for this program as required*
7 *to fund the first year of this program at \$150,000, the sum*
8 *of \$150,000 shall be immediately disbursed to the tribe for*
9 *the purposes of funding tribal administration for the first*
10 *year after the date of the enactment of this Act. Beginning*
11 *the second year after the date of the enactment of this Act,*
12 *interest earned on the remaining principal set aside under*
13 *this subsection shall be disbursed annually in a lump sum*
14 *to the tribe’s governing body for operating costs of the tribe’s*
15 *governing body, including travel, telephone, cultural, and*
16 *other expenses incurred in the conduct of the tribe’s affairs,*
17 *and legal fees as approved by the tribe’s governing body.*

18 (k) *GENERAL CONDITIONS.—The following conditions*
19 *will apply to the management and use of all funds available*
20 *under this Act by the tribe’s governing body:*

21 (1) *No amount greater than 10 percent of the in-*
22 *terest earned on the principal designated for any pro-*
23 *gram under this Act may be used for the administra-*
24 *tive costs of any of that program, except those pro-*
25 *grams operated pursuant to subsections (i) and (j).*

1 (2) *No service area is implied or imposed under*
2 *any program under this Act. If the costs of admin-*
3 *istering any program under this Act for the benefit*
4 *of tribal members living outside the tribe's Indian*
5 *Health Service area are greater than 10 percent of the*
6 *interest earned on the principal designated for that*
7 *program, the tribe's governing body may authorize*
8 *the expenditure of such funds for that program.*

9 (3) *Before any expenditures, the tribe's governing*
10 *body must approve all programs and shall publish in*
11 *a publication of general circulation regulations which*
12 *provide standards and priorities for programs estab-*
13 *lished in this Act.*

14 (4) *Section 7 of the Indian Tribal Judgment*
15 *Funds Use or Distribution Act (25 U.S.C. 1407) shall*
16 *apply to funds available under this Act.*

17 (5) *Any tribal member who feels he or she has*
18 *been unfairly denied the right to take part in any*
19 *program under this Act may appeal to the tribal sec-*
20 *retary. The tribal secretary shall bring the appeal to*
21 *the tribe's governing body for resolution. The resolu-*
22 *tion shall be made in a timely manner and the tribal*
23 *secretary at that time shall respond to the tribal*
24 *member.*
