A BILL

To expand the Timucuan Ecological and Historic Preserve,
Florida.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Timucuan Ecological*
5 *and Historic Preserve Boundary Revision Act of 2004”.*

1 **SEC. 2. REVISION OF BOUNDARY OF TIMUCUAN ECOLOGI-**
2 **CAL AND HISTORIC PRESERVE, FLORIDA.**

3 *Section 201(a) of Public Law 100–249 (16 U.S.C.*
4 *698n) is amended—*

5 *(1) by striking “(a) ESTABLISHMENT.—There is*
6 *hereby” and inserting the following:*

7 *“(a) ESTABLISHMENT.—*

8 *“(1) IN GENERAL.—There is”; and*

9 *(2) by adding at the end the following:*

10 *“(2) MODIFICATION OF BOUNDARY.—*

11 *“(A) IN GENERAL.—In addition to the land*
12 *described in paragraph (1), the Preserve shall in-*
13 *clude approximately 8.5 acres of land located in*
14 *Nassau County, Florida, as generally depicted*
15 *on the map entitled ‘Timucuan Ecological and*
16 *Historic Preserve American Beach Adjustment’,*
17 *numbered 006/80012 and dated June 2003.*

18 *“(B) DUTIES OF SECRETARY.—The Sec-*
19 *retary of the Interior shall—*

20 *“(i) revise the boundaries of the Pre-*
21 *serve so as to encompass the land described*
22 *in subparagraph (A); and*

23 *“(ii) maintain the map described in*
24 *subparagraph (A) on file and available for*
25 *public inspection in the appropriate offices*
26 *of the National Park Service.”.*
