A BILL

To reauthorize the Temporary Assistance for Needy Families block grant program through September 30, 2004, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “TANF and Related
5 Programs Continuation Act of 2004”.

6 **SEC. 2. EXTENSION OF THE TEMPORARY ASSISTANCE FOR**
7 **NEEDY FAMILIES BLOCK GRANT PROGRAM**
8 **THROUGH SEPTEMBER 30, 2004.**

9 (a) IN GENERAL.—Activities authorized by part A of
10 title IV of the Social Security Act, and by sections 510,

1 1108(b), and 1925 of such Act, shall continue through
 2 September 30, 2004, in the manner authorized for fiscal
 3 year 2002, notwithstanding section 1902(e)(1)(A) of such
 4 Act, and out of any money in the Treasury of the United
 5 States not otherwise appropriated, there are hereby appro-
 6 priated such sums as may be necessary for such purpose.
 7 Grants and payments may be made pursuant to this au-
 8 thority through the fourth quarter of fiscal year 2004 at
 9 the level provided for such activities through the fourth
 10 quarter of fiscal year 2002.

11 (b) CONFORMING AMENDMENT.—Section
 12 403(a)(3)(H)(ii) of the Social Security Act (42 U.S.C.
 13 603(a)(3)(H)(ii)) is amended by striking “June 30” and
 14 inserting “September 30”.

15 **SEC. 3. EXTENSION OF THE NATIONAL RANDOM SAMPLE**
 16 **STUDY OF CHILD WELFARE AND CHILD WEL-**
 17 **FARE WAIVER AUTHORITY THROUGH SEP-**
 18 **TEMBER 30, 2004.**

19 Activities authorized by sections 429A and 1130(a)
 20 of the Social Security Act shall continue through Sep-
 21 tember 30, 2004, in the manner authorized for fiscal year
 22 2002, and out of any money in the Treasury of the United
 23 States not otherwise appropriated, there are hereby appro-
 24 priated such sums as may be necessary for such purpose.
