AN ACT

To amend title 18, United States Code, to prohibit video voyeurism in the special maritime and territorial jurisdiction of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Video Voyeurism Preven-*
5 *tion Act of 2004”.*

1 **SEC. 2. PROHIBITION OF VIDEO VOYEURISM.**

2 (a) *IN GENERAL.*—Title 18, United States Code, is
 3 amended by inserting after chapter 87 the following new
 4 chapter:

5 **“CHAPTER 88—PRIVACY**

“Sec.
 “1801. *Video voyeurism.*

6 **“§ 1801. Video voyeurism**

7 “(a) *Whoever, in the special maritime and territorial*
 8 *jurisdiction of the United States, has the intent to capture*
 9 *an image of a private area of an individual without their*
 10 *consent, and knowingly does so under circumstances in*
 11 *which the individual has a reasonable expectation of pri-*
 12 *vacy, shall be fined under this title or imprisoned not more*
 13 *than one year, or both.*

14 “(b) *In this section—*

15 “(1) *the term ‘capture’, with respect to an image,*
 16 *means to videotape, photograph, film, record by any*
 17 *means, or broadcast;*

18 “(2) *the term ‘broadcast’ means to electronically*
 19 *transmit a visual image with the intent that it be*
 20 *viewed by a person or persons;*

21 “(3) *the term ‘a private area of the individual’*
 22 *means the naked or undergarment clad genitals, pubic*
 23 *area, buttocks, or female breast of that individual;*

1 “(4) the term ‘female breast’ means any portion
2 of the female breast below the top of the areola; and

3 “(5) the term ‘under circumstances in which that
4 individual has a reasonable expectation of privacy’
5 means—

6 “(A) circumstances in which a reasonable
7 person would believe that he or she could disrobe
8 in privacy, without being concerned that an
9 image of a private area of the individual was
10 being captured; or

11 “(B) circumstances in which a reasonable
12 person would believe that a private area of the
13 individual would not be visible to the public, re-
14 gardless of whether that person is in a public or
15 private place.

16 “(c) This section does not prohibit any lawful law en-
17 forcement, correctional, or intelligence activity.”.

18 (b) *AMENDMENT TO PART ANALYSIS.*—The table of
19 chapters at the beginning of part I of title 18, United States
20 Code, is amended by inserting after the item relating to
21 chapter 87 the following new item:

 “88. *Privacy* 1801”.
