1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **SECTION 1. FEDERAL COURT PROCEEDINGS IN PLANO,**
4 **TEXAS.**

5 Section ~~124(c)(3)~~ of title 28, United States Code, is
6 amended by inserting “and Plano” after “held at Sher-
7 man”.

1 **SECTION 1. CHANGE IN COMPOSITION OF DIVISIONS OF**
 2 **EASTERN DISTRICT OF TEXAS.**

3 (a) *IN GENERAL.*—Section 124(c) of title 28, United
 4 States Code, is amended—

5 (1) *in paragraph (3)—*

6 (A) *by striking “Denton, and Grayson” and*
 7 *inserting “Delta, Denton, Fannin, Grayson,*
 8 *Hopkins, and Lamar”;* and

9 (B) *by inserting “and Plano” after “held at*
 10 *Sherman”;*

11 (2) *by striking paragraph (4) and redesignating*
 12 *paragraphs (5) through (7) as paragraphs (4)*
 13 *through (6), respectively; and*

14 (3) *in paragraph (5), as so redesignated, by in-*
 15 *serting “Red River,” after “Franklin,”.*

16 (b) *EFFECTIVE DATE.*—

17 (1) *IN GENERAL.*—*This section and the amend-*
 18 *ments made by this section shall take effect on the*
 19 *date of the enactment of this Act.*

20 (2) *PENDING CASES NOT AFFECTED.*—*This sec-*
 21 *tion and the amendments made by this section shall*
 22 *not affect any action commenced before the effective*
 23 *date of this section and pending in the United States*
 24 *District Court for the Eastern District of Texas on*
 25 *such date.*

1 (3) *JURIES NOT AFFECTED.*—*This section and*
2 *the amendments made by this section shall not affect*
3 *the composition, or preclude the service, of any grand*
4 *or petit jury summoned, impaneled, or actually serv-*
5 *ing in the Eastern Judicial District of Texas on the*
6 *effective date of this section.*
