A BILL

To provide financial assistance for the rehabilitation of the Benjamin Franklin National Memorial in Philadelphia, Pennsylvania, and the development of an exhibit to commemorate the 300th anniversary of the birth of Benjamin Franklin.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. BENJAMIN FRANKLIN NATIONAL MEMORIAL.**

2 (a) FINDINGS.—Congress finds that—

3 (1) in Public Law 92–551 (86 Stat. 1164),
4 Congress—

5 (A) designated the Benjamin Franklin Me-
6 morial Hall as the Benjamin Franklin National
7 Memorial; and

8 (B) directed the Secretary of the Interior
9 to enter into a cooperative agreement with the
10 Franklin Institute; and

11 (2) in a memorandum of understanding entered
12 into on November 6, 1973, the Secretary of the In-
13 terior agreed to cooperate in the preservation and
14 presentation of the Benjamin Franklin Memorial
15 Hall as a national memorial.

16 (b) IN GENERAL.—The Secretary of the Interior
17 shall provide a grant to the Franklin Institute to—

18 (1) rehabilitate the Benjamin Franklin National
19 Memorial (including the Franklin statue) in Phila-
20 delphia, Pennsylvania; and

21 (2) develop an exhibit featuring artifacts and
22 multimedia collections relating to Benjamin Frank-
23 lin, to be displayed at a museum adjacent to the
24 Benjamin Franklin National Memorial.

1 ~~(e) AUTHORIZATION OF APPROPRIATIONS.—There is~~
2 authorized to be appropriated to carry out this Act for
3 ~~fiscal years 2004 through 2008 \$10,000,000.~~

4 **SECTION 1. BENJAMIN FRANKLIN NATIONAL MEMORIAL.**

5 *The Secretary of the Interior may provide a grant to*
6 *the Franklin Institute to—*

7 *(1) rehabilitate the Benjamin Franklin National*
8 *Memorial (including the Franklin statue) in Phila-*
9 *delphia, Pennsylvania; and*

10 *(2) develop an interpretive exhibit relating to*
11 *Benjamin Franklin, to be displayed at a museum ad-*
12 *jacent to the Benjamin Franklin National Memorial.*

13 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

14 *(a) IN GENERAL.—There is authorized to be appro-*
15 *priated to carry out this Act \$10,000,000.*

16 *(b) REQUIRED MATCH.—The Secretary of the Interior*
17 *shall require the Franklin Institute to match any amounts*
18 *provided to the Franklin Institute under this Act.*
