## A BILL

To establish certain requirements relating to the provision of services to minors by family planning projects under title X of the Public Health Service Act.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Parent’s Right to  
5 Know Act of 2005”.

6 **SEC. 2. PROVISIONS REGARDING TITLE X FAMILY PLAN-**  
7 **NING PROJECTS.**

8        (a) PROVISION OF CONTRACEPTIVE DRUGS OR PRE-  
9 SCRIPTION DEVICES TO MINORS.—None of the funds ap-  
10 propriated in any Federal Act for any fiscal year for car-  
11 rying out title X of the Public Health Service Act (42  
12 U.S.C. 300 et seq.) may be made available to any family  
13 planning project under section 1001 of such title if any  
14 provider of services in the project knowingly provides con-  
15 traceptive drugs or prescription devices to a minor, un-  
16 less—

17            (1) such provider of services has given actual  
18 written notice to a custodial parent or custodial legal  
19 guardian of the minor, notifying the parent or legal  
20 guardian of the intent to provide the drugs or pre-  
21 scription devices, at least five business days before  
22 providing the drugs or prescription devices;

23            (2) the minor has the written consent of a cus-  
24 todial parent or custodial legal guardian to receive  
25 the drugs or prescription devices;

1           (3) the minor is emancipated under applicable  
2 State law; or

3           (4) a court of competent jurisdiction has di-  
4 rected that the minor may receive the drugs or pre-  
5 scription devices.

6           (b) CERTIFICATION OF COMPLIANCE.—Each provider  
7 of services under section 1001 of title X of the Public  
8 Health Service Act shall each year certify to the Secretary  
9 of Health and Human Services compliance with this sec-  
10 tion. Such Secretary shall prescribe such regulations as  
11 may be necessary to effectuate this section.
