AN ACT

To assist individuals with disabilities affected by Hurricane Katrina or Rita through vocational rehabilitation services.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Assistance for Individ-
3 uals with Disabilities Affected by Hurricane Katrina or
4 Rita Act of 2005”.

5 **SEC. 2. ASSISTANCE FOR INDIVIDUALS WITH DISABILITIES.**

6 (a) DEFINITIONS.—In this section:

7 (1) AFFECTED STATE.—The term “affected
8 State” means a State that contains an area, or that
9 received a significant number of individuals who re-
10 sided in an area, in which the President has declared
11 that a major disaster exists.

12 (2) COMMISSIONER.—The term “Commis-
13 sioner” means the Commissioner of the Rehabilita-
14 tion Services Administration.

15 (3) INDIVIDUAL WITH A DISABILITY.—The term
16 “individual with a disability” has the meaning given
17 the term in section 7(20)(A) of the Rehabilitation
18 Act of 1973 (29 U.S.C. 705(20)(A)).

19 (4) INDIVIDUAL WITH A DISABILITY AFFECTED
20 BY HURRICANE KATRINA.—The term “individual
21 with a disability affected by Hurricane Katrina”
22 means an individual with a disability who resided on
23 August 22, 2005, in an area in which the President
24 has declared that a major disaster related to Hurri-
25 cane Katrina exists.

1 (5) INDIVIDUAL WITH A DISABILITY AFFECTED
2 BY HURRICANE RITA.—The term “individual with a
3 disability affected by Hurricane Rita” means an in-
4 dividual with a disability who resided in an area on
5 the date that was 7 days before the date on which
6 the President declared that a major disaster related
7 to Hurricane Rita exists in such area.

8 (6) MAJOR DISASTER.—The term “major dis-
9 aster” means a major disaster declared by the Presi-
10 dent in accordance with the Robert T. Stafford Dis-
11 aster Relief and Emergency Assistance Act (42
12 U.S.C. 5121 et seq.), related to Hurricane Katrina
13 or Rita.

14 (b) REALLOTMENTS OF AMOUNTS.—

15 (1) IN GENERAL.—In realloting amounts to
16 States under section 110(b)(2) of the Rehabilitation
17 Act of 1973 (29 U.S.C. 730(b)(2)) for fiscal year
18 2005, the Commissioner shall give preference to af-
19 fected States.

20 (2) WAIVERS.—If the Commissioner reallots
21 amounts under section 110(b)(2) of the Rehabilita-
22 tion Act of 1973 to an affected State for fiscal year
23 2005, or returns to the State of Louisiana for fiscal
24 year 2005 the funds that Louisiana had previously
25 relinquished pursuant to section 110(b)(1) of that

1 Act (29 U.S.C. 730(b)(1)) due to an inability to
2 meet the non-Federal share requirements requiring
3 Louisiana to contribute \$3,942,821 for fiscal year
4 2005, the Commissioner may grant a waiver of non-
5 Federal share requirements for fiscal year 2005 for
6 the affected State or Louisiana, respectively.

7 (3) DEFINITION.—In this subsection, the term
8 “non-Federal share requirements” means non-Fed-
9 eral share requirements applicable to programs
10 under title I of such Act (29 U.S.C. 720 et seq.).

11 (c) USE OF AMOUNTS REALLOTTED UNDER TITLE
12 I OF THE REHABILITATION ACT OF 1973.—An affected
13 State that receives amounts reallocated under section
14 110(b)(2) of the Rehabilitation Act of 1973 (29 U.S.C.
15 730(b)(2)) for fiscal year 2005 (as described in subsection
16 (b)) or returned under subsection (b) may use the
17 amounts—

18 (1) to pay for vocational rehabilitation services
19 described in section 103 of the Rehabilitation Act of
20 1973 (29 U.S.C. 723) (which may include training,
21 mentoring, or job shadowing opportunities), for indi-
22 viduals with disabilities affected by Hurricane
23 Katrina or individuals with disabilities affected by
24 Hurricane Rita, that contribute to the economic
25 growth and development of communities;

1 (2) to enable—

2 (A) individuals with disabilities affected by
3 Hurricane Katrina to participate in reconstruc-
4 tion or other major disaster assistance activities
5 in the areas in which the individuals resided on
6 August 22, 2005; and

7 (B) individuals with disabilities affected by
8 Hurricane Rita to participate in reconstruction
9 or other major disaster assistance activities in
10 the areas in which the individuals resided on
11 the date that was 7 days before the date on
12 which the President declared that a major dis-
13 aster related to Hurricane Rita exists in such
14 areas;

15 (3) to pay for vocational rehabilitation services
16 described in section 103 of the Rehabilitation Act of
17 1973 for individuals with disabilities affected by
18 Hurricane Katrina, or individuals with disabilities
19 affected by Hurricane Rita, who do not meet the af-
20 fected State's order of selection criteria for the af-
21 fected State's order of selection under section
22 101(a)(5) of the Rehabilitation Act of 1973 (29
23 U.S.C. 721(a)(5)); or

1 (4) to carry out other activities in accordance
2 with title I of the Rehabilitation Act of 1973 (29
3 U.S.C. 720 et seq.).
