AN ACT

11 OPERATION AND MAINTENANCE, ARMY

12 For expenses, not otherwise provided for, necessary
13 for the operation and maintenance of the Army, as author-
14 ized by law; and not to exceed \$11,478,000 can be used
15 for emergencies and extraordinary expenses, to be ex-
16 pended on the approval or authority of the Secretary of
17 the Army, and payments may be made on his certificate
18 of necessity for confidential military purposes,
19 \$22,292,965,000: *Provided*, That of funds made available
20 under this heading, \$2,499,000 shall be available for Fort
21 Baker, in accordance with the terms and conditions as
22 provided under the heading "Operation and Maintenance,
23 Army", in Public Law 107-117.

1 OPERATION AND MAINTENANCE, NAVY

2 For expenses, not otherwise provided for, necessary
3 for the operation and maintenance of the Navy and the
4 Marine Corps, as authorized by law; and not to exceed
5 \$6,129,000 can be used for emergencies and extraordinary
6 expenses, to be expended on the approval or authority of
7 the Secretary of the Navy, and payments may be made
8 on his certificate of necessity for confidential military pur-
9 poses, \$29,853,676,000.

10 OPERATION AND MAINTENANCE, MARINE CORPS

11 For expenses, not otherwise provided for, necessary
12 for the operation and maintenance of the Marine Corps,
13 as authorized by law, \$3,351,121,000.

14 OPERATION AND MAINTENANCE, AIR FORCE

15 For expenses, not otherwise provided for, necessary
16 for the operation and maintenance of the Air Force, as
17 authorized by law; and not to exceed \$7,699,000 can be
18 used for emergencies and extraordinary expenses, to be ex-
19 pended on the approval or authority of the Secretary of
20 the Air Force, and payments may be made on his certifi-
21 cate of necessity for confidential military purposes,
22 \$29,089,688,000.

1 OPERATION AND MAINTENANCE, DEFENSE-WIDE

2 (INCLUDING TRANSFER OF FUNDS)

3 For expenses, not otherwise provided for, necessary
4 for the operation and maintenance of activities and agen-
5 cies of the Department of Defense (other than the military
6 departments), as authorized by law, \$19,883,790,000:
7 *Provided*, That not more than \$25,000,000 may be used
8 for the Combatant Commander Initiative Fund authorized
9 under section 166a of title 10, United States Code: *Pro-*
10 *vided further*, That not to exceed \$40,000,000 can be used
11 for emergencies and extraordinary expenses, to be ex-
12 pended on the approval or authority of the Secretary of
13 Defense, and payments may be made on his certificate of
14 necessity for confidential military purposes: *Provided fur-*
15 *ther*, That of the funds made available under this heading,
16 \$6,300,000 is available for contractor support to coordi-
17 nate a wind test demonstration project on an Air Force
18 installation using wind turbines manufactured in the
19 United States that are new to the United States market
20 and to execute the renewable energy purchasing plan: *Pro-*
21 *vided further*, That none of the funds appropriated or oth-
22 erwise made available by this Act may be used to plan
23 or implement the consolidation of a budget or appropria-
24 tions liaison office of the Office of the Secretary of De-
25 fense, the office of the Secretary of a military department,

1 or the service headquarters of one of the Armed Forces
2 into a legislative affairs or legislative liaison office: *Pro-*
3 *vided further*, That \$4,000,000, to remain available until
4 expended, is available only for expenses relating to certain
5 classified activities, and may be transferred as necessary
6 by the Secretary to operation and maintenance appropria-
7 tions or research, development, test and evaluation appro-
8 priations, to be merged with and to be available for the
9 same time period as the appropriations to which trans-
10 ferred: *Provided further*, That any ceiling on the invest-
11 ment item unit cost of items that may be purchased with
12 operation and maintenance funds shall not apply to the
13 funds described in the preceding proviso: *Provided further*,
14 That the transfer authority provided under this heading
15 is in addition to any other transfer authority provided else-
16 where in this Act.

2 For expenses, not otherwise provided for, necessary
3 for the operation and maintenance, including training, or-
4 ganization, and administration, of the Navy Reserve; re-
5 pair of facilities and equipment; hire of passenger motor
6 vehicles; travel and transportation; care of the dead; re-
7 cruiting; procurement of services, supplies, and equip-
8 ment; and communications, \$1,223,628,000.

9 OPERATION AND MAINTENANCE, MARINE CORPS

10 RESERVE

11 For expenses, not otherwise provided for, necessary
12 for the operation and maintenance, including training, or-
13 ganization, and administration, of the Marine Corps Re-
14 serve; repair of facilities and equipment; hire of passenger
15 motor vehicles; travel and transportation; care of the dead;
16 recruiting; procurement of services, supplies, and equip-
17 ment; and communications, \$202,732,000.

18 OPERATION AND MAINTENANCE, AIR FORCE RESERVE

19 For expenses, not otherwise provided for, necessary
20 for the operation and maintenance, including training, or-
21 ganization, and administration, of the Air Force Reserve;
22 repair of facilities and equipment; hire of passenger motor
23 vehicles; travel and transportation; care of the dead; re-
24 cruiting; procurement of services, supplies, and equip-
25 ment; and communications, \$2,659,951,000.

1 modification, maintenance, and issue of supplies and
2 equipment, including those furnished from stocks under
3 the control of agencies of the Department of Defense;
4 travel expenses (other than mileage) on the same basis as
5 authorized by law for Air National Guard personnel on
6 active Federal duty, for Air National Guard commanders

12 For salaries and expenses necessary for the United

16 OVERSEAS HUMANITARIAN, DISASTER, AND CIVIC AID

17 For expenses relating to the Overseas Humanitarian,
18 Disaster, and Civic Aid programs of the Department of
19 Defense (consisting of the programs provided under sec-
20 tions 401, 402, 404, 2557, and 2561 of title 10, United
21 States Code), \$63,204,000, to remain available until Sep-
22 tember 30, 2008.

23 FORMER SOVIET UNION THREAT REDUCTION ACCOUNT

24 For assistance to the republics of the former Soviet
25 Union, including assistance provided by contract or by

1 grants, for facilitating the elimination and the safe and
2 secure transportation and storage of nuclear, chemical and
3 other weapons; for establishing programs to prevent the
4 proliferation of weapons, weapons components, and weap-
5 on-related technology and expertise; for programs relating
6 to the training and support of defense and military per-
7 sonnel for demilitarization and protection of weapons,
8 weapons components and weapons technology and exper-
9 tise; and for defense and military contracts, \$372,128,000,
10 to remain available until September 30, 2009.

24 reserve plant and Government and contractor-owned
25 equipment layaway; and other expenses necessary for the

1 foregoing purposes, ~~\$3,529,983,000~~, to remain available
2 for obligation until September 30, 2009, of which
3 ~~\$27,375,000~~ shall be available for the Army National
4 Guard and Army Reserve: *Provided*, That \$19,200,000 of
5 the funds provided in this paragraph are available only

7 evacuation Variant Blackhawk helicopter only for the

15 the land necessary therefor, for the foregoing purposes,
16 and such lands and interests therein, may be acquired,
17 and construction prosecuted thereon prior to approval of
18 title; and procurement and installation of equipment, ap-
19 pliances, and machine tools in public and private plants;
20 reserve plant and Government and contractor-owned
21 equipment layaway; and other expenses necessary for the

9 lands and interests therein, may be acquired, and con-
10 struction prosecuted thereon prior to approval of title; and
11 procurement and installation of equipment, appliances,
12 and machine tools in public and private plants; reserve
13 plant and Government and contractor-owned equipment
14 layaway; and other expenses necessary for the foregoing
15 purposes, \$2,047,804,000, to remain available for obliga-
16 tion until September 30, 2009, of which \$218,481,000
17 shall be available for the Army National Guard and Army
18 Reserve.

20 For construction, procurement, production, and
21 modification of ammunition, and accessories therefor; spe-
22 cialized equipment and training devices; expansion of pub-
23 lic and private plants, including ammunition facilities, au-
24 thorized by section 2854 of title 10, United States Code,
25 and the land necessary therefor, for the foregoing pur-

1 poses, and such lands and interests therein, may be ac-
2 quired, and construction prosecuted thereon prior to ap-
3 proval of title; and procurement and installation of equip-
4 ment, appliances, and machine tools in public and private
5 plants; reserve plant and Government and contractor-
6 owned equipment layaway; and other expenses necessary
7 for the foregoing purposes, \$1,710,475,000, to remain
8 available for obligation until September 30, 2009, of which
9 \$197,181,000 shall be available for the Army National
10 Guard and Army Reserve.

11 OTHER PROCUREMENT, ARMY

12 For construction, procurement, production, and
13 modification of vehicles, including tactical, support, and
14 non-tracked combat vehicles; the purchase of passenger
15 motor vehicles for replacement only; communications and
16 electronic equipment; other support equipment; spare
17 parts, ordnance, and accessories therefor; specialized
18 equipment and training devices; expansion of public and
19 private plants, including the land necessary therefor, for
20 the foregoing purposes, and such lands and interests
21 therein, may be acquired, and construction prosecuted
22 thereon prior to approval of title; and procurement and
23 installation of equipment, appliances, and machine tools
24 in public and private plants; reserve plant and Govern-
25 ment and contractor-owned equipment layaway; and other

1 expenses necessary for the foregoing purposes,
2 \$7,005,338,000, to remain available for obligation until
3 September 30, 2009, of which \$534,360,000 shall be
4 available for the Army National Guard and Army Reserve.

6 For construction, procurement, production, modifica-
7 tion, and modernization of aircraft, equipment, including
8 ordnance, spare parts, and accessories therefor; specialized
9 equipment; expansion of public and private plants, includ-
10 ing the land necessary therefor, and such lands and inter-
11 ests therein, may be acquired, and construction prosecuted
12 thereon prior to approval of title; and procurement and
13 installation of equipment, appliances, and machine tools
14 in public and private plants; reserve plant and Govern-
15 ment and contractor-owned equipment layaway,
16 \$10,590,934,000, to remain available for obligation until
17 September 30, 2009, of which \$154,800,000 shall be
18 available for the Navy Reserve and Marine Corps Reserve.

20 For construction, procurement, production, modifica-
21 tion, and modernization of missiles, torpedoes, other weap-
22 ons, and related support equipment including spare parts,
23 and accessories therefor; expansion of public and private
24 plants, including the land necessary therefor, and such
25 lands and interests therein, may be acquired, and con-

1 SHIPBUILDING AND CONVERSION, NAVY

2 For expenses necessary for the construction, acquisi-
3 tion, or conversion of vessels as authorized by law, includ-
4 ing armor and armament thereof, plant equipment, appli-
5 ances, and machine tools and installation thereof in public
6 and private plants; reserve plant and Government and con-
7 tractor-owned equipment layaway; procurement of critical,
8 long leadtime components and designs for vessels to be
9 constructed or converted in the future; and expansion of
10 public and private plants, including land necessary there-
11 for, and such lands and interests therein, may be acquired,
12 and construction prosecuted thereon prior to approval of

3 authority of this provision or any other transfer authority
4 contained in this Act.

5 SEC. 8015. None of the funds in this Act may be
6 available for the purchase by the Department of Defense
7 (and its departments and agencies) of welded shipboard
8 anchor and mooring chain 4 inches in diameter and under
9 unless the anchor and mooring chain are manufactured
10 in the United States from components which are substan-
11 tially manufactured in the United States: *Provided*, That
12 for the purpose of this section manufactured will include
13 cutting, heat treating, quality control, testing of chain and
14 welding (including the forging and shot blasting process):
15 *Provided further*, That for the purpose of this section sub-
16 stantially all of the components of anchor and mooring
17 chain shall be considered to be produced or manufactured
18 in the United States if the aggregate cost of the compo-
19 nents produced or manufactured in the United States ex-
20 ceeds the aggregate cost of the components produced or
21 manufactured outside the United States: *Provided further*,
22 That when adequate domestic supplies are not available
23 to meet Department of Defense requirements on a timely
24 basis, the Secretary of the service responsible for the pro-
25 curement may waive this restriction on a case-by-case

1 basis by certifying in writing to the Committees on Appro-
2 priations that such an acquisition must be made in order
3 to acquire capability for national security purposes.

4 SEC. 8016. None of the funds available to the De-
5 partment of Defense may be used to demilitarize or dis-
6 pose of M-1 Carbines, M-1 Garand rifles, M-14 rifles,
7 .22 caliber rifles, .30 caliber rifles, or M-1911 pistols.

8 SEC. 8017. No more than \$500,000 of the funds ap-
9 propriated or made available in this Act shall be used dur-
10 ing a single fiscal year for any single relocation of an orga-
11 nization, unit, activity or function of the Department of
12 Defense into or within the National Capital Region: *Pro-*
13 *vided*, That the Secretary of Defense may waive this re-
14 striction on a case-by-case basis by certifying in writing
15 to the congressional defense committees that such a relo-
16 cation is required in the best interest of the Government.

17 SEC. 8018. In addition to the funds provided else-
18 where in this Act, \$8,000,000 is appropriated only for in-
19 centive payments authorized by section 504 of the Indian
20 Financing Act of 1974 (25 U.S.C. 1544): *Provided*, That
21 a prime contractor or a subcontractor at any tier that
22 makes a subcontract award to any subcontractor or sup-
23 plier as defined in section 1544 of title 25, United States
24 Code or a small business owned and controlled by an indi-
25 vidual or individuals defined under section 4221(9) of title

1 25, United States Code shall be considered a contractor
2 for the purposes of being allowed additional compensation
3 under section 504 of the Indian Financing Act of 1974
4 (~~25 U.S.C. 1544~~) whenever the prime contract or sub-
5 contract amount is over \$500,000 and involves the ex-
6 penditure of funds appropriated by an Act making Appro-
7 priations for the Department of Defense with respect to
8 any fiscal year: *Provided further*, That notwithstanding
9 section 430 of title 41, United States Code, this section
10 shall be applicable to any Department of Defense acquisi-
11 tion of supplies or services, including any contract and any
12 subcontract at any tier for acquisition of commercial items
13 produced or manufactured, in whole or in part by any sub-
14 contractor or supplier defined in section 1544 of title 25,
15 United States Code or a small business owned and con-
16 trolled by an individual or individuals defined under sec-
17 tion 4221(9) of title 25, United States Code: *Provided fur-*
18 *ther*, That, during the current fiscal year and hereafter,
19 businesses certified as 8(a) by the Small Business Admin-
20 istration pursuant to section 8(a)(15) of Public Law 85-
21 536, as amended, shall have the same status as other pro-
22 gram participants under section 602 of Public Law 100-
23 656, 102 Stat. 3825 (Business Opportunity Development
24 Reform Act of 1988) for purposes of contracting with
25 agencies of the Department of Defense.

1 SEC. 8019. None of the funds appropriated by this
2 Act shall be available to perform any cost study pursuant
3 to the provisions of OMB Circular A-76 if the study being
4 performed exceeds a period of 24 months after initiation
5 of such study with respect to a single function activity or
6 30 months after initiation of such study for a multi-func-
7 tion activity.

8 SEC. 8020. Funds appropriated by this Act for the
9 American Forces Information Service shall not be used for
10 any national or international political or psychological ac-
11 tivities.

12 SEC. 8021. During the current fiscal year, the De-
13 partment of Defense is authorized to incur obligations of
14 not to exceed \$350,000,000 for purposes specified in sec-
15 tion 2350j(e) of title 10, United States Code, in anticipa-
16 tion of receipt of contributions, only from the Government
17 of Kuwait, under that section: *Provided*, That upon re-
18 ceipt, such contributions from the Government of Kuwait
19 shall be credited to the appropriations or fund which in-
20 curred such obligations.

21 SEC. 8022. (a) Of the funds made available in this
22 Act, not less than \$36,188,000 shall be available for the
23 Civil Air Patrol Corporation, of which—

24 (1) \$25,087,000 shall be available from “Oper-
25 ation and Maintenance, Air Force” to support Civil

1 Air Patrol Corporation operation and maintenance,
2 readiness, counterdrug activities, and drug demand
3 reduction activities involving youth programs;

4 (2) \$10,193,000 shall be available from “Air-
5 craft Procurement, Air Force”; and

6 (3) \$908,000 shall be available from “Other
7 Procurement, Air Force” for vehicle procurement.

8 (b) The Secretary of the Air Force should waive reim-
9 bursement for any funds used by the Civil Air Patrol for
10 counter-drug activities in support of Federal, State, and
11 local government agencies.

12 SEC. 8023. (a) None of the funds appropriated in this
13 Act are available to establish a new Department of De-
14 fense (department) federally funded research and develop-
15 ment center (FFRDC), either as a new entity, or as a
16 separate entity administrated by an organization man-
17 aging another FFRDC, or as a nonprofit membership cor-
18 poration consisting of a consortium of other FFRDCs and
19 other non-profit entities.

20 (b) No member of a Board of Directors, Trustees,
21 Overseers, Advisory Group, Special Issues Panel, Visiting
22 Committee, or any similar entity of a defense FFRDC,
23 and no paid consultant to any defense FFRDC, except
24 when acting in a technical advisory capacity, may be com-
25 pensated for his or her services as a member of such enti-

1 ty, or as a paid consultant by more than one FFRDC in
2 a fiscal year: *Provided*, That a member of any such entity
3 referred to previously in this subsection shall be allowed
4 travel expenses and per diem as authorized under the Fed-
5 eral Joint Travel Regulations, when engaged in the per-
6 formance of membership duties.

7 (c) Notwithstanding any other provision of law, none
8 of the funds available to the department from any source
9 during fiscal year 2007 may be used by a defense FFRDC,
10 through a fee or other payment mechanism, for construc-
11 tion of new buildings, for payment of cost sharing for
12 projects funded by Government grants, for absorption of
13 contract overruns, or for certain charitable contributions,
14 not to include employee participation in community service
15 and/or development.

16 (d) Notwithstanding any other provision of law, of
17 the funds available to the department during fiscal year
18 2007, not more than 5,417 staff years of technical effort
19 (staff years) may be funded for defense FFRDCs: *Pro-*
20 *vided*, That this subsection shall not apply to staff years
21 funded in the National Intelligence Program (NIP) and
22 the Military Intelligence Program (MIP).

23 (e) The Secretary of Defense shall, with the submis-
24 sion of the department's fiscal year 2008 budget request,
25 submit a report presenting the specific amounts of staff

1 years of technical effort to be allocated for each defense
2 FFRDC during that fiscal year.

3 (f) Notwithstanding any other provision of this Act,
4 the total amount appropriated in this Act for FFRDCs
5 is hereby reduced by \$25,000,000.

6 SEC. 8024. None of the funds appropriated or made
7 available in this Act shall be used to procure carbon, alloy
8 or armor steel plate for use in any Government-owned fa-
9 cility or property under the control of the Department of
10 Defense which were not melted and rolled in the United
11 States or Canada: *Provided*, That these procurement re-
12 strictions shall apply to any and all Federal Supply Class
13 9515, American Society of Testing and Materials (ASTM)
14 or American Iron and Steel Institute (AISI) specifications
15 of carbon, alloy or armor steel plate: *Provided further*,
16 That the Secretary of the military department responsible
17 for the procurement may waive this restriction on a case-
18 by-case basis by certifying in writing to the Committees
19 on Appropriations of the House of Representatives and the
20 Senate that adequate domestic supplies are not available
21 to meet Department of Defense requirements on a timely
22 basis and that such an acquisition must be made in order
23 to acquire capability for national security purposes: *Pro-*
24 *vided further*, That these restrictions shall not apply to

1 contracts which are in being as of the date of the enact-
2 ment of this Act.

3 SEC. 8025. For the purposes of this Act, the term
4 “congressional defense committees” means the Armed
5 Services Committee of the House of Representatives, the
6 Armed Services Committee of the Senate, the Sub-

8 of the Senate, and the Subcommittee on Defense of the
9 Committee on Appropriations of the House of Representa-
10 tives.

11 SEC. 8026. During the current fiscal year, the De-
12 partment of Defense may acquire the modification, depot
13 maintenance and repair of aircraft, vehicles and vessels
14 as well as the production of components and other De-
15 fense-related articles, through competition between De-
16 partment of Defense depot maintenance activities and pri-
17 vate firms: *Provided*, That the Senior Acquisition Execu-
18 tive of the military department or Defense Agency con-
19 cerned, with power of delegation, shall certify that success-
20 ful bids include comparable estimates of all direct and in-
21 direct costs for both public and private bids: *Provided fur-*
22 *ther*, That Office of Management and Budget Circular A-
23 76 shall not apply to competitions conducted under this
24 section.

1 SEC. 8027. (a)(1) If the Secretary of Defense, after
2 consultation with the United States Trade Representative,
3 determines that a foreign country which is party to an
4 agreement described in paragraph (2) has violated the
5 terms of the agreement by discriminating against certain
6 types of products produced in the United States that are
7 covered by the agreement, the Secretary of Defense shall
8 rescind the Secretary's blanket waiver of the Buy Amer-
9 ican Act with respect to such types of products produced
10 in that foreign country.

11 (2) An agreement referred to in paragraph (1) is any
12 reciprocal defense procurement memorandum of under-
13 standing, between the United States and a foreign country
14 pursuant to which the Secretary of Defense has prospec-
15 tively waived the Buy American Act for certain products
16 in that country.

17 (b) The Secretary of Defense shall submit to the Con-
18 gress a report on the amount of Department of Defense
19 purchases from foreign entities in fiscal year 2007. Such
20 report shall separately indicate the dollar value of items
21 for which the Buy American Act was waived pursuant to
22 any agreement described in subsection (a)(2), the Trade
23 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any
24 international agreement to which the United States is a
25 party.

1 (c) For purposes of this section, the term “Buy
2 American Act” means title III of the Act entitled “An Act
3 making appropriations for the Treasury and Post Office
4 Departments for the fiscal year ending June 30, 1934,
5 and for other purposes”, approved March 3, 1933 (41
6 U.S.C. 10a et seq.).

7 SEC. 8028. Notwithstanding any other provision of
8 law, funds available during the current fiscal year and
9 hereafter for “Drug Interdiction and Counter-Drug Activi-
10 ties, Defense” may be obligated for the Young Marines
11 program.

12 SEC. 8029. During the current fiscal year, amounts
13 contained in the Department of Defense Overseas Military
14 Facility Investment Recovery Account established by sec-
15 tion 2921(e)(1) of the National Defense Authorization Act
16 of 1991 (Public Law 101-510; 10 U.S.C. 2687 note) shall
17 be available until expended for the payments specified by
18 section 2921(e)(2) of that Act.

19 SEC. 8030. (a) IN GENERAL.—Notwithstanding any
20 other provision of law, the Secretary of the Air Force may
21 convey at no cost to the Air Force, without consideration,
22 to Indian tribes located in the States of North Dakota,
23 South Dakota, Montana, and Minnesota relocatable mili-
24 tary housing units located at Grand Forks Air Force Base

1 and Minot Air Force Base that are excess to the needs
2 of the Air Force.

3 (b) PROCESSING OF REQUESTS.—The Secretary of
4 the Air Force shall convey, at no cost to the Air Force,
5 military housing units under subsection (a) in accordance
6 with the request for such units that are submitted to the
7 Secretary by the Operation Walking Shield Program on
8 behalf of Indian tribes located in the States of North Da-
9 kota, South Dakota, Montana, and Minnesota.

10 (c) RESOLUTION OF HOUSING UNIT CONFLICTS.—
11 The Operation Walking Shield Program shall resolve any
12 conflicts among requests of Indian tribes for housing units
13 under subsection (a) before submitting requests to the
14 Secretary of the Air Force under subsection (b).

15 (d) INDIAN TRIBE DEFINED.—In this section, the
16 term “Indian tribe” means any recognized Indian tribe in-
17 cluded on the current list published by the Secretary of
18 the Interior under section 104 of the Federally Recognized
19 Indian Tribe Act of 1994 (Public Law 103–454, 108 Stat.
20 4792, 25 U.S.C. 479a–1).

21 SEC. 8031. During the current fiscal year, appropria-
22 tions which are available to the Department of Defense
23 for operation and maintenance may be used to purchase
24 items having an investment item unit cost of not more
25 than \$250,000.

1 SEC. 8032. (a) During the current fiscal year, none
2 of the appropriations or funds available to the Department
3 of Defense Working Capital Funds shall be used for the
4 purchase of an investment item for the purpose of acquir-
5 ing a new inventory item for sale or anticipated sale dur-
6 ing the current fiscal year or a subsequent fiscal year to
7 customers of the Department of Defense Working Capital
8 Funds if such an item would not have been chargeable
9 to the Department of Defense Business Operations Fund
10 during fiscal year 1994 and if the purchase of such an
11 investment item would be chargeable during the current
12 fiscal year to appropriations made to the Department of
13 Defense for procurement.

14 (b) The fiscal year 2008 budget request for the De-
15 partment of Defense as well as all justification material
16 and other documentation supporting the fiscal year 2008
17 Department of Defense budget shall be prepared and sub-
18 mitted to the Congress on the basis that any equipment
19 which was classified as an end item and funded in a pro-
20 curement appropriation contained in this Act shall be
21 budgeted for in a proposed fiscal year 2008 procurement
22 appropriation and not in the supply management business
23 area or any other area or category of the Department of
24 Defense Working Capital Funds.

1 ~~SEC. 8033.~~ None of the funds appropriated by this
2 Act for programs of the Central Intelligence Agency shall
3 remain available for obligation beyond the current fiscal
4 year, except for funds appropriated for the Reserve for
5 Contingencies, which shall remain available until Sep-
6 tember 30, 2008: *Provided,* That funds appropriated,
7 transferred, or otherwise credited to the Central Intel-

22 competitive, quality-competitive, and available in a timely

1 or consulting services entered into without competition on
2 the basis of an unsolicited proposal unless the head of the

5 only one source is found fully qualified to perform
6 the proposed work;

7 (2) the purpose of the contract is to explore an
8 unsolicited proposal which offers significant sci-

12 (3) the purpose of the contract is to take ad-

14 the Air National Guard, Army Reserve and Air Force Re-
15 serve for the purpose of applying any administratively im-
16 posed civilian personnel ceiling, freeze, or reduction on
17 military (civilian) technicians, unless such reductions are
18 a direct result of a reduction in military force structure.

19 SEC. 8041. None of the funds appropriated or other-
20 wise made available in this Act may be obligated or ex-
21 pended for assistance to the Democratic People’s Republic
22 of North Korea unless specifically appropriated for that
23 purpose.

24 SEC. 8042. Funds appropriated in this Act for oper-
25 ation and maintenance of the Military Departments, Com-

1 batant Commands and Defense Agencies shall be available
2 for reimbursement of pay, allowances and other expenses
3 which would otherwise be incurred against appropriations
4 for the National Guard and Reserve when members of the
5 National Guard and Reserve provide intelligence or coun-
6 terintelligence support to Combatant Commands, Defense
7 Agencies and Joint Intelligence Activities, including the
8 activities and programs included within the National Intel-
9 ligence Program, and the Military Intelligence Program:
10 *Provided*, That nothing in this section authorizes deviation

14 fying in writing to the Committees on Appropriations of
15 the House of Representatives and the Senate, that ade-

1 SEC. 8050. None of the funds available to the De-
2 partment of Defense under this Act shall be obligated or
3 expended to pay a contractor under a contract with the
4 Department of Defense for costs of any amount paid by
5 the contractor to an employee when—

7 excess of the normal salary paid by the contractor
8 to the employee; and

9 (2) such bonus is part of restructuring costs as-

16 that the unit has committed a gross violation of human
17 rights, unless all necessary corrective steps have been

4 *ment of Defense may acquire the modification, depot main-*
5 *tenance and repair of aircraft, vehicles and vessels as well*
6 *as the production of components and other Defense-related*
7 *articles, through competition between Department of De-*
8 *fense depot maintenance activities and private firms: Pro-*
9 *vided, That the Senior Acquisition Executive of the military*
10 *department or Defense Agency concerned, with power of del-*
11 *egation, shall certify that successful bids include comparable*
12 *estimates of all direct and indirect costs for both public and*
13 *private bids: Provided further, That Office of Management*
14 *and Budget Circular A-76 shall not apply to competitions*
15 *conducted under this section.*

16 *SEC. 8030. (a)(1) If the Secretary of Defense, after con-*
17 *sultation with the United States Trade Representative, de-*
18 *termines that a foreign country which is party to an agree-*
19 *ment described in paragraph (2) has violated the terms of*
20 *the agreement by discriminating against certain types of*
21 *products produced in the United States that are covered by*
22 *the agreement, the Secretary of Defense shall rescind the*
23 *Secretary's blanket waiver of the Buy American Act with*
24 *respect to such types of products produced in that foreign*
25 *country.*

1 (2) *An agreement referred to in paragraph (1) is any*
2 *reciprocal defense procurement memorandum of under-*
3 *standing, between the United States and a foreign country*
4 *pursuant to which the Secretary of Defense has prospec-*
5 *tively waived the Buy American Act for certain products*
6 *in that country.*

7 (b) *The Secretary of Defense shall submit to the Con-*
8 *gress a report on the amount of Department of Defense pur-*
9 *chases from foreign entities in fiscal year 2007. Such report*
10 *shall separately indicate the dollar value of items for which*
11 *the Buy American Act was waived pursuant to any agree-*
12 *ment described in subsection (a)(2), the Trade Agreement*
13 *Act of 1979 (19 U.S.C. 2501 et seq.), or any international*
14 *agreement to which the United States is a party.*

15 (c) *For purposes of this section, the term “Buy Amer-*
16 *ican Act” means title III of the Act entitled “An Act mak-*
17 *ing appropriations for the Treasury and Post Office De-*
18 *partments for the fiscal year ending June 30, 1934, and*
19 *for other purposes”, approved March 3, 1933 (41 U.S.C.*
20 *10a et seq.).*

21 SEC. 8031. *Notwithstanding any other provision of*
22 *law, funds available during the current fiscal year and*
23 *hereafter for “Drug Interdiction and Counter-Drug Activi-*
24 *ties, Defense” may be obligated for the Young Marines pro-*
25 *gram.*

1 (INCLUDING TRANSFER OF FUNDS)

2 SEC. 8032. *During the current fiscal year, amounts*
3 *contained in the Department of Defense Overseas Military*
4 *Facility Investment Recovery Account established by section*
5 *2921(c)(1) of the National Defense Authorization Act of*
6 *1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall be*
7 *available until expended for the payments specified by sec-*
8 *tion 2921(c)(2) of that Act.*

9 SEC. 8033. (a) *IN GENERAL.*—*Notwithstanding any*
10 *other provision of law, the Secretary of the Air Force may*
11 *convey at no cost to the Air Force, without consideration,*
12 *to Indian tribes located in the States of North Dakota,*
13 *South Dakota, Montana, and Minnesota relocatable mili-*
14 *tary housing units located at Grand Forks Air Force Base*
15 *and Minot Air Force Base that are excess to the needs of*
16 *the Air Force.*

17 (b) *PROCESSING OF REQUESTS.*—*The Secretary of the*
18 *Air Force shall convey, at no cost to the Air Force, military*

3 *retary of the Air Force under subsection (b).*

4 (d) *INDIAN TRIBE DEFINED.*—*In this section, the term*

20 *the current fiscal year or a subsequent fiscal year to cus-*

22 *Funds if such an item would not have been chargeable to*

24 *ing fiscal year 1994 and if the purchase of such an invest-*

1 *year to appropriations made to the Department of Defense*
2 *for procurement.*

3 **(b)** *The fiscal year 2008 budget request for the Depart-*
4 *ment of Defense as well as all justification material and*
5 *other documentation supporting the fiscal year 2008 De-*
6 *partment of Defense budget shall be prepared and submitted*
7 *to the Congress on the basis that any equipment which was*
8 *classified as an end item and funded in a procurement ap-*
9 *propriation contained in this Act shall be budgeted for in*
10 *a proposed fiscal year 2008 procurement appropriation and*
11 *not in the supply management business area or any other*
12 *area or category of the Department of Defense Working*
13 *Capital Funds.*

14 **SEC. 8036.** *None of the funds appropriated by this Act*
15 *for programs of the Central Intelligence Agency shall re-*
16 *main available for obligation beyond the current fiscal year,*

19 *2008: Provided, That funds appropriated, transferred, or*

5 *SEC. 8037. Notwithstanding any other provision of*
6 *law, funds made available in this Act for the Defense Intel-*
7 *ligence Agency may be used for the design, development, and*
8 *deployment of General Defense Intelligence Program intel-*
9 *ligence communications and intelligence information sys-*
10 *tems for the Services, the Unified and Specified Commands,*
11 *and the component commands.*

12 *SEC. 8038. Of the funds appropriated to the Depart-*
13 *ment of Defense under the heading “Operation and Mainte-*
14 *nance, Defense-Wide”, not less than \$10,000,000 shall be*
15 *made available only for the mitigation of environmental*
16 *impacts, including training and technical assistance to*
17 *tribes, related administrative support, the gathering of in-*
18 *formation, documenting of environmental damage, and de-*
19 *veloping a system for prioritization of mitigation and cost*

9 *or shipped to the United States that is not made in Amer-*
10 *ica, the Secretary shall determine, in accordance with sec-*
11 *tion 2410f of title 10, United States Code, whether the per-*
12 *son should be debarred from contracting with the Depart-*
13 *ment of Defense.*

14 *(c) In the case of any equipment or products purchased*
15 *with appropriations provided under this Act, it is the sense*
16 *of the Congress that any entity of the Department of De-*
17 *fense, in expending the appropriation, purchase only Amer-*
18 *ican-made equipment and products, provided that Amer-*
19 *ican-made equipment and products are cost-competitive,*
20 *quality-competitive, and available in a timely fashion.*

21 *SEC. 8040. None of the funds appropriated by this Act*
22 *shall be available for a contract for studies, analysis, or*
23 *consulting services entered into without competition on the*
24 *basis of an unsolicited proposal unless the head of the activ-*
25 *ity responsible for the procurement determines—*

1 (1) *as a result of thorough technical evaluation,*
2 *only one source is found fully qualified to perform the*
3 *proposed work;*

4 (2) *the purpose of the contract is to explore an*
5 *unsolicited proposal which offers significant scientific*
6 *or technological promise, represents the product of*
7 *original thinking, and was submitted in confidence*
8 *by one source; or*

9 (3) *the purpose of the contract is to take advan-*
10 *tage of unique and significant industrial accomplish-*
11 *ment by a specific concern, or to insure that a new*
12 *product or idea of a specific concern is given finan-*
13 *cial support: Provided, That this limitation shall not*
14 *apply to contracts in an amount of less than \$25,000,*
15 *contracts related to improvements of equipment that*
16 *is in development or production, or contracts as to*
17 *which a civilian official of the Department of Defense,*
18 *who has been confirmed by the Senate, determines*
19 *that the award of such contract is in the interest of*
20 *the national defense.*

21 SEC. 8041. (a) *Except as provided in subsection (b)*
22 *and (c), none of the funds made available by this Act may*
23 *be used—*

24 (1) *to establish a field operating agency; or*

1 (2) to pay the basic pay of a member of the
2 *Armed Forces or civilian employee of the department*
3 *who is transferred or reassigned from a headquarters*
4 *activity if the member or employee’s place of duty re-*

6 (b) *The Secretary of Defense or Secretary of a military*
7 *department may waive the limitations in subsection (a),*
8 *on a case-by-case basis, if the Secretary determines, and cer-*
9 *tifies to the Committees on Appropriations of the House of*
10 *Representatives and Senate that the granting of the waiver*
11 *will reduce the personnel requirements or the financial re-*
12 *quirements of the department.*

13 (c) *This section does not apply to—*

14 (1) *field operating agencies funded within the*
15 *National Intelligence Program; or*

18 *vised explosive devices, and, as determined by the Sec-*
19 *retary of the Army, other similar threats.*

20 *SEC. 8042. The Secretary of Defense, notwithstanding*
21 *any other provision of law, acting through the Office of Eco-*
22 *nomics Adjustment of the Department of Defense, may use*
23 *funds made available in this Act under the heading “Oper-*
24 *ation and Maintenance, Defense-Wide” to make grants and*
25 *supplement other Federal funds in accordance with the*

1 *guidance provided in the report of the Committee on Appro-*
2 *priations of the Senate accompanying this Act, and the*
3 *projects specified in such guidance shall be considered to*
4 *be authorized by law.*

7 *SEC. 8044. None of the funds available in this Act may*
8 *be used to reduce the authorized positions for military (ci-*
9 *vilian) technicians of the Army National Guard, the Air*
10 *National Guard, Army Reserve and Air Force Reserve for*
11 *the purpose of applying any administratively imposed ci-*
12 *vilian personnel ceiling, freeze, or reduction on military (ci-*
13 *vilian) technicians, unless such reductions are a direct re-*
14 *sult of a reduction in military force structure.*

15 *SEC. 8045. None of the funds appropriated or other-*
16 *wise made available in this Act may be obligated or ex-*
17 *pended for assistance to the Democratic People’s Republic*
18 *of North Korea unless specifically appropriated for that*
19 *purpose.*

20 *SEC. 8046. Funds appropriated in this Act for oper-*
21 *ation and maintenance of the Military Departments, Com-*

9 *SEC. 8050. None of the funds appropriated by this Act*
10 *may be used for the procurement of ball and roller bearings*
11 *other than those produced by a domestic source and of do-*
12 *mestic origin: Provided, That the Secretary of the military*
13 *department responsible for such procurement may waive*
14 *this restriction on a case-by-case basis by certifying in writ-*
15 *ing to the Committees on Appropriations of the House of*
16 *Representatives and the Senate, that adequate domestic*
17 *supplies are not available to meet Department of Defense*

4 *proves or implements the transfer of administrative respon-*
5 *sibilities or budgetary resources of any program, project,*
6 *or activity financed by this Act to the jurisdiction of an-*
7 *other Federal agency not financed by this Act without the*
8 *express authorization of Congress: Provided, That this limi-*
9 *tation shall not apply to transfers of funds expressly pro-*
10 *vided for in Defense Appropriations Acts, or provisions of*
11 *Acts providing supplemental appropriations for the De-*
12 *partment of Defense.*

13 *SEC. 8054. (a) LIMITATION ON TRANSFER OF DE-*
14 *FENSE ARTICLES AND SERVICES.—Notwithstanding any*
15 *other provision of law, none of the funds available to the*
16 *Department of Defense for the current fiscal year may be*
17 *obligated or expended to transfer to another nation or an*
18 *international organization any defense articles or services*
19 *(other than intelligence services) for use in the activities de-*
20 *scribed in subsection (b) unless the congressional defense*
21 *committees, the Committee on International Relations of*
22 *the House of Representatives, and the Committee on For-*

6 (2) *any other international peacekeeping, peace-*
7 *enforcement, or humanitarian assistance operation.*

8 (c) *REQUIRED NOTICE.*—*A notice under subsection (a)*
9 *shall include the following:*

10 (1) *A description of the equipment, supplies, or*
11 *services to be transferred.*

12 (2) *A statement of the value of the equipment,*
13 *supplies, or services to be transferred.*

14 (3) *In the case of a proposed transfer of equip-*
15 *ment or supplies—*

16 (A) *a statement of whether the inventory re-*
17 *quirements of all elements of the Armed Forces*
18 *(including the reserve components) for the type*
19 *of equipment or supplies to be transferred have*
20 *been met; and*

21 (B) *a statement of whether the items pro-*
22 *posed to be transferred will have to be replaced*
23 *and, if so, how the President proposes to provide*
24 *funds for such replacement.*

1 *SEC. 8055. None of the funds available to the Depart-*
2 *ment of Defense under this Act shall be obligated or ex-*
3 *pende*d to pay a contractor under a contract with the De-
4 *partment of Defense for costs of any amount paid by the*
5 *contractor to an employee when—*

6 (1) *such costs are for a bonus or otherwise in ex-*
7 *cess of the normal salary paid by the contractor to the*
8 *employee; and*

9 (2) *such bonus is part of restructuring costs asso-*
10 *ciated with a business combination.*

11 *(INCLUDING TRANSFER OF FUNDS)*

12 *SEC. 8056. During the current fiscal year, no more*
13 *than \$30,000,000 of appropriations made in this Act under*
14 *the heading “Operation and Maintenance, Defense-Wide”*
15 *may be transferred to appropriations available for the pay*

2 *an adjustment of an obligation may be charged to any cur-*
3 *rent appropriation account for the same purpose as the ex-*
4 *pired or closed account if—*

5 (1) *the obligation would have been properly*
6 *chargeable (except as to amount) to the expired or*
7 *closed account before the end of the period of avail-*
8 *ability or closing of that account;*

9 (2) *the obligation is not otherwise properly*
10 *chargeable to any current appropriation account of*
11 *the Department of Defense; and*

12 (3) *in the case of an expired account, the obliga-*
13 *tion is not chargeable to a current appropriation of*
14 *the Department of Defense under the provisions of sec-*
15 *tion 1405(b)(8) of the National Defense Authorization*
16 *Act for Fiscal Year 1991, Public Law 101–510, as*
17 *amended (31 U.S.C. 1551 note): Provided, That in*
18 *the case of an expired account, if subsequent review*
19 *or investigation discloses that there was not in fact a*
20 *negative unliquidated or unexpended balance in the*
21 *account, any charge to a current account under the*
22 *authority of this section shall be reversed and re-*
23 *corded against the expired account: Provided further,*
24 *That the total amount charged to a current appro-*
25 *priation under this section may not exceed an*

1 *amount equal to 1 percent of the total appropriation*

3 *SEC. 8058. (a) Notwithstanding any other provision*
4 *of law, the Chief of the National Guard Bureau may permit*
5 *the use of equipment of the National Guard Distance Learn-*

1 *for the purpose of enabling military commanders in Iraq*
2 *to respond to urgent humanitarian relief and reconstruction*
3 *requirements within their areas of responsibility by car-*
4 *rying out programs that will immediately assist the Iraqi*
5 *people, and to fund a similar program to assist the people*
6 *of Afghanistan.*

7 **(b) QUARTERLY REPORTS.**—*Not later than 15 days*
8 *after the end of each fiscal year quarter (beginning with*
9 *the first quarter of fiscal year 2007), the Secretary of De-*
10 *fense shall submit to the congressional defense committees*
11 *a report regarding the source of funds and the allocation*
12 *and use of funds during that quarter that were made avail-*
13 *able pursuant to the authority provided in this section or*
14 *under any other provision of law for the purposes of the*
15 *programs under subsection (a).*

16 **SEC. 9007.** *Amounts provided in this title for oper-*
17 *ations in Iraq and Afghanistan may be used by the Depart-*
18 *ment of Defense for the purchase of up to 20 heavy and*
19 *light armored vehicles for force protection purposes, not-*
20 *withstanding price or other limitations specified elsewhere*
21 *in this Act, or any other provision of law: Provided, That*
22 *the Secretary of Defense shall submit a report in writing*
23 *no later than 30 days after the end of each fiscal quarter*
24 *notifying the congressional defense committees of any pur-*

1 chase described in this section, including the cost, purposes,
2 and quantities of vehicles purchased.

3 *SEC. 9008. During the current fiscal year, funds avail-*
4 *able to the Department of Defense for operation and mainte-*
5 *nance may be used, notwithstanding any other provision*
6 *of law, to provide supplies, services, transportation, includ-*
7 *ing airlift and sealift, and other logistical support to coal-*
8 *ition forces supporting military and stability operations in*
9 *Iraq and Afghanistan: Provided, That the Secretary of De-*
10 *fense shall provide quarterly reports to the congressional de-*
11 *fense committees regarding support provided under this sec-*
12 *tion.*

13 *SEC. 9009. Supervision and administration costs asso-*
14 *ciated with a construction project funded with appropria-*
15 *tions available for operation and maintenance, and exe-*
16 *cuted in direct support of the Global War on Terrorism only*
17 *in Iraq and Afghanistan, may be obligated at the time a*
18 *construction contract is awarded: Provided, That for the*
19 *purpose of this section, supervision and administration*
20 *costs include all in-house Government costs.*

21 *SEC. 9010. (a) Not later than 60 days after the date*
22 *of the enactment of this Act and every 90 days thereafter*
23 *through the end of fiscal year 2007, the Secretary of Defense*
24 *shall set forth in a report to Congress a comprehensive set*

1 *of performance indicators and measures for progress toward*
2 *military and political stability in Iraq.*

3 *(b) The report shall include performance standards*
4 *and goals for security, economic, and security force training*
5 *objectives in Iraq together with a notional timetable for*
6 *achieving these goals.*

7 *(c) In specific, the report requires, at a minimum, the*
8 *following:*

9 *(1) With respect to stability and security in*
10 *Iraq, the following:*

11 *(A) Key measures of political stability, in-*
12 *cluding the important political milestones that*
13 *must be achieved over the next several years.*

14 *(B) The primary indicators of a stable secu-*
15 *rity environment in Iraq, such as number of en-*
16 *gagements per day, numbers of trained Iraqi*
17 *forces, and trends relating to numbers and types*
18 *of ethnic and religious-based hostile encounters.*

19 *(C) An assessment of the estimated strength*
20 *of the insurgency in Iraq and the extent to which*
21 *it is composed of non-Iraqi fighters.*

22 *(D) A description of all militias operating*
23 *in Iraq, including the number, size, equipment*
24 *strength, military effectiveness, sources of sup-*

1 *port, legal status, and efforts to disarm or re-*
2 *integrate each militia.*

3 *(E) Key indicators of economic activity that*
4 *should be considered the most important for de-*
5 *termining the prospects of stability in Iraq, in-*
6 *cluding—*

7 *(i) unemployment levels;*

8 *(ii) electricity, water, and oil produc-*
9 *tion rates; and*

10 *(iii) hunger and poverty levels.*

11 *(F) The criteria the Administration will use*
12 *to determine when it is safe to begin with-*
13 *drawing United States forces from Iraq.*

14 *(2) With respect to the training and performance*
15 *of security forces in Iraq, the following:*

16 *(A) The training provided Iraqi military*
17 *and other Ministry of Defense forces and the*
18 *equipment used by such forces.*

19 *(B) Key criteria for assessing the capabili-*
20 *ties and readiness of the Iraqi military and*
21 *other Ministry of Defense forces, goals for achiev-*
22 *ing certain capability and readiness levels (as*
23 *well as for recruiting, training, and equipping*
24 *these forces), and the milestones and notional*
25 *timetable for achieving these goals.*

1 (C) *The operational readiness status of the*
2 *Iraqi military forces, including the type, num-*
3 *ber, size, and organizational structure of Iraqi*
4 *battalions that are—*

5 (i) *capable of conducting*
6 *counterinsurgency operations independ-*
7 *ently;*

8 (ii) *capable of conducting*
9 *counterinsurgency operations with the sup-*
10 *port of United States or coalition forces; or*

11 (iii) *not ready to conduct*
12 *counterinsurgency operations.*

13 (D) *The rates of absenteeism in the Iraqi*
14 *military forces and the extent to which insur-*
15 *gents have infiltrated such forces.*

16 (E) *The training provided Iraqi police and*
17 *other Ministry of Interior forces and the equip-*
18 *ment used by such forces.*

19 (F) *Key criteria for assessing the capabili-*
20 *ties and readiness of the Iraqi police and other*
21 *Ministry of Interior forces, goals for achieving*
22 *certain capability and readiness levels (as well*
23 *as for recruiting, training, and equipping), and*
24 *the milestones and notional timetable for achiev-*
25 *ing these goals, including—*

1 (i) the number of police recruits that
2 have received classroom training and the
3 duration of such instruction;

4 (ii) the number of veteran police offi-
5 cers who have received classroom instruction
6 and the duration of such instruction;

7 (iii) the number of police candidates
8 screened by the Iraqi Police Screening Serv-
9 ice, the number of candidates derived from
10 other entry procedures, and the success rates
11 of those groups of candidates;

12 (iv) the number of Iraqi police forces
13 who have received field training by inter-
14 national police trainers and the duration of
15 such instruction; and

16 (v) attrition rates and measures of ab-
17 senteeism and infiltration by insurgents.

18 (G) The estimated total number of Iraqi
19 battalions needed for the Iraqi security forces to
20 perform duties now being undertaken by coal-
21 ition forces, including defending the borders of
22 Iraq and providing adequate levels of law and
23 order throughout Iraq.

1 (H) *The effectiveness of the Iraqi military*
2 *and police officer cadres and the chain of com-*
3 *mand.*

4 (I) *The number of United States and coal-*
5 *ition advisors needed to support the Iraqi secu-*
6 *rity forces and associated ministries.*

7 (J) *An assessment, in a classified annex if*
8 *necessary, of United States military require-*
9 *ments, including planned force rotations,*
10 *through the end of calendar year 2007.*

11 *SEC. 9011. Amounts provided in chapters 1 and 2 of*
12 *this title are designated as making appropriations for con-*
13 *tingency operations directly related to the global war on*
14 *terrorism, and other unanticipated defense-related oper-*
15 *ations, pursuant to section 402 of H. Con. Res. 376 (109th*
16 *Congress), as made applicable to the House of Representa-*
17 *tives by H. Res. 818 (109th Congress) and are designated*
18 *as an emergency requirement pursuant to section 402 of*
19 *S. Con. Res. 83 (109th Congress), the concurrent resolution*
20 *on the budget for fiscal year 2007, as made applicable in*
21 *the Senate by section 7035 of Public Law 109–234: Pro-*
22 *vided, That the amounts provided in chapters 3, 4, 5, and*
23 *6 of this title are available immediately upon enactment*
24 *of this Act.*
