AN ACT

To amend title 38, United States Code, to extend certain expiring provisions of law administered by the Secretary of Veterans Affairs, to expand eligibility for the Survivors' and Dependents' Educational Assistance program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) SHORT TITLE.—This Act may be cited as the
3 “Veterans Programs Extension Act of 2006”.

4 (b) TABLE OF CONTENTS.—The table of contents of

6 **SEC. 2. EXTENSION OF CERTAIN EXPIRING PROVISIONS OF**
7 **LAW ADMINISTERED BY THE SECRETARY OF**
8 **VETERANS AFFAIRS.**

9 (a) AUTHORITY FOR HEALTH CARE FOR PARTICIPA-
10 TION IN DOD CHEMICAL AND BIOLOGICAL WARFARE
11 TESTING.—Section 1710(e)(3)(D) of title 38, United
12 States Code, is amended by striking “December 31, 2005”
13 and inserting “December 31, 2007”.

14 (b) GRANT AND PER DIEM GRANT ASSISTANCE FOR
15 HOMELESS VETERANS.—Section 2011(a)(2) of such title
16 is amended by striking “September 30, 2005” and insert-
17 ing “September 30, 2007”.

1 (c) TREATMENT AND REHABILITATION FOR SERI-
2 OUSLY MENTALLY ILL AND HOMELESS VETERANS.—Sec-
3 tion 2031(b) of such title is amended by striking “Decem-
4 ber 31, 2006” and inserting “December 31, 2007”.

5 (d) ADDITIONAL SERVICES FOR HOMELESS AND SE-
6 RIOUSLY MENTALLY ILL VETERANS.—Section 2033(d) of
7 such title is amended by striking “December 31, 2006”
8 and inserting “December 31, 2007”.

9 (e) ADVISORY COMMITTEE ON HOMELESS VET-
10 ERANS.—Section 2066(d) of such title is amended by
11 striking “December 31, 2006” and inserting “December
12 31, 2007”.

13 (f) GOVERNMENT MARKERS IN PRIVATE CEME-
14 TERIES.—Section 2306(d)(3) of such title is amended by
15 striking “December 31, 2006” and inserting “December
16 31, 2007”.

17 (g) ADDITIONAL EDUCATIONAL ASSISTANCE ALLOW-
18 ANCE FOR WORK-STUDY.—Section 3485(a)(4) of such
19 title is amended in subparagraphs (A), (C), and (F) by
20 striking “December 27, 2006” and inserting “June 30,
21 2007”.

1 **SEC. 3. EXPANSION OF ELIGIBILITY FOR SURVIVORS' AND**
2 **DEPENDENTS' EDUCATIONAL ASSISTANCE**
3 **PROGRAM.**

4 (a) EXPANSION OF ELIGIBILITY.—Section
5 3501(a)(1) of title 38, United States Code, is amended—

6 (1) in the matter preceding subparagraph (A),
7 by striking “means—” and inserting “means any of
8 the following:”;

9 (2) in each of subparagraphs (A) through (D),
10 by capitalizing the first letter of the first word;

11 (3) in subparagraph (A)—

12 (A) by inserting after “a person who” the
13 following: “, as a result of qualifying service”;

14 (B) by striking the comma at the end of
15 clause (i) and inserting “; or”;

16 (C) by striking “, or” at the end of clause
17 (ii) and inserting a period; and

18 (D) by striking clause (iii);

19 (4) in subparagraph (B) by striking the comma
20 at the end and inserting the following: “sustained
21 during a period of qualifying service.”;

22 (5) in subparagraph (C)—

23 (A) by inserting “or child” after “the
24 spouse”; and

25 (B) by striking “, or” at the end and in-
26 serting a period;

1 (6) in subparagraph (D)—

2 (A) in clause (i), by inserting before the
3 comma the following: “sustained during a pe-
4 riod of qualifying service”; and

5 (B) by striking the comma at the end and
6 inserting a period;

7 (7) by inserting after subparagraph (D) the fol-
8 lowing new subparagraph:

9 “(E) The spouse or child of a person
10 who—

11 “(i) at the time of the Secretary’s de-
12 termination under clause (ii), is a member
13 of the Armed Forces who is hospitalized or
14 receiving outpatient medical care, services,
15 or treatment;

16 “(ii) the Secretary determines has a
17 total disability permanent in nature in-
18 curred or aggravated in the line of duty in
19 the active military, naval, or air service;
20 and

21 “(iii) is likely to be discharged or re-
22 leased from such service for such dis-
23 ability.”; and

24 (8) by striking “arising out of” and all that fol-
25 lows through the end.

1 (b) CONFORMING AMENDMENTS TO CHAPTER 35.—
2 Chapter 35 of such title is further amended as follows:

3 (1) Section 3501(a) is amended by adding at
4 the end the following new paragraph:

5 “(12) The term ‘qualifying service’ means serv-
6 ice in the active military, naval, or air service after
7 the beginning of the Spanish-American War that did
8 not terminate under dishonorable conditions.”.

9 (2) Section 3511 is amended—

10 (A) in subsection (a)(1)—

11 (i) by striking “Each eligible person”
12 and inserting the following: “Each eligible
13 person, whether made eligible by one or
14 more of the provisions of section
15 3501(a)(1) of this title,”;

16 (ii) by striking “a period” and insert-
17 ing “an aggregate period”; and

18 (iii) by striking the second sentence;

19 (B) in subsection (b)—

20 (i) in paragraph (2)—

21 (I) by striking “the provisions of
22 section 3501(a)(1)(A)(iii) or” and in-
23 serting “section”; and

24 (II) by striking “or” at the end;

25 (ii) in paragraph (3)—

1 (I) by striking “section
2 3501(a)(1)(D)” and inserting “sub-
3 paragraph (D) or (E) of section
4 3501(a)(1)”;

5 (II) by inserting “or” after the
6 comma at the end; and

7 (iii) by inserting after paragraph (3)
8 the following new paragraph:

9 “(4) the parent or spouse from whom such eli-
10 gibility is derived based upon subparagraph (E) of
11 section 3501(a)(1) of this title no longer meets a re-
12 quirement under clause (i), (ii), or (iii) of that sub-
13 paragraph,”; and

14 (C) by striking subsection (c).

15 (3) Section 3512 is amended—

16 (A) in subsection (a)—

17 (i) by striking “an eligible person
18 (within the meaning of section
19 3501(a)(1)(A) of this title)” and inserting
20 “an eligible person whose eligibility is
21 based on the death or disability of a parent
22 or on a parent being listed in one of the
23 categories referred to in section
24 3501(a)(1)(C) of this title”;

1 (ii) in paragraph (6), by striking “the
2 provisions of section 3501(a)(1)(A)(iii)”
3 and inserting “a parent being listed in one
4 of the categories referred to in section
5 3501(a)(1)(C)”;

6 (B) in subsection (b)—

7 (i) in paragraph (1)(A)—

8 (I) by inserting after “section
9 3501(a)(1) of this title” the following:
10 “or a person made eligible by the dis-
11 ability of a spouse under section
12 3501(a)(1)(E) of this title”; and

13 (II) by striking “or
14 3501(a)(1)(D)(ii) of this title” and in-
15 serting “3501(a)(1)(D)(ii), or
16 3501(a)(1)(E) of this title”;

17 (ii) in paragraph (1)(B), by adding at
18 the end the following new clause:

19 “(iii) The date on which the Secretary notifies
20 the member of the Armed Forces from whom eligi-
21 bility is derived that the member has a total dis-
22 ability permanent in nature incurred or aggravated
23 in the line of duty in the active military, naval, or
24 air service.”; and

25 (iii) in paragraph (2)—

1 (I) by striking “or (D) of this
2 title” and inserting “(D), or (E) of
3 this title”; and

4 (II) by inserting “whose eligi-
5 bility is based on the death or dis-
6 ability of a spouse or on a spouse
7 being listed in one of the categories
8 referred to in section 3501(a)(1)(C) of
9 this title” after “of this title”;

10 (C) in subsection (d), by striking “vet-
11 eran” and inserting “person”; and

12 (D) in subsection (e)—

13 (i) by inserting “based on a spouse
14 being listed in one of the categories re-
15 ferred to in section 3501(a)(1)(C) of this
16 title” after “of this title”;

17 (ii) by inserting “so” after “the
18 spouse was”; and

19 (iii) by striking “by the Secretary”
20 and all that follows through “occurs”.

21 (4) Section 3540 is amended by striking “(as
22 defined in subparagraphs (A), (B), and (D) of sec-
23 tion 3501(a)(1) of this title)” and inserting “(other
24 than a person made eligible under subparagraph (C)
25 of such section by reason of a spouse being listed in

1 one of the categories referred to in that subpara-
2 graph)”.
3

4 (5) Section 3563 is amended by striking “each
5 eligible person defined in section 3501(a)(1)(A) of
6 this title” and inserting “each eligible person whose
7 eligibility is based on the death or disability of a
8 parent or on a parent being listed in one of the cat-
9 egories referred to in section 3501(a)(1)(C) of this
10 title”.

11 (c) OTHER CONFORMING AMENDMENTS.—Such title
12 is further amended as follows:

13 (1) Sections 3686(a)(1) is amended by striking
14 “or (D)” and inserting “(D), or (E)”.

15 (2) Section 5113(b)(3) is amended—

16 (A) in subparagraph (B) by striking “sec-
17 tion 3501(a)(1)” and all that follows through
18 the end and inserting the following: “subpara-
19 graphs (A), (B), (D), and (E) of section
20 3501(a)(1) of this title.”; and

21 (B) in subparagraph (C)—

22 (i) by striking “such veteran’s death”
23 and inserting “the death of the person
24 from whom such eligibility is derived”; and

25 (ii) by striking “such veteran’s serv-
ice-connected total disability permanent in

1 nature” and inserting “the service-con-
2 nected total disability permanent in nature
3 (or, in the case of a person made eligible
4 under section 3501(a)(1)(E), the total dis-
5 ability permanent in nature incurred or ag-
6 gravated in the line of duty in the active
7 military, naval, or air service) of the per-
8 son from whom such eligibility is derived”.

9 (d) EFFECTIVE DATE.—The amendments made by
10 this section shall apply with respect to a payment of edu-
11 cational assistance for a course of education pursued after
12 the date of the enactment of this Act.

13 **SEC. 4. DEADLINE AND PERMANENT REQUIREMENT FOR**
14 **REPORT ON EDUCATIONAL ASSISTANCE PRO-**
15 **GRAM.**

16 (a) DEADLINE FOR REPORT.—Not later than six
17 months after the date of the enactment of this Act, the
18 Secretary of Defense and the Secretary of Veterans Af-
19 fairs shall each submit to Congress a report containing
20 the information specified in subsections (b) and (c) of sec-
21 tion 3036 of title 38, United States Code.

22 (b) REPEAL OF TERMINATION.—Section 3036 of title
23 38, United States Code, is amended by striking subsection
24 (d).

1 **SEC. 5. REAUTHORIZATION OF BIENNIAL REPORT OF ADVI-**
2 **SORY COMMITTEE ON WOMEN VETERANS.**

3 Section 542(c)(1) of title 38, United States Code, is
4 amended by striking “2004” and inserting “2008”.

5 **SEC. 6. PARKINSON’S DISEASE RESEARCH, EDUCATION,**
6 **AND CLINICAL CENTERS AND MULTIPLE**
7 **SCLEROSIS CENTERS OF EXCELLENCE.**

8 (a) REQUIREMENT FOR ESTABLISHMENT OF CEN-
9 TERS.—

10 (1) IN GENERAL.—Subchapter II of chapter 73
11 of title 38, United States Code, is amended by add-
12 ing at the end the following new sections:

13 **“§ 7329. Parkinson’s Disease research, education, and**
14 **clinical centers**

15 “(a) ESTABLISHMENT OF CENTERS.—(1) The Sec-
16 retary, upon the recommendation of the Under Secretary
17 for Health, shall designate not less than six Department
18 health-care facilities as the locations for centers of Parkin-
19 son’s Disease research, education, and clinical activities.

20 “(2) Subject to the appropriation of sufficient funds
21 for such purpose, the Secretary shall establish and operate
22 centers of Parkinson’s Disease research, education, and
23 clinical activities at the locations designated pursuant to
24 paragraph (1) for such centers.

25 “(b) CRITERIA FOR DESIGNATION OF FACILITIES.—
26 (1) In designating Department health-care facilities for

1 centers under subsection (a), the Secretary, upon the rec-
2 ommendation of the Under Secretary for Health, shall as-
3 sure appropriate geographic distribution of such facilities.

4 “(2) Except as provided in paragraph (3), the Sec-
5 retary shall designate as the location for a center of Par-
6 kinson’s Disease research, education, and clinical activities
7 pursuant to subsection (a)(1) each Department health-
8 care facility that as of January 1, 2005, was operating
9 a Parkinson’s Disease research, education, and clinical
10 center.

11 “(3) The Secretary may not under subsection (a) des-
12 ignate a facility described in paragraph (2) if (on the rec-
13 ommendation of the Under Secretary for Health) the Sec-
14 retary determines that such facility—

15 “(A) does not meet the requirements of sub-
16 section (c); or

17 “(B) has not demonstrated—

18 “(i) effectiveness in carrying out the estab-
19 lished purposes of such center; or

20 “(ii) the potential to carry out such pur-
21 poses effectively in the reasonably foreseeable
22 future.

23 “(c) REQUIREMENTS FOR DESIGNATION.—(1) The
24 Secretary may not designate a Department health-care fa-
25 cility as a location for a center under subsection (a) unless

1 the peer review panel established under subsection (d) has
2 determined under that subsection that the proposal sub-
3 mitted by such facility as a location for a new center under
4 subsection (a) is among those proposals that meet the
5 highest competitive standards of scientific and clinical
6 merit.

7 “(2) The Secretary may not designate a Department
8 health-care facility as a location for a center under sub-
9 section (a) unless the Secretary (upon the recommenda-
10 tion of the Under Secretary for Health) determines that
11 the facility has (or may reasonably be anticipated to de-
12 velop) each of the following:

13 “(A) An arrangement with an accredited med-
14 ical school that provides education and training in
15 neurology and with which the Department health-
16 care facility is affiliated under which residents re-
17 ceive education and training in innovative diagnosis
18 and treatment of chronic neurodegenerative diseases
19 and movement disorders, including Parkinson’s Dis-
20 ease.

21 “(B) The ability to attract the participation of
22 scientists who are capable of ingenuity and creativity
23 in health-care research efforts.

24 “(C) An advisory committee composed of vet-
25 erans and appropriate health-care and research rep-

1 representatives of the Department health-care facility
2 and of the affiliated school or schools to advise the
3 directors of such facility and such center on policy
4 matters pertaining to the activities of the center dur-
5 ing the period of the operation of such center.

6 “(D) The capability to conduct effectively eval-
7 uations of the activities of such center.

8 “(E) The capability to coordinate (as part of an
9 integrated national system) education, clinical, and
10 research activities within all facilities with such cen-
11 ters.

12 “(F) The capability to jointly develop a consor-
13 tium of providers with interest in treating
14 neurodegenerative diseases, including Parkinson’s
15 Disease and other movement disorders, at facilities
16 without such centers in order to ensure better access
17 to state-of-the-art diagnosis, care, and education for
18 neurodegenerative disorders throughout the health
19 care system of the Department.

20 “(G) The capability to develop a national repos-
21 itory in the health care system of the Department
22 for the collection of data on health services delivered
23 to veterans seeking care for neurodegenerative dis-
24 eases, including Parkinson’s Disease, and other
25 movement disorders.

1 “(d) PEER REVIEW PANEL.—(1) The Under Sec-
2 retary for Health shall establish a panel to assess the sci-
3 entific and clinical merit of proposals that are submitted
4 to the Secretary for the establishment of centers under
5 this section.

6 “(2)(A) The membership of the panel shall consist
7 of experts in neurodegenerative diseases, including Parkin-
8 son’s Disease, and other movement disorders.

9 “(B) Members of the panel shall serve for a period
10 of no longer than two years, except as specified in sub-
11 paragraph (C).

12 “(C) Of the members first appointed to the panel,
13 one half shall be appointed for a period of three years and
14 one half shall be appointed for a period of two years, as
15 designated by the Under Secretary at the time of appoint-
16 ment.

17 “(3) The panel shall review each proposal submitted
18 to the panel by the Under Secretary and shall submit its
19 views on the relative scientific and clinical merit of each
20 such proposal to the Under Secretary.

21 “(4) The panel shall not be subject to the Federal
22 Advisory Committee Act.

23 “(e) PRIORITY OF FUNDING.—Before providing
24 funds for the operation of a center designated under sub-
25 section (a) at a Department health-care facility other than

1 at a facility designated pursuant to subsection (b)(2), the
2 Secretary shall ensure that each Parkinson’s Disease cen-
3 ter at a facility designated pursuant to subsection (b)(2)
4 is receiving adequate funding to enable that center to
5 function effectively in the areas of Parkinson’s Disease re-
6 search, education, and clinical activities.

7 “(f) AUTHORIZATION OF APPROPRIATIONS.—There
8 are authorized to be appropriated such sums as may be
9 necessary for the support of the research and education
10 activities of the centers established pursuant to subsection
11 (a). The Under Secretary for Health shall allocate to such
12 centers from other funds appropriated generally for the
13 Department medical services account and medical and
14 prosthetics research account, as appropriate, such
15 amounts as the Under Secretary for Health determines
16 appropriate.

17 “(g) AWARD COMPETITIONS.—Activities of clinical
18 and scientific investigation at each center established
19 under subsection (a) shall be eligible to compete for the
20 award of funding from funds appropriated for the Depart-
21 ment medical and prosthetics research account. Such ac-
22 tivities shall receive priority in the award of funding from
23 such account insofar as funds are awarded to projects for
24 research in Parkinson’s Disease and other movement dis-
25 orders.

1 **“§ 7330. Multiple sclerosis centers of excellence**

2 “(a) ESTABLISHMENT OF CENTERS.—(1) The Sec-
3 retary, upon the recommendation of the Under Secretary
4 for Health, shall designate not less than two Department
5 health-care facilities as the locations for multiple sclerosis
6 centers of excellence.

7 “(2) Subject to the appropriation of sufficient funds
8 for such purpose, the Secretary shall establish and operate
9 multiple sclerosis centers of excellence at the locations des-
10 igned pursuant to paragraph (1) for such centers.

11 “(b) CRITERIA FOR DESIGNATION OF FACILITIES.—
12 (1) In designating Department health-care facilities for
13 centers under subsection (a), the Secretary, upon the rec-
14 ommendation of the Under Secretary for Health, shall as-
15 sure appropriate geographic distribution of such facilities.

16 “(2) Except as provided in paragraph (3), the Sec-
17 retary shall designate as the location for a multiple sle-
18 rosis center of excellence pursuant to subsection (a)(1)
19 each Department health-care facility that as of January
20 1, 2005, was operating a multiple sclerosis center of excel-
21 lence.

22 “(3) The Secretary may not under subsection (a) des-
23 ignate a facility described in paragraph (2) if (on the rec-
24 ommendation of the Under Secretary for Health) the Sec-
25 retary determines that such facility—

1 “(A) does not meet the requirements of sub-
2 section (c); or

3 “(B) has not demonstrated—

4 “(i) effectiveness in carrying out the estab-
5 lished purposes of such center; or

6 “(ii) the potential to carry out such pur-
7 poses effectively in the reasonably foreseeable
8 future.

9 “(c) REQUIREMENTS FOR DESIGNATION.—(1) The
10 Secretary may not designate a Department health-care fa-
11 cility as a location for a center under subsection (a) unless
12 the peer review panel established under subsection (d) has
13 determined under that subsection that the proposal sub-
14 mitted by such facility as a location for a new center under
15 subsection (a) is among those proposals that meet the
16 highest competitive standards of scientific and clinical
17 merit.

18 “(2) The Secretary may not designate a Department
19 health-care facility as a location for a center under sub-
20 section (a) unless the Secretary (upon the recommenda-
21 tion of the Under Secretary for Health) determines that
22 the facility has (or may reasonably be anticipated to de-
23 velop) each of the following:

24 “(A) An arrangement with an accredited med-
25 ical school that provides education and training in

1 neurology and with which the Department health-
2 care facility is affiliated under which residents re-
3 ceive education and training in innovative diagnosis
4 and treatment of chronic neurodegenerative diseases,
5 including multiple sclerosis.

6 “(B) The ability to attract the participation of
7 scientists who are capable of ingenuity and creativity
8 in health-care research efforts.

9 “(C) An advisory committee composed of vet-
10 erans and appropriate health-care and research rep-
11 resentatives of the Department health-care facility
12 and of the affiliated school or schools to advise the
13 directors of such facility and such center on policy
14 matters pertaining to the activities of the center dur-
15 ing the period of the operation of such center.

16 “(D) The capability to conduct effectively eval-
17 uations of the activities of such center.

18 “(E) The capability to coordinate (as part of an
19 integrated national system) education, clinical, and
20 research activities within all facilities with such cen-
21 ters.

22 “(F) The capability to jointly develop a consor-
23 tium of providers with interest in treating multiple
24 sclerosis at facilities without such centers in order to
25 ensure better access to state-of-the-art diagnosis,

1 care, and education for autoimmune disease affect-
2 ing the central nervous system throughout the health
3 care system of the Department.

4 “(G) The capability to develop a national repos-
5 itory in the health care system of the Department
6 for the collection of data on health services delivered
7 to veterans seeking care for autoimmune disease af-
8 fecting the central nervous system.

9 “(d) PEER REVIEW PANEL.—(1) The Under Sec-
10 retary for Health shall establish a panel to assess the sci-
11 entific and clinical merit of proposals that are submitted
12 to the Secretary for the establishment of centers under
13 this section.

14 “(2)(A) The membership of the panel shall consist
15 of experts in autoimmune disease affecting the central
16 nervous system.

17 “(B) Members of the panel shall serve for a period
18 of no longer than two years, except as specified in sub-
19 paragraph (C).

20 “(C) Of the members first appointed to the panel,
21 one half shall be appointed for a period of three years and
22 one half shall be appointed for a period of two years, as
23 designated by the Under Secretary at the time of appoint-
24 ment.

1 “(3) The panel shall review each proposal submitted
2 to the panel by the Under Secretary and shall submit its
3 views on the relative scientific and clinical merit of each
4 such proposal to the Under Secretary.

5 “(4) The panel shall not be subject to the Federal
6 Advisory Committee Act.

7 “(e) PRIORITY OF FUNDING.—Before providing
8 funds for the operation of a center designated under sub-
9 section (a) at a Department health-care facility other than
10 at a facility designated pursuant to subsection (b)(2), the
11 Secretary shall ensure that each multiple sclerosis center
12 at a facility designated pursuant to subsection (b)(2) is
13 receiving adequate funding to enable that center to func-
14 tion effectively in the areas of multiple sclerosis research,
15 education, and clinical activities.

16 “(f) AUTHORIZATION OF APPROPRIATIONS.—There
17 are authorized to be appropriated such sums as may be
18 necessary for the support of the research and education
19 activities of the centers established pursuant to subsection
20 (a). The Under Secretary for Health shall allocate to such
21 centers from other funds appropriated generally for the
22 Department medical services account and medical and
23 prosthetics research account, as appropriate, such
24 amounts as the Under Secretary for Health determines
25 appropriate.

1 “(g) AWARD COMPETITIONS.—Activities of clinical
 2 and scientific investigation at each center established
 3 under subsection (a) shall be eligible to compete for the
 4 award of funding from funds appropriated for the Depart-
 5 ment medical and prosthetics research account. Such ac-
 6 tivities shall receive priority in the award of funding from
 7 such account insofar as funds are awarded to projects for
 8 research in multiple sclerosis and other neurodegenerative
 9 disorders.”.

10 (2) CLERICAL AMENDMENT.—The table of sec-
 11 tions at the beginning of such chapter is amended
 12 by inserting after the item relating to section 7328
