A BILL

To direct the Federal Communications Commission to make efforts to reduce telephone rates for Armed Forces personnel deployed overseas.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Call Home Act of
5 2006”.

1 **SEC. 2. TELEPHONE RATES FOR MEMBERS OF ARMED**
2 **FORCES DEPLOYED ABROAD.**

3 (a) IN GENERAL.—The Federal Communications
4 Commission shall take such action as may be necessary
5 to reduce the cost of calling home for Armed Forces per-
6 sonnel who are stationed outside the United States under
7 official military orders or deployed outside the United
8 States in support of military operations, training exer-
9 cises, or other purposes as approved by the Secretary of
10 Defense, including the reduction of such costs through the
11 waiver of government fees, assessments, or other charges
12 for such calls. The Commission may not regulate rates in
13 order to carry out this section.

14 (b) FACTORS TO CONSIDER.—In taking the action
15 described in subsection (a), the Commission, in coordina-
16 tion with the Department of Defense and the Department
17 of State, shall—

18 (1) evaluate and analyze the costs to Armed
19 Forces personnel of such telephone calls to and from
20 American military bases abroad;

21 (2) evaluate methods of reducing the rates im-
22 posed on such calls, including deployment of new
23 technology such as voice over internet protocol or
24 other Internet protocol technology;

25 (3) encourage telecommunications carriers (as
26 defined in section 3(44) of the Communications Act

1 of 1934 (47 U.S.C. 153(44))) to adopt flexible bill-
 2 ing procedures and policies for Armed Forces per-
 3 sonnel and their dependents for telephone calls to
 4 and from such Armed Forces personnel; and

5 (4) seek agreements with foreign governments
 6 to reduce international surcharges on such telephone
 7 calls.

8 (c) DEFINITIONS.—In this section:

9 (1) ARMED FORCES.—The term “Armed
 10 Forces” has the meaning given that term by section
 11 2101(2) of title 5, United States Code.

12 (2) MILITARY BASE.—The term “military base”
 13 includes official duty stations to include vessels,
 14 whether such vessels are in port or underway outside
 15 of the United States.

16 **SEC. 3. REPEAL OF EXISTING AUTHORIZATION.**

17 Section 213 of the Telecommunications Authorization
 18 Act of 1992 (47 U.S.C. 201 note) is repealed.
