A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Torture Victims Relief
5 Reauthorization Act of 2007”.

6 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS FOR DOMES-**
7 **TIC TREATMENT CENTERS FOR VICTIMS OF**
8 **TORTURE.**

9 Section 5(b)(1) of the Torture Victims Relief Act of
10 1998 (22 U.S.C. 2152 note) is amended to read as follows:

11 “(1) AUTHORIZATION OF APPROPRIATIONS.—Of
12 the amounts authorized to be appropriated for the
13 Department of Health and Human Services for fis-
14 cal years 2008 and 2009, there are authorized to be
15 appropriated to carry out subsection (a)
16 \$25,000,000 for each of the fiscal years 2008 and
17 2009.”.

1 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS FOR FOR-**
2 **EIGN TREATMENT CENTERS FOR VICTIMS OF**
3 **TORTURE.**

4 Section 4(b)(1) of the Torture Victims Relief Act of
5 1998 (22 U.S.C. 2152 note) is amended to read as follows:

6 “(1) AUTHORIZATION OF APPROPRIATIONS.—Of
7 the amounts authorized to be appropriated for fiscal
8 years 2008 and 2009 pursuant to chapter 1 of part
9 I of the Foreign Assistance Act of 1961, there are
10 authorized to be appropriated to the President to
11 carry out section 130 of such Act \$12,000,000 for
12 each of the fiscal years 2008 and 2009.”.

13 **SEC. 4. AUTHORIZATION OF APPROPRIATIONS FOR THE**
14 **UNITED STATES CONTRIBUTION TO THE**
15 **UNITED NATIONS VOLUNTARY FUND FOR**
16 **VICTIMS OF TORTURE.**

17 Of the amounts authorized to be appropriated for fis-
18 cal years 2008 and 2009 pursuant to chapter 3 of part
19 I of the Foreign Assistance Act of 1961, there are author-
20 ized to be appropriated to the President for a voluntary
21 contribution to the United Nations Voluntary Fund for
22 Victims of Torture \$12,000,000 for each of the fiscal
23 years 2008 and 2009.
