A BILL

To amend title 44, United States Code, to require each agency to include a contact telephone number in its collection of information.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AGENCY CONTACT INFORMATION REQUIRE-**
2 **MENT.**

3 Section 3506(e)(1)(B)(iii) of title 44, United States
4 Code, is amended—

5 (1) in subclause (IV) by striking “and” at the
6 end; and

7 (2) by adding at the end the following:

8 “(VI) the agency’s contact tele-
9 phone number; and”.

10 **SEC. 2. STUDY AND REPORT.**

11 Not later than 2 years after the date of enactment
12 of this Act, the Comptroller General shall—

13 (1) conduct a study on—

14 (A) the number of complaints made to an
15 agency or other entity by a person receiving the
16 collection of information from an agency with
17 respect to such agency’s contact telephone num-
18 ber, or lack thereof; and

19 (B) the status of the resolution of such
20 complaints by such agency; and

21 (2) submit a report on the findings of such
22 study to each House of Congress.

23 **SEC. 3. EFFECTIVE DATE.**

24 The amendment made by section 1 shall take effect
25 1 year after the date of enactment of this Act.

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Paperwork Assistance*
3 *Act”.*

4 **SEC. 2. AGENCY CONTACT INFORMATION REQUIREMENT.**

5 *Section 3506(c)(1)(B)(iii) of title 44, United States*
6 *Code, is amended—*

7 *(1) in subclause (IV) by striking “and” at the*
8 *end; and*

9 *(2) by adding at the end the following:*

10 *“(VI) contact information for the*
11 *agency, including a website and a tele-*
12 *phone number, by which a person may*
13 *obtain a specific contact person respon-*
14 *sible for answering questions about the*
15 *information collection and other infor-*
16 *mation to assist in responding to the*
17 *information collection; and”.*

18 **SEC. 3. REPORT BY THE OFFICE OF MANAGEMENT AND**
19 **BUDGET.**

20 *The Director of the Office of Management and Budget*
21 *shall include in the report required by section*
22 *3514(a)(1)(B) of title 44, United States Code, covering fis-*
23 *cal year 2010 the following:*

24 *(1) The status of implementation by agencies of*
25 *the requirement in section 3506(c)(1)(B)(iii)(VI) of*
26 *such title 44, as added by section 2 of this Act.*

1 (2) *A description of how each agency has re-*
2 *sponded to complaints made to the agency related to*
3 *the agency's compliance with such requirement.*

4 **SEC. 4. EFFECTIVE DATE.**

5 *The amendment made by section 2 shall apply to new*
6 *or revised collections of information approved by the Direc-*
7 *tor of the Office of Management and Budget beginning 1*
8 *year after the date of enactment of this Act.*

Amend the title so as to read: “A bill to amend title 44, United States Code, to require each agency to include contact information for the agency in its collection of information.”.
