1 **SECTION 1. REDESIGNATION.**

2 The Federal building located at 167 North Main
3 Street in Memphis, Tennessee, commonly known as the
4 Clifford Davis Federal Building, shall be known and des-
5 ignated as the “Clifford Davis/Odell Horton Federal
6 Building”.

7 **SEC. 2. REFERENCES.**

8 Any reference in a law, map, regulation, document,
9 paper, or other record of the United States to the Federal
10 building referred to in section 1 shall be deemed to be
11 a reference to the “Clifford Davis/Odell Horton Federal
12 Building”.

13 **SECTION 1. REDESIGNATION.**

14 *The Federal building located at 167 North Main Street*
15 *in Memphis, Tennessee, commonly known as the Clifford*
16 *Davis Federal Building, shall be known and designated as*
17 *the “Clifford Davis and Odell Horton Federal Building”.*

18 **SEC. 2. REFERENCES.**

19 *Any reference in a law, map, regulation, document,*
20 *paper, or other record of the United States to the Federal*
21 *building referred to in section 1 shall be deemed to be a*
22 *reference to the “Clifford Davis and Odell Horton Federal*
23 *Building”.*
